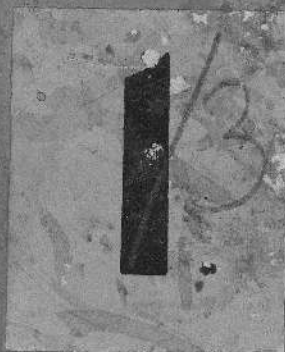

MINUTES OF THE RANCHI COMMITTEE ON PROPERTIES MEETING  
HELD ON 14-12-66.

The meeting of the Ranchi Committee on Properties was held on 14.12.66 under the chairmanship of Shri. M.Soy. The meeting started with a short prayer.

2. The meeting was called for specially to discuss with Pastor Seeberg on the present condition of the G.E.L.Church Compound, Ranchi.
3. First of all Shri. M.Soy presented the prepared Budget for 1967 before the Committee and explained both about the receipt and expenditures of the budget. According to the present position, he told that the expenditure exceeds the income but this can be met if some prudent measures are adopted by selling trees, paddy, fishes and realizing arrear house rents which comes to Rupees 6,000.00 (Rupees six thousand) approximately.
4. Next, he said that according to the stipulated plan, compound wall is urgently essential, but without fund it is a wellnigh impossibility to carry out this special work.
5. Previously, discussion on leasing out some portion of the compound was made in the Mandli Panch meeting, but it was rejected by most of the members of the Congregation.
6. Shri. M.Soy again told that the municipal tax is terribly in arrear amounting to more than Rs 25,000.00 (Rupees twentyfive thousand) since 1960, which was totally ignored by the Board of Properties during its holding of charge of the compound.
7. Now, according to him, whatever planning will be made as regards new construction, diversion of old roads etc, the municipality will not permit any such developmental work ~~unless~~ unless the arrear tax is fully paid.

8. VIEWS OF THE PASTOR SEEBERG :

First of all Pastor SeeBerg expressed his happiness finding himself in the committee meeting and so he extended his thankfulness to the Committee. He accepted this powerful committee has done an excellent work by taking over charge of the properties within the G.E.L.Church Compound., Ranchi. He told that in Germany all the Church members whatsoever, are very very interested in such matters. So, here also, when thousand of Christians as well as , non-Christians too, are looking forward the Head Quarters to be a model one. Each and every Christian tolas and mahallas should be an example in good works.

9. Previously the Ranchi compound was controlled by a handful self interested private parties and hence no good work could be done. According to Pastor Seeberg the Board of Properties exhausted all income in paying up only the expenditure and left nothing for any developmental work. He said that the Church properties should be considered as a gift and must be utilised in its best possible way. The laymen, according to him, are the right men for its management as they have done their best in collecting rents and other works. They have collected atleast the normal income to meet the normal expenditure. Further he stressed that everybody should go through the published Planning of the Ranchi Municipality and the Improvement Trust in order to have the knowledge of the present as well as future Prospect of the compound.
10. For Ranchi compound, proper planning should be prepared. The planning work is to be completed by 1970 which is not very long. The old buildings should be demolished and the new ones should be constructed. In India, compound wall is very essential to safeguard the compound. This should be done. The committee should have to look for special income. Uptil now the Church is getting subsidy from abroad, so there must be an improvement of the works. He said that the compound is 120 acres so when it is properly utilised this will be better. Sometimes, it may be possible to sell a plot to save the rest of the compound or it may be better, to lease out alongside the main road. If nothing of these kind is done in the compound then some portion may be allowed to be acquired by the Municipality for development of the increasing town. There must be some strong wall alongside the main road for its fast protection.
11. He agreed that it is not possible to get back the leased out property in India, but even then, it may be necessary to lease out some portion of the compound to save the larger part of the compound. Many outsiders are looking for the land so there is danger in safeguarding the compound. According to Pastor Seeberg, leasing out is wiser than selling out as by selling out the Property goes out for ever which will be a permanent loss, but by leasing out money will be received regularly upto the time of lease period and the Property will be got back after the expiry of the lease period.
12. Pastor Seeberg's Advice :- This new Committee should be quite free and independent. He agreed to give aid on the condition that the expenditure should be incurred properly. He reiterated that one must avoid private business. The authorities must be frank and let the public know what is going on within the compound. We must have a contract in leasing out the Property stating clearly that the Church has a right to intervene as and when deemed necessary.

Loan for the compound wall :- Pastor Seeberg expressed that he is fully agreed to give loan for erecting compound wall. He advised the committee to decide to enter into a very good agreement in this respect. He also requested to find out the proper estimate and to let him know personally.

The meeting was closed with a short prayer.

3. PROPOSAL OF BOUNDARY WALL :-

The matter was discussed. It is expected for this work Finance is going to be made available very soon from Gossner Mission.

Since the Ranchi Committee on Properties has taken over charge for the management and maintenance of the Properties GEL Church Compound at Ranchi with effect from 7.9.66

Resolved that- Dr. Berge, the Director of the Gossner Mission be informed of this fact and be requested to make the funds available for completing the Boundary Wall of the GEL Church Compound at Ranchi.

3. The arrear list of the Shop Rent : The arrear list of the shop rent was read out and the correct position was ascertained. Mr. Montag, the Financial Advisor reiterated the views of the M.P. and emphasised that the new rent should be fixed immediately and the arrear should be collected part by part every month. It was also ordered by him that the rent should be fixed in such a way as it would be equal to the standard rent plus a particular amount of instalments of arrear rent to be recoverable within a definite period of time so that the whole arrear rent to be should be recovered in full within that period of time. After that the regular standard rent fixed would be payable month by the tenants. As regards the fixation of rent the committee decided that before the fixation of new rent, the area occupied by the tenants should be measured exactly, so that there should not be any possibility of overreachment. For this purpose the Committee suggested that a surveyor should be appointed and he should note the particulars as regards the standard of shops and the exact area occupied by each shop keeper. Mr. Bhengra, the Manager himself was interested to do this job within a fortnight and submit his report to the next Committee meeting for the fixation of new rent.

New Shops :- Mr Montag said, "the creating of shop buildings is quite controversial matter in as much as this matter is being submitted to the Property Board. The sub-Committee is not competent enough to discuss and decide on the matter." According to him this matter is a very complicated and requires high level talk, as some persons hold that the Property Board should erect its own shop buildings and give on rent basis, while others suggest to lease out some portions of land to some rich men who may be able to advance a good sum of money to enable us to do our own beneficial works within the Compound.

He again said that all the roads which we have at present round about the Mission Compound may be undertaken by the Improvement Trust and our whole planning may be upset. The planning Commission considers that the main road has its best profit value in comparison to other sides and as such the shops should be opened by the main road side.

Dr. Bage said, the land should be utilised in any way, but the policy matter should be for the good of the Church in general. He supported the Validity of the lease amounts in advance and emphasised that the tenure would also be the Church Property.

Further, he said what sort of land should be given for this purpose. According to him the shop should not count much, but our Institutions will have the upper hand in our G.E.L. Church, Ranchi. This should be our first principle while we are Chalking out our plan for the Institutions and shops within the Compound.

Rev. J. Lakra suggested that the nice looking shops should be constructed and to do this the tenants should be given charge of it and the rent realized from them in advance. Before construction of shop buildings by the shop keepers, approval of the Property Board is essential.

Planning is required immediately as suggested by Dr. M. Bage.

Mr. P. Topno, the Chairman opined that a joint committee of the Property Board as well as Ranchi Committee on Properties should be called for just to have the good understanding on this matter.

- Application of Shri C.D. Ekka was read out and it was opined that he should be given some concession of rent for the house occupied by him. The Committee decided that accounts of the expenditure should be called for from him for consideration.

Shri. M. Khalkho and C.D. Ekka should be asked to submit the papers immediately.

- As regards the unauthorised persons Shri Latif Gwala and Ganesh Bahadur in Raja Bungalow Compound, Rev. J. Lakra, Rev. J. Topno and Shri. S. Bhengra, the Co-Manager, were requested to take up the matter with Shri. Phulchand Panna, the Hotel Keeper.

- Boundary Wall :- Mr. Montag said that three or four contractors should be asked just to take up the Construction work of the boundary Wall around the compound. The Property Board will invite tenders for this Purpose.

Again, both the North Gate and the South Gate should be closed up, but side Gate should be made with the better facility to come in and to go out by the side of both the North and the South Gates.

3. Before coming to the main topics, thanks was given to Shri. Montag the Financial Advisor for his return safely from England with a burning zeal to assist and advise the Committee as well as the Property Board, G.E.L. Church, Ranchi in financial matters.
4. As regards Vacation of Quarters by Shri. Z. Purty his application for retention of quarters was read out and it was thought necessary that any other suitable action should be taken against him later on.
5. Shri. H. Lakra, the Manager had applied to allot a portion of the building occupied previously by Rev. S. Surin near the L.P. School for poultry farm purposes, but his request was rejected keeping in view that quarters were urgently required for the teachers of the Gossner High School, Ranchi and as such the eastern portion was allotted to Shri. U. Lugun and the Western portion to Shri. S. Buding at a monthly rent of Rs. 7/- and Rs. 10/- respectively.
6. Mr. Montag expressed that Rev. J. Topno the Secretary, Property Board in Chotanagpur and Assam did not recognise the status of the Ranchi Committee like that of the Anchals and hence hindrance may occur in executing all the works freely. As regard loan for Compound wall Mr. Montag explained that the P.B. was unwilling to accept any loan subject to be refundable. The P.B. is however ready to accept loan only when loan will be given as a gift which can not be possible in as much as the loan has no meaning in the later case. Under the circumstances if loan is not taken it will be a hindrance in the work of the Compound wall. He however gave much stress on the erection of the Compound wall for the safeguard and well protection of the Compound. Mr. Topno the Chairman, then suggested that the P.B. may be persuaded to accept the loan from the Planning Commission so that the work may be done.  
At this Mr. Montag explained that the planning Commission is going to be abolished and the Property Board will be given the full responsibility to work according to its own interest.  
Mr. Montag further gave his opinion that the Committee should be allowed to reconsider the case of taking loan from Foreign for Compound wall with the consent of the Property Board. This may be pointed out to the Property Board for its information and consideration on the matter.



As regards vacation of quarters by the unauthorised persons it was opined that first of all the Police should be informed in writing to be present at the spot for which a date should be fixed. Before writing to the Police a body of selected persons from amongst the members should meet the Police once for primary talks. Shri. E. Minz Shri. M. Kerketta and Shri B. Khess were selected to contact the Police and fix a date for taking necessary action.

As regards the appointment of an assistant to carry on the work of the Ranchi Committee on Properties, it was reported by Shri. B. Khess that the work is increasing day by day and as such a paid assistant should be appointed. It was decided by the full bunch that a full time assistant should be appointed, but before doing this the matter may be forwarded to the Property Board for prior approval. But it was thought more wise that the matter may be communicated to the Property Board after the appointment of the assistant as the Property Board may not be in favour of appointment of the assistant and due to this the work may be unmanageable. It was decided that the assistant may be paid out of the 50% of the rent collected. The salary fixed will be Rs. 75/- P.M. plus allowance at the usual rate.

- As some of the tenants do not pay rents, Mr. Minz, Mr. Bhengra and Mr. Kerketta will visit the defaulters and find out the reasons and put up their findings before the Committee for consideration.
10. Rent fixation of the Press Compound quarters :- Rents for the Press Compound quarters were roughly fixed by Shri Minz and Shri Kerketta which were fairly fixed with the consultation of Mr. Mittenhuber and confirmed by the Committee.

The meeting was closed with short prayer.


11. As some items in the agenda were pending the meeting held again on 26.10.65 with a short prayer.
- The first point was on the fixation of shop rents. It was decided by the Committee that the rate of shop rent should be fixed as below :-

  - ii) For mission building : Rs 20/- per room (26'x11') in addition to the rent of ground.
  - iii) Main road side : 0.80 Paise per foot plus 0.08 paise square foot for the back ground.

3. The minute of the last meeting of the Ranchi Sub-Committee of Properties held on 10.4.65 was read and confirmed.

4. Item No. 5 of the minute of the last meeting held on 10.4.65 regarding opening of separate Bank Account, it was pointed out by Mr. Montag the Financial Advisor, that a separate banking account should be opened with the United Bank of India Ltd. Ranchi Branch, entitled "Repair Fund Account" in order to enable this Committee to meet the emergent expenditures for the betterment of this Compound. The views were accepted by the Committee and it was resolved that the banking account should be operated jointly by the Treasurer, Property Board, Ranchi and any one from amongst the members of the Ranchi Sub-Committee of Properties.

5. Item No. 9 of the minutes of the last meeting for Allocation of Land for Cow-shed.

Few points were raised by the members that Shri H. Lakra, the Manager Board of Properties, G.E.L.Church in Chotanagpur and Assam, Ranchi should be requested to allocate a particular site referring to the resolution forwarded to him dated the 10th April, 1965 for the construction of the Cow-shed by the Cow-owners themselves.

6. Allocation of land for Jubilee Library.

(a) Mr. B. Khess, the Secretary, Ranchi Sub-Committee of Properties reported the decision of the last Property Board meeting held on 11.4.65 regarding the site for Jubilee Library. It was decided by the Property Board that Ranchi Sub-Committee should be informed to look into the matter. That information does not appear to have been received by this Committee as yet.

(b) In view of the messages received from Dr. Berge the Director World Gossner Mission, Berlin by the Jubilee Committee regarding the construction of Jubilee Library it was verbally reported by Mr. Khess that at this juncture this Committee is not competent to allocate the suitable site for Jubilee Library as many members of the Jubilee Sub-Committee entrusted to negotiate with the Pastor Schmidt are away from Ranchi.

(c) It was further resolved that this Committee will take initiative towards the allocation of the site as soon as the Jubilee Committee negotiate with Rev. Schmidt.

7. Fixation of Rent on Press Building.

Respected member Mr. Mittenhuber voluntarily expressed his opinion to assess the rent of Rs.250/- p.m. for the Press Building which consists of 11 rooms and this voluntary offer was accepted by the Committee.

8. The Committee further decided that the house rent of the quarter occupied by Rev. J. Lakra should be fixed. For this particular job Mr. Mittenhuber and Shri Khess were entrusted to visit the Officer's Bungalow and put up the matter in the next meeting of this Committee.

9. One Shri Tigga has occupied the servants' quarter attached to the Lal Bungalow which hitherto used to be occupied by the servant of the Officers residing in that bungalow. Now as all the officers have gone away these servants are not entitled to retain these servants' quarters. As the Pastor Schmidt as well as Mr. Montag the present Officers are in dire need of quarters for their servants, the Committee decided to allot these quarters to them. In view of this fact it was resolved that Shri Tigga should be asked to vacate the quarters occupied by him immediately so as to enable the Ranchi Sub-Committee to accommodate the servants of the officers working now in the G.E.L. Church, Ranchi. Further it was resolved that Shri Tigga should be asked to come to Shri B.Khess for discussion prior to giving him a notice for vacating the quarter.

10. Regarding the collection of rent.

(a) Many points were raised by the members and it was resolved that for facilitating the work of the Committee all the tenants should take their own responsibility to come straight to the Accountant for the payment of rent within the 1st to 10th of each month. Failing to do this, a Collector appointed for the purpose will visit door to door to collect the rent from the defaulters and for this special job .05 paise in a Rupee as fine will be charged from the defaulters. In no case any excuse will be entertained.

(b) Shri Eliazar Minz, the fellow member of this Committee was elected as a Collector on the Commission basis @ 5 % of the total rent collected.

11. Repair Works.

It was further resolved that two men Sub-Committee may be appointed who will look into the matter from time to time. And also resolved that this body will be competent enough to carry on their works of petty repair like roof repair etc. Major repair works should be referred to the Ranchi Sub-Committee on Properties, for necessary action. Shri B. Khess and Mr. Mittenhuber were appointed members of this Sub-Committee.

12. Application of Shri S. Buding for quarters.

The application of Shri Buding was considered and it was decided that Shri Z. Purti the ex-teacher of the Gossner High School should be asked to vacate the quarters and it should be allotted to Shri Buding. Attempt should be made to give accommodation to Shri Purty in the quarter occupied at present by Rev. S Surin. It was further resolved that Rev. Surin should shift to the Theological Compound.

In this connection it was fairly decided that the moment an employee retires from the services under the Church Institution he/she should vacate the quarters for the next successor. In no case the retired person will be allowed to stay in the Property Board's quarters within the compound.

Church in Chotanagpur and Assam allotted a Plot of Land measuring 95' X 75' (Length - South-North; width East-West) on the South-East corner of the Raja Bungalow Compound, as suggested by Mr. K. Shwerk the direction of the Planning side for erecting the said building.

5. Minutes of the Board of Property Sub-Committee, Ranchi.

The 4th Meeting of the Sub-Committee of the Property Board held on the 10th of April, 1965 in the K.S.S. Office at 5 P.M. to assist the Property Board in the following matters.

1. The following members nominated by the Property Board attended the meeting.

2. The minutes of the last meeting of the Sub-Committee held on 29th and 30th March, 1965 was read out and confirmed after necessary corrections and amendments by the Sub-Committee.
3. The Sub-Committee resolved that one half of the collected rents should be shown separately in the books of the Board of Property as "Repair Fund Account" which must not be touched for any other purposes, but the amounts of this Fund should exclusively be utilised for the Petty Construction and Repair works of the buildings under the Compound. However the Sub-Committee will have the reserve to consider and decide as to how this Fund will be utilised for any other purposes concerning the Hd. Qrt., GEL Church Compound.
4. The Sub-Committee further <sup>Convened</sup> ~~Compound~~ to fix the house rent of the buildings occupied by the K.S.S. for Office purpose. This Committee inspected the K.S.S. Office and found that the building consists of 11 rooms. In view of this finding the Sub-Committee decided that rent for Rs. 100/- per month was fair and payable invariably by the K.S.S. itself on the 1st of every month.
5. The Sub-Committee further decided that Shri Khess and newly nominated member Shri Minz would visit the Press Building and the Theological Compound as well as the Gossner College Hostel and put up their inspection reports to the Sub-Committee scheduled to meet on the 5th of May, 1965.
6. In view of the ~~Committee's~~ Census report submitted by Shri Khess Secretary to the Sub-Committee it is clear that some of the quarters are in dire need of repair and for this Shri Montag our Hon'ble guest expressed his helping attitude to give a sum of Rs. 1,000/- to the Sub-Committee as loan refundable to him. With this amount the repair works will be done before rainy season.
7. The Sub-Committee further decided that the Committee would take any repair work or other petty construction work as soon as the Committee receives back all the agreement deeds and rents from the tenants.
8. The Sub-Committee considered the objection raised by a number of occupants sympathetically and found that the rents fixed against them were fair and reasonable. The Committee therefore, expressed its regret and the occupants are bound to give the rent fixed regularly from April, 1965 onward.



8. ✓ Again the Sub-Committee resolved that the Cows in the Mission Compound should not be allowed in the Residential Quarters. However provision will be made by the Property Board to keep all the Cows in a Particular place subject to some terms and conditions. The Sub-Committee further decided that at present it is not in a position to take effective steps towards this score hence it was decided that the cow-shed should be prepared collectively by the Cow-owners themselves. Regarding the feeding of the Cows, it was also decided that the owner himself will do this job. The Sub-Committee thinks desirable that a night Guard will be appointed for at a monthly salary of Rs. 25/- or Rs. 32/- as the case may be.
10. Again every individual should care their chickens. In no case chicken will be allowed free wandering within the Mata premises. If so found the chicken will be taken away by the Property Board.
11. The Sub-Committee and the Property Board step forward for the betterment of the G. E. L. Church Compound with full force.
12. ✓ Shri Dattas expressed his view that Mr. Parg the Director of the Gossamer Mission has written a letter to him that some <sup>Loan</sup> aid is likely to be received by the Property Board sometime in the month of May '65. This amount is to be utilized for the boundary wall purposes.
13. ✓ The Sub-Committee further decided that some of the members of the Compound should be called down immediately and also decided that some non-Christian members should be asked to vacate the quarters occupied by <sup>them</sup> without delay. Some notes were raised that there are some occupants who want to be converted into Christianity, which will be inquired by the pastors for their satisfaction and put up their recommendation to the Sub-Committee Property Board, G. E. L. Church, Ranchi.

Minutes of the meeting of the Ranchi Committee on Properties held on 17th June, 1965 at 6 P.M. in the Property Board Office, Ranchi.

1. Opening : The meeting opened with a short prayer led by Shri P. Topno the Chairman of the Ranchi Committee on Properties, G.E.L. Church, Ranchi.
2. Attendance : The following members were present :-

3. Terms of reference : The Ranchi Committee on Properties felt the necessity of the terms of reference to facilitate the Committee, to handle the matters smoothly in the light of it. In pursuance of the request by the Secretary to the Property Board, a view was came up that the terms of reference needed by the Ranchi Committee should be communicated to the Property Board. Accordingly the members of the Property Board had the pleasure to depute one member Shri S. Bhengra to prepare a draft of terms of reference. The reference framed by Shri Bhengra was preliminary read out and after due scrutiny by the Committee permitted Shri Bhengra to put up the same before the Property Board.
4. Special Compound for the Cows : The site for cow-shed has been allocated by the Property Board in the western coast of the Lal Bungalow. As the time has elapsed, no arrangement could be made for fencing. In light of the view it was decided that the barbed wire fencing should be done and all the cow owners should be intimated just to contribute their finance to build the cow-shed by themselves. It was further decided that if the cow owners will not be satisfied with their arrangement then they should be asked to keep their cows outside the compound. It was further decided that the cow owners should be charged Rs.3/- P.M. for each cow and Re.1/- P.M. for each goat.
5. Non - payment of rent : The rent fixed by the Committee was successfully realised during the month of April, 1965 but it reduced during May, 1965 as such the committee decided that the special collection should be regularised. Shri E. Minz the member was again requested to visit the defaulters and collect the rent with a fine of paise 5 in a Rupee. It was further emphasized that every defaulter should be informed for early payment of his arrear rent.
6. Submission of agreement deed : It was further reported by Shri B. Khess that most of the tenants of the compound have not yet submitted their agreement deed. In view of this statement it was finally firmly decided that the agreement for the new organisational set up of the tenancy, the defaulters should be asked to submit the same within 72 hours failing which it will be treated as agreed. It was resolved that each and every tenant would be informed accordingly.
7. Quarters on vacation notice : It was reported by the Secretary that the vacation notice served have in most cases expired, but the tenants have not yet vacated the quarters. In view of the fact it was fairly opined that a commission of the following members should be made to go through the facts as to why the persons concerned have not abided by the terms of the Committee. MEMBERS : (i) Shri B. Khess, Secretary, (ii) Shri E. Minz, (iii) Mr. Mittenhuber and (iv) Mr. R. Montag.



8. Demolition of the House of Mrs. S. Kerketta:-

Mrs. S. Kerketta has a heavy arrear of her shop rent amounting to Rs. 740/-. It was felt that this amount is beyond her expectation to repay. So it was decided that the Mrs. Kerketta may be provided with alternative Quarters and the said house should be demolished. Regarding tiles and beams etc. it was decided that as she has failed to pay a heavy amount of rent the entire assets will be the Property Board Assets.

9. Unauthorised Shelters given to one Latif Gowala and Gyan Bahadur.

In view of the notice served to Sri Latif milk man and Gyan Bahadur it was that if Bahadur and Latif failed to vacate the Mission Compound they should be ousted from the Compound.

10. Vacation of quarters by Sri Z. Purty :-

In spite of notices for vacation served to Sri Purty He has delayed abnormally violating the decision of the Committee. Although he has been given alternative Quarters. Hence it was resolved that he should be asked to meet the officers to convey the reasons for failing to vacate the quarters occupied by him.

11. Technical Hostel at Babulane :- Many points were raised by the members and it was decided that the hos of the students and the institution under which they have been attached to be recorded. And if not found in the Institution will be asked to vacate. No relation either of any apprentices will be ~~accepted~~ occupied.

12. Application of Sri D. Kujur Clerk Cum typist for Allowances:- The Application of Sri Kujur was read out and it was found that the matter was ultra-veres and as such he should be informed that the application should be forwarded through the Manager to the Property Board for the needful.

13. Repair of Raja Bungalow:- As soon as Rev. Surin the Principal Theological College moves to the new caners; the same building if found necessary be repaired and allocated to Sri H. Lakra, the Manager of the Property Board. It was further resolved that a reference should be made to Mr. Shwerk for the suitable provision of quarters for Sri S. N. Kapoor.

14. Replacement of the old trees :- The Compound is full of the trees either for beauty or for other commercial purposes. It was viewed by Mr. Montag, the financial advisor, that most of the trees are very old, and useless in the ~~maximizing~~ commercial live. So old trees should be cut down and be utilised for the furniture and other purposes. At the same time care is to be taken that the old trees cut down must be replaced and the boundary hedge for the new trees which are quite unsafe will be made immediately after the old trees have been removed.

15. Bricks removed by the Jubilee Committee:- It was reported that the bricks stocked for the planning programme were removed by one Sri Phulchand Panna without permission. It was felt necessary to give view on this issue, and having a number of the beneficency views it was decided that the matter be referred to the Property Board for necessary action.

16. 1. Opening : The meeting opened with a prayer led by Shri P. Topno the Chairman of the Ranchi Committee on Properties, G.E.L. Church, Ranchi.
2. Attendance :

3. Application of Rev. Bixal Tirkey for quarters. : The application of Rev. B. Tirkey was read out and considered, and it was decided that the House No. 152 should be allotted to Rev. B. Tirkey formerly occupied by Rev. J. Lakra. In order to make the speedy action, it was decided that Rev. J. Lakra should be requested to take out all the bag and baggages lying in the Qr. No. 152. And also decided that the same quarter if deemed necessary be repaired. Regarding house rent of the quarters it was confirmed that an agreement regarding the allotment should be communicated as soon as the quarters occupied by the person is vacated.
4. Allocation of a suitable site for Kurukh Jubilee Library : The resolution of the Kurukh Jubilee Committee held on the 6th June, 1965 was read out and with due consideration and proper care it was decided by the Committee that a site for the construction of Kurukh Jubilee Library to prosper the Christian fellowship in the G.E.L. Church was selected as proposed by the Kurukh Jubilee Committee. The Ranchi Committee on the light of the food understanding with Mr. K. Shwerk resolved that the Ranchi Committee on Properties G.E.L. Church has on request of the Property Board of the G.E.L. Church in Chotanagpur and Assam allotted a Plot of Land measuring 95' X 75' (Length - South-North; width East-West) on the South-East corner of the Raja Bungalow Compound, as suggested by Mr. K. Shwerk the direction of the Planning side for erecting the said building.

The Ranchi Committee has also further resolved that before any building works commence a plan should be submitted to Mr. K. Shwerk for his scrutiny of the exact measurement of Land allotted in conformity of the Master Plan of the Church Compound and for his approval.
5. Nomination of Shri Michael Kerketta as new member : In view of the the Item No. 13 of the minutes of the last meeting held on 5.5.1965 was discussed and decided that the place left vacant by Shri Carnelius Toppo should be filled in. Shri B. Khess proposed the name of Shri Kerketta for the post vacant and with due consideration be was unanimously elected as a new member with effect from 7th June, 1965. Shri Kerketta should accordingly be informed for his acceptance; and an intimation to this effect be communicated to the K.S.S.
6. Fixation of rent of the Bungalow occupied by Rev. J. Lakra : As the bungalow occupied by Rev. J. Lakra consists 5 Rooms, the committee decided that House Rent of Rs. 25/- P.M. should be fixed which is fair and quite reasonable.
7. In view of the decision made by the Ranchi Committee on Properties G.E.L. Church, Ranchi it was opined by Shri B. Khess the Secretary, the Ranchi Committee on Properties, Ranchi that the decision taken by the Committee should materially be implemented.

Some points were raised by the members regarding the vacation of the session quarters and it was resolved that the persons failed to vacate quarters after the grace time allowed to them will be forcibly

forcibly driven out from the compound. In adopting the method it was decided that the members and the servants of the Board will jointly drive out such defaulters.

8. Collection of House Rent : On a grave scrutiny the Committee decided regarding the collections of house rent that the entire house rent within the compound should be collected by the Committee itself. To facilitate this work it was further decided that a full time assistant is to be appointed on the monthly Pay basis. His Pay and allowances should be borne by the Committee's share of 50 % and the rest 50 % should be credited to Property Board.
9. Shop Inspection : In pursuance of the rising market standard it was descussed that the rents fixed previously for the shops are very low. In due collaborated with the mission quarters it was decided that the Committee should inspect the entire shops with full details of the site and size of the shops and it deemed necessary the rent for the shops be fixed immediately.

1. Opening :- The meeting opened with a Prayer led by Rev. Schmidt the honourable quest.

3. The minute of the last meeting of the Ranchi Sub-Committee of Properties held on 10.4.65 was read and confirmed.

4. Item No. 3 of the minute of the last meeting held on 10.4.65 regarding opening of separate Bank Account, it was pointed out by Mr. Montag the Financial Advisor, that a separate banking account should be opened with the United Bank of India Ltd. Ranchi Branch, entitled "Repair Fund Account" in order to enable this Committee to meet the emergency expenditures for the betterment of this Compound. The views were accepted by the Committee and it was resolved that the banking account should be operated jointly by the Treasurer, Property Board, Ranchi and any one from amongst the members of the Ranchi Sub-Committee of Properties.

5. Item No. 9 of the minutes of the last meeting for Allocation of Land for Cow-shed.

Few points were raised by the members that Shri H. Lakra, the Manager Board of Properties, G.E.L.Church in Chotanagpur and Assam, Ranchi should be requested to allocate a particular site referring to the resolution forwarded to him dated the 10th April, 1965 for the construction of the Cow-shed by the Cow-owners themselves.

6. Allocation of land for Jubilee Library.

(a) Mr. B. Khess, the Secretary, Ranchi Sub-Committee of Properties reported the decision of the last Property Board meeting held on 11.4.65 regarding the site for Jubilee Library. It was decided by the Property Board that Ranchi Sub-Committee should be informed to look into the matter. That information does not appear to have been received by this Committee as yet.

(b) In view of the messages received from Dr. Berge the Director World Gossner Mission, Berlin by the Jubilee Committee regarding the construction of Jubilee Library it was verbally reported by Mr. Khess that at this juncture this Committee is not competent to allocate the suitable site for Jubilee Library as many members of the Jubilee Sub-Committee entrusted to negotiate with the Pastor Schmidt are away from Ranchi.

(c) It was further resolved that this Committee will take initiative towards the allocation of the site as soon as the Jubilee Committee negotiate with Rev. Schmidt.



7. Fixation of Rent on Press Building.

Respected member Mr. Mittenhuber voluntarily expressed his opinion to assess the rent of Rs.250/- p.m. for the Press Building which consists of 11 rooms and this voluntary offer was accepted by the Committee.

8. The Committee further decided that the house rent of the quarter occupied by Rev. J. Lakra should be fixed. For this particular job Mr. Mittenhuber and Shri Khess were entrusted to visit the Officer's Bungalow and put up the matter in the next meeting of this Committee.

9. One Shri Tigga has occupied the servants quarter attached to the Lal Bungalow which hitherto used to be occupied by the servant of the Officers residing in that bungalow. Now as all the officers have gone away these servants are not entitled to retain these servant's quarters. As the Pastor Schmidt as well as Mr. Montag the present Officers are in dire need of quarters for their servants, the Committee decided to allot these quarters to them. In view of this fact it was resolved that Shri Tigga should be asked to vacate the quarters occupied by him immediately so as to enable the Ranchi Sub-Committee to accommodate the servants of the officers working now in the G.E.L. Church, Ranchi. Further it was resolved that Shri Tigga should be asked to come to Shri B.Khess for discussion prior to giving him a notice for vacating the quarter.

10. Regarding the collection of rent.

(a) Many points were raised by the members and it was resolved that for facilitating the work of the Committee all the tenants should take their own responsibility to come straight to the Accountant for the payment of rent within the 1st to 10th of each month. Failing to do this, a Collector appointed for the purpose will visit door to door to collect the rent from the defaulters and for this special job .05 paise in a Rupee as fine will be charged from the defaulters. In no case any excuse will be entertained.

(b) Shri Eliazar Minz, the fellow member of this Committee was elected as a Collector on the Commission basis @ 5 % of the total rent collected.

11. Repair Works.

It was further resolved that two men Sub-Committee may be appointed who will look into the matter from time to time. And also resolved that this body will be competent enough to carry on their works of petty repair like roof repair etc. Major repair works should be referred to the Ranchi Sub-Committee on Properties, for necessary action. Shri B. Khess and Mr. Mittenhuber were appointed members of this Sub-Committee.

12. Application of Shri S. Buding for quarters.

The application of Shri Buding was considered and it was decided that Shri Z. Purti the ex-teacher of the Gossner High School should be asked to vacate the quarters and it should be allotted to Shri Buding. Attempt should be made to give accommodation to Shri Purty in the quarter occupied at present by Rev. S Surin. It was further resolved that Rev. Surin should shift to the Theological Compound.

In this connection it was fairly decided that the moment an employee retires from the services under the Church Institution he/she should vacate the quarters for the next successor. In no case the retired person will be allowed to stay in the Property Board's quarters within the compound.

1. The following by the Property Board nominated members attended the meeting :-

2. Dr. Berg read and explained the proposals forwarded by him and Mr. Montag to the K.S.S. and Property Board, which set up later this Sub-Committee.
3. As a temporary Chairman, not all members were present two not yet nominated, Mr. Mittenhuber was elected.
4. Mr. Montag gave a report about his experience in the Properties of the Church in Ranchi. Specially he reported about his recent meeting with the Chairman of Ranchi Improvement Trust were also Mr. N.E. Horo took part. Mr. Montag pointed out that the Improvement Trust has at the moment the intention to take up its work in the Main Road and other places where space is idle in the centre of the City. It was made clear that if our Church will not soon give a proper plan how the sites of the compound will be used the Trust will be able to take over our land through the Government. On the other side the Trust would help the Church in any respect in its undertakings if there are any.
5. The Sub-Committee resolved that a new Master Plan should be made to remodel the Compound and to be presented to the Improvement Trust.
6. Mr. Schwerk should be taken as an Architect he should appoint another Architect to assist him. This was found to be done most urgent.
6. It was recommended that in order to take up the work immediately land has to be sold to get necessary funds. In this connection it was resolved that Mr. Montag will negotiate immediately with interested parties.
7. Point 5 and 6 must go side by side (hand in hand) with the Master Plan. The Committee will think over and decide about the different points of which must be considered in the Master Plan (i.e. future projects as Hospit~~te~~ (hotel) or Hospital (?) which may be considered.
8. It was agreed that one of the most important and urgent project is the completion of the Compound wall as far as possible. For this work a loan should be taken which can later be repaid by land sold.
9. The Sub-Committee acknowledges that in future 50% of the Properties income will only be used in the local properties for remodelling repair work etc.



10. Mr. Montag announces that the Property Board will give to all tenants on the Compound a new tenancy agreement with effect from 1st April, 1965. For this he suggested and the Committee agreed that one person of the Committee should be elected to assist the Property Board in making :-
- (a) A census in the G.E.L. Church Compound.
  - (b) To fix the new rents which will become in effect from 1st of April, 1965.
  - (c) Assist the Property Board in collecting rents.
  - (d) Investigate in the necessary maintenance of building or their demolishing about which the Committee will decide.
- Mr. B. Khess agreed to take over this duties. The Sub-Committee is looking forward for the report of Mr. Khess.
11. In connection with the Military still occupying part of our Compound it was suggested that also a plan showing the future usage of this part of the Compound should be made to enable the Board to claim the land. The property Board should always have contact to Military especially watch carefully the eventually constructions work done by the Military.
12. The Sub-Committee acknowledges Mr. Montag's negotiating with Mrs. Barla who has tele~~ve~~ that big bungalow ~~whixh~~ where she lives alone.
13. The Sub-Committee agrees with the suggestion of Dr. Berg that the Christ Church must be repaired and furnished with a good visible (eluminated cross) which should latest be finished latest by 1969.
14. Mr. Montag said and it was also agreed to it that the Property Board has to secure all empty houses on the Compound, which the Sub-Committee will again lease through the Property Board. The Committee will always be consulted if there is any change in tenency.
15. Finally it was decided that the next meeting will be held on Monday the 29th March, 1965.

3. PROPER RELATIONSHIP BETWEEN THE CENTRAL PROPERTY BOARD AND THE ANCHAL SUB-COMMITTEES ON PROPERTIES, KHUTITOLY SYNOD AND THE HEAD QUARTERS CONGREGATION :

After discussing the draft presented by Pramukh Adhyaksh it was resolved that the draft is approved with certain amendments as follows :-

- (A). That, to administer the Properties within the Hd. Quarters Congregation, Ranchi, the Mandli Panch will form its committee of seven members which will be named "RANCHI COMMITTEE ON PROPERTIES"
- (B). The Manager and the Executive Officers have the right to attend and participate in the meetings of the committees on properties of Anchals, Khutitoli Synod and Head Quarters Congregation.
- (C). The arrangement for the management of the GEL Church properties within the Hd. Qrts. Congregation, Ranchi.
  - (a). That, similar to that of the Anchals or the Khutitoli Synod, the Mandli Panch of the Hd. Qrts. Congregation, Ranchi be given full responsibility for proper management and administration of the Church properties within the Hd. Qrts. Congregation., Ranchi.
  - (b). That, power and responsibility to be given to the Mandli Panch of the Hd. Qrts. Congregation, Ranchi may be withdrawn by the Centre if and when there be such need.
  - (c). That, in all such matters as selling or leasing of lands which involve the basic policy of the Church, the Central Property Board has to be asked for prior permission or approval.
  - (d). That, the Ranchi Committee on Properties will have the following functions :-
    - . It shall fix or re-fix and collect rents for lands given or leased residential quarters, shops and other such buildings given or to be given for commercial purposes. The areas allotted to various institutions and the buildings used for the same excluding the residential quarters and the two gardens given in contract to Gossner High School and Bethesda Girls' High School will be administered by the Management Committee of these institutions.

- (ii). Pay Municipal Taxes and other such taxes to the authorities concerned.
- (i). Lease out lands if required on permission from the Board of Properties.
- (i). Maintain all buildings, roads, gardens, tanks and wells etc.
- (i). Construct new buildings, roads and boundary walls etc.
- (i). Make necessary arrangements for lights, road-lights, latrines, sanitation etc.
- (i). Cut old trees and plant new ones.
- (e) The Ranchi Committee on Properties shall have its own office as well as staff for maintaining and administering the properties properly.
- (f). That, for the present the Ranchi Committee on Properties shall, for its fund retain 40 % of the total collections made and the other 60 % will be centralised to the Central Accountant of the Property Board. This will be revised by the Property Board from time to time.
- (i). The Ranchi Committee on Properties shall maintain proper accounts which will be annually audited by the centre. Monthly statement of income and expenditure shall be sent by the Ranchi Committee on Properties to the Property Board.
- (i). The Committee shall have its separate Bank Account with any of the Scheduled Banks at Ranchi and the same will be jointly operated by the Secretary and the Treasurer of the Ranchi Committee on Properties to the Property Board.
- (i). Whenever the matters in connection with the Ranchi properties are discussed by the Property Board, one of the Officers of the Ranchi Committee on Properties shall be invited to attend the same.
- (j). That, the Ranchi Committee on Properties will meet as and when necessary.
- (i). That, as in the case of Anchals and Khutitoli Synod, the Manager and the executive officers will have the right to attend and participate in the meetings of the Ranchi Committee on Properties.
- (i). That, the Ranchi Committee on Properties shall submit Quarterly Report to the Central Board of Properties through the Mandli Panch.
- (i). That, the Mandli Panch shall receive in all its regular meetings reports from the Ranchi Committee on Properties and give necessary directions to the committee for the proper management.
