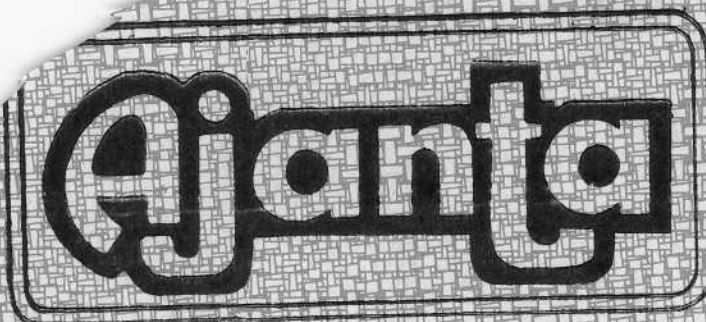

DATED : 22-1-92 to 25-1-92

RANCHI.

The meeting started with devotion led by Rev. M. Barjo Member KSS and Adhyaksh S.E. Anchal. Rev. C.S.R. Topno, Pramukh Adhyaksh who chaired the meeting while welcoming the member apprised them with the prevailing situation in the GEL Church in short and expressed his hope with confidence that the members present would take part active participation in the discussion.

Mr. Niral Kongari member, S.E. Anchal and Rev. S. Kerketta Adhyaksh, Madhya Anchal have apology send as writing for their inability to attend the meeting for unavoidable reason. Mr. J.S. Topno has requested the KSS meeting to grant him leave for the session for some very urgent and unavoidable reasons which was granted. Thereafter Mr. G. Tiru member was unanimously elected to be the Recording Secretary and Mr. V.M. Barla was asked to assist him.

As sufficient members required to form the quorum were found present. The chairman declared the meeting to be in order.

Item No. 3 : Matters from previous Minutes:

(i) Election of Board chairman (vide Item No. 2 (ja))

It was reported that Dr. P. Kerketta declined to take the responsibility to the chairmanship of the Board of Education on health ground. After some discussion Miss. Helen Bhengra whose name was proposed by Rev. J. Topno and seconded by Rev. S.K. Jojo was unanimously elected as chairman for the Board of Education. Her name is to be sent to all the Anchals for corroboration as required under provisions of the constitution.

(ii) Matter relating to Madhya Anchal (vide item 2 (jha))

It was reported that the direction to constitute a new managing committee for Khuntitoli High School has not yet been complied with. The members reiterated their earlier decision in this respect. Further 29 Acres of land said to be given to Khuntitoli High School be handed over to the Anchal and conciliation efforts be made with regard to pending court cases. Up-Pramukh Adhyaksh of the church and the Manager Properties shall visit Khuntitoli and settle all things.

(iii) Jatatoli Matter (vide Item 2 (Ta)) : The matter could not be solved properly. Adhyaksh Madhya Anchal could not make himself available during the visit of the commission to Jatatoli. Some action had however been taken but without any positive result. It was decided that both the members of the commission, namely the Adhyaksh, Madhya Anchal and Adhyaksh N.W. Anchal should visit Jatatoli again and that Adhyaksh S.E. Anchal be requested to accompany them.

(iv) Statistical Reports (vide item 3 (7)) : Matter came up from Assam Anchal. It was decided that all the Anchals of the church including Assam Anchal be directed to submit correct and up-to-date census report to the KSS Office for record.

(v) Orissa Anchal report (vide item 3 (Ga)) : Matter was decided to be taken up along with Adhyakshes report in item No.6 of the Agenda.

(vi) L.W.F. sponsored Exchange visit programme (vide item 4(4))

It was reported that Rev. M. Barjo, Rev. T. Kispotta and Prof. S. Kerketta have duly submitted their forms but no further information has been received by the office in this regard.

(vii) Theology Trained Women (vide item 8 (8)) : It was reported that Mrs. Marian Minz has not yet made her opinion available to the office and that Mrs. Shanti Juliani Tuti and Ezabela Tirkey have been absorbed in Pracharak Training School (PTS), Govindpur and that the UELCI has also been informed accordingly. Similarly it was reported that Mrs. Shilwanti Topno has also been absorbed as women co-ordinator in Madhya Anchal w.e.f. January, 1992. Mrs. Promila Lugun who was to be absorbed in Assam Anchal as Mahila co-ordinator, declined the offer. It was decided that the KSS Office should find out a suitable Theology trained women for Assam Anchal at the earliest. Mrs. Promila Lugun has been offered to work in Orissa Anchal.

(viii) Financial Aid to Mahila Samities (vide item 8 (Anga)1,2)

The members from concerned Anchals regretted that the amount of financial help have not yet been released to the grantees concerned. It was decided that the KSS office should direct the Kalisya Mahila Sangh, Ranchi to deposit the sanctioned amount i.e. Rs 6000/- for Khuntitoli Plastic Katai-Bunai Project and Rs 5000/- for Joradia Mahila Samite immediately to the KSS office for disbursement to the grantee Mahila Samities.

(ix) Loans from Revolving Fund (vide item No. 8 (Cha))

It was reported that the sanctioned amounts of loans from the church construction Revolving Fund have not yet been released due to present financial stingency in the church.

(x) Inter Anchal Transfer T.A. of Rev. M. Horo (vide item 8(Cha))

The Inter Anchal Transfer find T.A. bill as submitted by Rev. M. Horo for a total of Rs 15000/- (Rupees fifteen thousand only) was considered to be requiring reverification. The Pramukh Adhyaksh, the Treasurer of the KSS and Mr. G. Tiru, member from Assam Anchal were requested to verify the bill and finalised the amount to be passed.

(xi) Bethesda Primary Teachers Training College Teacher for.

Pension benefit (vide item No. 8 (Ja)) : More clarifications required Mr. U. Sanga, member has been requested to collect the same from the institution.

Item No. 4 Report of Pramukh Adhyaksh : Pramukh Adhyaksh gave his report from which the following points came up : -

- (i) CASA has decided to ask all the churches to donate some amounts towards the church Auxiliary and has fixed Rs 10,000/- for the GEL Church. The KSS is to consider the same.
- (ii) Out of 3 (three) KNH Homes, the one at Sundargarh is in very dilapidated condition which might be closed at any time. Efforts for improvement are however, being made.
- (iii) Youth programmes in the Centre : - Serious thought is to be made for re-instalising the youth department of the church particularly in the centre. It is decided that a convention of all the Anchal youth leaders particularly of Anchal youth organisation President or Director and the Secretaries and Treasurer be convened preferably during ensuing Kalisha Sangh meeting to form a Central Boady.
- (iv) Direct partnership : The Director G.M. be informed that the following Ilakas of the church have been selected to enter into a direct partnership with the Lutheran Churches in Germany : -
- (1) Assam Anchal - Lower Assam Ilaka.
 - (2) Orissa Anchal - Rajgangpur Ilaka
 - (3) Madhya Anchal - Khuntitoli Ilaka.
 - (4) N.W. Anchal - Ranchi Ilaka
 - (5) S.E. Anchal - Takarma Ilaka.
- (v) Women Ordination : - Reported that Miss. Basanti M.G. of J.E.L.C. is going to be ordained on 26-1-92. It was decided that a greeting message be sent to her under case of Rt.Rev.B.D. Bagh, Bishop J.E.L.C. Kotapad Orissa.

Item No. 5 : Financial Matter :

Statements of Receipts and Expenditures for period 1-4-91 to 31-12-91 of General Account and that of the Board for the same period as circulated among the members of the KSS during the session were taken up for discussion and after a prolong discussions subject to Audit verification. Mr. A. Kerketta and Rev. Kispotta both members of the KSS were deputed to meet Mrs. H. Tete wife of Late Rev. M. Tete to collect copies of vouchers and other documents connected with the Accounts of the KSS of period prior to the death of Late Rev. M. Tete.

It was also decided that Rs 40,000/- (Maturity value Rs 53,796.00) presently kept in a fixed deposit accounts in the name of Dr. C.K. P. Singh, Director BEL be allowed to be kept in that accounts and in the same name with the date of its maturity i.e. till 10-2-1993.

Regarding release of loans of Rs 5000/- to Harmoti Joradia in Assam Anchal and Khuntitoli in Madhya Anchal it was suggested that the amount be released as soon as the fund is available.

Regarding payment of Atampalan Dan to the centre, it was unanimously decided that the Anchals be asked to regularise the payments without further delay. Mrs. H. Tete as she was out in Assam State. It was suggested that the Hd. Account be asked to submit a statement of financial position for period from the date of death of Late Rev. Tete to 31st March 1991.

It was decided that (i) The Finance Committee should meet on the first day of every month and that the Secretary Property Board and Manager Property will also be the members of the Finance.

(ii) That the Accounts of Central Institution and the BEL be got audited immediately. (iii) That the Accounts of the Anchals should also be audited and copies of Audit Report be forwarded to the Central Office.

Budget for the Period 1-4-1992 to 31-3-1993 :-

Both the Budget in the Budget of the whole KSS (General Budget) as well as the Budget of the Board of Properties for 1992-93 were taken up for consideration. Following decision were taken :-

(i) Atampalan Dan : - The per family rate of Atampalan Dan @ Rs 5/- is allowed to be retained. Appeal should be made to general people for their regular payment and that the Anchals be asked to see that the Atampalan Dan is fully collected and remitted to the centre.

It was also decided that there should be a special appeal to those members of the church whose financial position is better for donation a special Atampalan Dan and that the copies of the appeals with signature of the KSS office be sent to the Anchals and the Anchals shall issue the appeals to such members.

(ii) Head Accountant : - Decided that Mr. A. Barla, the Head Accountant of the KSS shall continue in his service only upto 31st March, 1992 during which he will have to complete all the pending accounting works for handing over the charge to his successor in perfect order.

Further it was decided that the present Head Accountant Mr. A. Barla should not make any financial transaction with immediate effect. Accordingly, it is unanimously resolved that henceforth the Bank Accounts of the KSS should be jointly operated by the Treasurer GEL Church whose signature shall be compulsory and either by the Pramukh Adhyaksh GEL Church or by Rev. J. Sanga, Accountant. This should be communicated to the Banks concerned.

(iii) After discussion following amendments have been made in the proposed Budget for the year 1992 - 93 of the G.E.L. Church in Chotanagpur & Assam, KSS Central Office :-

(A) Atampalan Dan income raised from proposed Rs 2,50,000/- to Rs 3,00,000/-

(B) New head of income introduced - Special Donation to church with Rs 50,000/- as estimated income.

(C) Contribution by Board of Properties raised from proposed Rs 1,50,000/- to Rs 2,00,000/-.

This raised the total income in the Budget from existing Rs 5,85,000/- to Rs 7,35,000/- .

On the expenditure side, (i) the staff salary & allowances has been reduced from the proposed Rs 1,77,060/- to Rs 1,57,000/- (ii) Gossner Theological College account has been corrected as to Rs 2,29,547/- . In this way the total expenditure including those of Theological College and Pracharak Training School has been fixed at Rs 9,51,030/- with a total deficit of Rs 2,16,030/-.

It was also decided that serious efforts be made to cover up the above deficit in due time.

Thus after thread-bare discussion the Budget of the G.E.L. Church in Chotanagpur & Assam for 1992 - 93 has been passed.

Item No. 6 : Report from Anchal Adhyakshes :-

1. Report from Rev. M. Barjo, Adhyaksh, S.E. Anchal.

The Anchal Adhyaksh in his written report stated that a sum of 500 DM is being sent by Gossner Mission for Andaman Church for its development. The Adhyaksh has also requested for a grant of Rs 25000/- loan for construction of the Jubilee building and that Cand. Siprian Jaria is to be ordained.

2. Assam Anchal : - Assam Anchal Adhyaksh, Rev. S. Mohan M.G. in his verbal report informed the members that serious efforts are being made to bring peace to the Anchal, to improve the administration and that the land allocation matter with Immanuel College has got to be settled immediately. He also stated that two candidates namely Candt. N. Lakra and Candt. B. Terrang are required to be ordained. Rev. N. Sirka (under suspension) is working among the divided group and that a letter written by Late Rev. M. Tete Ex-Pramukh Adhyaksh empowering 5 (five) pastors of the Anchal to extend pastoral services to the members of the dissident group is to be withdrawn by the Pramukh Adhyaksh. He has also requested to allow the Anchal to print the urgent religious books particularly the song books.

3. North-West Anchal : - Reported that there are 45,000 Baptised members including 8 convert families from Muslim community and 40 ordained pastors in the Anchal. Evangelical works in Mission Field are being carried on satisfactorily. There is a problem in Jatatoli but efforts are being made seriously to solve it.

4. Orissa Anchal :- Verbally reported that the problem created by the divided group is still continuing which is to be solved in earnest by the KSS as early as possible.

5. Madhya Anchal : In the absence of the Adhyaksh, Mr. A. Kerketta, Member KSS was asked to give a short report. He reported that presently there are 3000 families 17713 Baptised and 9101 confirmed members 9 ordained pastors, 69 pracharaks and 1 Pracharika, 3 Middle English Schools, 1 High School and 5 Primary Schools in the Anchal. A punchayat Bhawan is proposed to be constructed in church land which requires formal decision. Jatatoli matter is being solved. M.C. of Khuntitoli School has not yet been found. School hostel construction is yet to be started.

Discussion & Decisions on the Report :-

(a) S.E. Anchal :- Rs 25,000/- required as loan for construction of Jubilee Buildings be collected from the amount since advanced to Shopping Centre at Chaibasa. Cand. Siprian Jaria is allowed to be ordained.

(b) Assam Anchal :- Decided that letter 5 pastors written by the then Pramukh Adhyaksh be withdrawn immediately and copies of the letters to be forwarded to other pastors who are encroaching into other parishes shall also be forwarded with devotion to stop this unconstitutional activities. Pastors to whom the letter was addressed are Rev. C.S.B. Horo, Rev. L. Surin, Rev. M. Guria, Rev. W. Korkoria and Rev. M. Horo. Pastors who are to be copied are Rev. N. Sirka (under suspension) Rev. S. Tiru and Rev. R. Timung who is M. Field Supervisor.

(c) Orissa Anchal :- The dissident group of 8 pastors who have organised themselves as Swaiyan Sewak Sudhar Sangh etc. be directed to come to KSS Office Ranchi for counselling on 25th-2-92 (Tuesday) and the following members of the KSS should meet the pastors:

1. Rev. M. Barjo, Adhyaksh S.E.A.
2. Rev. J. Topno, Member KSS
3. Rev. S. Kerketta, Adhyaksh M. Anchal
4. Mr. C.S. Tigga, Member KSS
5. Mr. U. Sanga, Member KSS

8 pastors to be named by Orissa Anchal Adhyaksh also be asked to be present during discussion.

(d) Madhya Anchal :- Decision already taken.

Item No. 7 - Report of the different boards.

(A) Board of E.V.L. & Literature: Report placed by the Director of BEL of BEL was read out and important point requiring consideration were taken up.

(i) Decided that the Reading Room cum Human Research Development Centre Building construction work be started and the Director BEL is authorised to find out the financial resources.

(ii) Decided that the land allotted for BEL Reading Room cum HRDC (etc) be provided immediately with drainage system and Property Board to take up the work.

(B) Board of Theological Education :

(i) Decided that the College Agriculture land (peddy land) should continued to be cultivated the G.T. College. The KSS shall arrange for the future use of the said land from next year.

(ii) Pay Scale Revision Matter :-

Decided that Committee with the following members be formed to examine the existing pay scale of whole church workers including G.T.C. and the report with revised pay scale be submitted in the next KSS meeting.

Names are : - 1. Mr. U. Sanga

2. Dr. R. Dang, Principal, GTC

3. Adhyaksh, S.L. Anchal (Convenor)

(C) Board of Property:

All recommendations as made and submitted by the Property Board to the KSS have been approved (see Anexuture (1)).

Regarding land leased out to Bible Society of India, it was decided that the annual lease rent be increased to Rs 2000/- per annum w.e.f. from the existing Jan. 1992 of Rs 200/-: Manager Property to take up the matter.

It was further decided that a total of 5 acres of land at Jharsugda is allowed to be sold as recommended by the Orissa Anchal in plots and that 10% of the sale proceeds be deposited to the KSS fund.

Regarding allocation of land to Governor Bihar for construction of hostel for Gossner by the Welfare Deptt. it was decided that plot required for the purpose be only separated and earmarked for the Gossner College for the Girl's hostel purpose. This shall be communicated to the Gossner College.

(D) Board of Education:

All recommendations made and submitted by the Board to the KSS have been approved, see Anexatur (2) . The proposed seminar for Headmaster and Headmistress for the Middle and High Schools is approved subject to availability of fund.

(E) Board of Higher Education:

(i) It was decided that the members of the Board should visit the Central Institutions within their respective Anchals from time to time.

(ii) That report from the Head of the Institutions be called for and placed during future meeting of the Board. The report should include informations about availability of hostel facilities.

(iii) That Hostel Committees be formed by the Anchals/KSS officers as the case may be.

(F) Medical Board:

All the recommendations with minor modification have been accepted as given below :-

(i) Atleast one Medical Dispensary be opened in all Anchals should stand a dispensary at Baithabhanga with its own resources and submit report to the KSS.

N.W. Anchal shall study the possibility of opening a dispensary and bring formal proposal to the next KSS meeting.

(ii) The KSS should sponsor suitable candidates for training of doctors and nurses.

(iii) Amgaon Hospital be upgraded with nurses training school facility. Fund required for this should be found out by the KSS and that Dr. W.Horo should take initiative in this respect.

(iv) Full report regarding the possition of Purnapani Dispensary be called for by the KSS.

Item No. 8 : Matter from Ecuminical Bodies.

(i) B.C.C. - Verbal reports was placed by the up Pramukh Adhyaksh which was accepted.

(ii) L.W.F. - The Pramukh Adhyaksh report that Lutheran World Federation is going to meet in Madras in September 1992. Which shall be hoisted by UELCI.

It was decided that the proposals, if any, for contribution towards this end to be considered by the Finance Committee. of the KSS.

(iii) Report of NCCI matters were reported.

(iv) UELCI - Minutes of the joint accepted consultation meeting of the members of the KSS, Promotional Committee, Promotional Sub-Committee and the New Structure Committee held on 20 and 21st January 1992 was read out and proposals approved with minor modifications as below -

(a) That there should be one constitution, one organisation, one membership and one fellowship in the whole G.E.L. Church.

(b) That Anchals shall be called dioceses.

(c) That there should be 5 dioceses in the whole church with specific geographical boundary.

1. Assam Dioces
2. North West Dioces
3. South East Dioces
4. Orissa Dioces
5. Central Dioces

(d) That the present N.W. Anchal and the present N.W/GELC shall constitute one Dioces that is N.W. Dioces of the GELC.

(e) There shall be a Moderator for the whole church whose Head Quarter will be at Ranchi.

(f) That the Bishops of the Dioceses should be appointed by the Central Committee of the church for a term of 5 years who may however be reappointed. They are liable to be transferred to other Dioces.

(g) That the Dioceses should enjoy maximum autonomy, that is autonomy in maintaining relationship with Mission partner abroad, right of ordaining pastors, etc. With regard to membership in Ecumenical Bodies in national and international level the Central committee of the GELC shall be the only authority to nominate the delegates. The Dioceses shall have power to represent in the regional ecumenical bodies.

(h) That Bishops of Dioceses shall be constitutional Bishop (functional Bishops) and not Episcopal.

It was suggested that a formal resolution to draft a new constitution be passed and a committees to draft the same be constituted. Accordingly it was unanimously resolved that in view of the prevailing situation and changed circumstances in the church and in view of the fact that now it has become imperative on the part of the GELC to remodel the organisation and administrative structure of the church, a committee, to be called new construction drafting committee, be formed with the following members -

- (i) Rev. J. Topno - S.E. Anchal
- (ii) Rev. S.K. Jojo - Orissa Anchal
- (iii) Mr. C.S. Tigga - N.W. Anchal
- (iv) Prof. S. Kerketta - M. Anchal

- (v) Mr. G. Tiru - Assam Anchal
- (vi) Ranchi H.Q. Congregation Secretary or his nominee
- (vii) Miss. H. Bhengra - Mahila Sangh President
- (viii) Mr. U. Sanga - On behalf of the youth
- (ix) The Pramukh Adhyaksh of the church - Convenor.

All Anchal Adhyakshes who are not in the committee shall in consulant.

It was further resolved that the first meeting of the above committee be held in the last week of the month of March 1992.

Item No. 9 - Letters and Applications.

(i) Extension of services of Rev. N.E.J. Samad of Orissa Anchal is allowed for another one year upto 18-12-92 with effect from 19-12-91.

(ii) Higher Studies - Candidate N. Lakra and Candidat Ramjan are allowed to study B.D. subject to availability of Fund.

That for ordination of Candidate N. Lakra, Candidate B. Terang (both from Assam Anchal) and Candidate S. Jaria of S.E. Anchal be fixed in consultation with the Secretary of the church Ministerium.

Item No. 10 - Any Other Matter.

(1) Rev. N. Sirka (under suspension) matter - It was decided that Rev. N. Sirka, under suspension, Assam Anchal, be called for counselling to KSS Office on 25-2-92.

(2) Kalishya Sangh -

Decided that the Kalishya Sangh 1992 be held from 27th. to 29th March 1992, the arriving date being 26th of March 92 evening.

In this connection it was reported by the Pramukh Adhyaksh that 39150 Dm. is being made available to the church by G.M. for helping church workers etc. Finance Committee is authorised to consider if any amount out of the above grant could also be utilised for the Kalishya Sangh.

(3) Resolved that a monthly allowance at the rate of Rs 300/- p.m. be allowed to up-Pramukh Adhyaksh w.e.f. January 1992.

(4) It is decided that during all KSS and Kalishya Sangh meetings a Steno-cum-Typist be engaged on contract basis for recording purpose.

(5) Letter from Mr. J.S. Topno, Secretary, KSS - A letter dated 23-1-92 from Mr. J.S. Topno was read out by which he has requested to relieve him from the Secretaryship on health ground.

Decided that Mr. J.S. Topno be requested to continue in the office in view of the present situation in the church. And that the KSS should see that the Secretary is assisted in his work as and when required.

With vote of thanks to and the chair the meeting ended with prayer led by Rev. J. Topno.

"ग" उड़ीसा अंचल के अध्यक्ष की रिपोर्ट :- अध्यक्ष द्वारा मौखिक रिपोर्ट दी गई ।

1. उड़ीसा अंचल में खास राजगंगपुर में मालगुजारी देने संबंधी मामला बहुत वर्जों से लंबित है । अभी तहसिलदार के पास यह मामला है । 3000/- रुपये तक मालगुजारी चुकानी है । अंचल, समस्या के समाधान के लिए प्रयत्नशील है । सदस्यों द्वारा राय आयी कि यहीं पर उड़ीसा अंचल मामला को लिया जाय ।

The meeting of the full K.S.S. started with prayer led by the Pramukh Adhyaksh of the Church. He read out the scripture from Psalm 23 and welcomed the members of the K.S.S.

Rev. S. Kongari and Mr. V.M. Barla from Assam Anchal, Mr. A. Toppo, Co-opted member from Ranchi, Head Quarter were found absent without any information to the Pra. Adhyaksh. As most of the members were found present the chairman (The Pramukh Adhyaksh) declared meeting to be in order as per rule.

3. Matters from the Previous Minutes :-

(A) Election matter of N.W. Anchal - The matter is a pending subject from the K.S.S. meeting held on 26,27 February, 1991. The copies of the ruling and judgement of the Election Tribunal on the election of Rev. S. Toppo, as Adhyaksh and Mr. Jonson Lakra as Secretary of the N.W. Anchal were distributed among the members for consideration. After prolonged discussion the members while unanimously deciding to accept the

view of the Election Tribunal it was preferred to refer back the matter relating to the election of Mr. Johnson Lakra as Secretary of the N.W. Anchal to the Election Tribunal for review and reconsideration. Solely on the basis of the clear, specific and the comprehensive constitutional provision given in CHUNAW NIYAM NIRMAY 13, DHARA 2, "CH" - 8. It was also unanimously observed that the K.S.S. of the G.L.L. Church duly constituted as per provisions of the constitution of the church does not take any cognizance of any ruling, if any, made on such issue or issues in the past at the initiative of any authority other than the K.S.S. of the G.L.L. Church.

(B). Appointment of Office Superintendent and Property Manager: -

The Chairman informed the members that one application for the post of Office Superintendent one Mr. Martin Tirkey a local person of Ranchi Head Quarter Congregation, it was also given to understand that the candidate was approached in pursuance of the instruction given by the members during last meeting of the K.S.S. It was decided that Mr. Martin Tirkey be interviewed by the officers of the K.S.S. for the post of office Superintendent and if found suitable for the post to appoint him on probation for a period of six months before regularisation for his service.

3. Matters from Bd. of Properties : -

The minutes of the Bd. of Properties was read out by the Secretary of the board which revealed the following main points require the attention of the K.S.S. : -

(i) That the plot of land given to the Gossner College of the North Eastern side of the Khijuria Tank measured 800' x 140 sq. ft. and that the plot of land is covered by Plot No. 1193.

2 (A) Chutupalu Land : - Efforts are been made collection of the more information with a view to start service and also, if possible to start a primary school.

(B) Regarding opening of a girl's hostel for the Gossner College by the Welfare Department of the government full informations are yet to be collected.

3 (A) Jubilee Bunglow : - The members were informed that the Jubilee Bunglow has been renovated with urgent repair excluding installation of water supply system and that Rs 30020/- being the cost of the iron gruel is yet to be paid to T.T.C. Fudi.

(b) Lal Bunglow : - The members were informed that till today Rs 5196.38 has been spent for the repairing work and that the cost of repairing the pump house and the well is yet to be paid to T.T.C. Fudi.

4. Repair of Compound Wall & Building of the K.S.S. Premises : -

It is stated that the compound wall on the southern side and the old building in the K.S.S. compound are being repaired on urgent basis for which Rs 74000/- has been advanced already.

5. The Manager Property Bd. has requested for appointment of a person with knowledge and experience on survey of land. The Bd. of properties has also decided to confirm the services of Mr. J. Kujur and Mr. Joy Minz as rent collectors with effect from 1-6-89 and 1-6-91 respectively with provident & Pension fund benefits. The Property Manager will specify and allot duties to above rent collectors.

6. The Bd. of Properties has also decided to allow Miss. Jinid Surin development Co-ordinator to be appointed as L.D.C. in the prescribed scale with effect from 1st June, 1991 and Sri. Jyoti Kerketta as Mali-cum-peon in the prescribed scale of grade IV employee with effect from 1-6-91.

7. The Bd. of Properties has also recommended for appointment of one more driver-cum-peon for the K.S.S. Office.

8. Purulia Land Matter : - It was reported that special power of Attorney has been given to five local persons of Purulia congregation to deal with the case including rectification of the land records particularly relating to the actual area of land presently owned by the GELC.

9. Tujur Land : - It is stated that a big area of church land has been illegally encroached by some outsiders (Kumhars) against whom legal action has already been initiated and that a sum of Rs 2000/- has been decided to be advanced to south-east Anchal for dealing with the case similarly Rs 1000/- be advanced to Rev. T. Kispotta, Pathalgaon, Udaypur to fight out court case in Bilaspur High Court against Sunil Tirkey of Lureg.

10. Daltanganj Car Accident Case : - The Bd. of Properties has sought approval for spending Rs 50000/- for the case.

11. Assam Anchal Land : - The Bd. has recommended that special power of Attorney be given to Assam Adhyaksh for selling some plots of land of Tezpur. It is also recommended that similar special power of Attorney be given for sale of other plots of Assam Anchal on receipt of specific proposals from the Assam Anchal.

12. Barobisa Land : - It is stated that some portions of Barobisa (N.W. Anchal) church land has been sold by the N.W. G.L.L. Church illegally and without any knowledge of the G.L.L. Church. It is also stated that Rev. Mathias Surin of that area has been given special power

of Attorney to take necessary legal steps against the deal

13. It was reported that Rev. Cyril Hembrom had occupied a big portion of Pramukh Bunglow. Decided to vacate the bunglow soon.

As most of the matters coming from the Bd. of Properties were directly related to finance, the members desired that the report of financial position of the K.S.S. be first taken up for consideration.

Financial Matters :

(1) From the memorandum submitted by the finance committee (Item No. 7) it was given to understand that Rs 528217/- should be the approximate annual income of the property Board. As such after diversion of Rs 1,50,000/- from this amount to the general income of the K.S.S. as per budget of the K.S.S. for the year 1991-92. A good sum of money remains in the hand of the Bd. of Properties. It was therefore, Decided that all projects proposed to be taken up by the Bd. of Properties should be limited within this balance amount which should also include the administrative cost.

(2) The following matters coming from the financial committee were also taken up for consideration : -

(A) Proposal to deposit Rs 200000/- from the P.F. account in fixed deposit for five years. The K.S.S. approved the proposal.

(B) Proposal to deposit Rs 150000/- from the Pension Fund Account in a fixed deposit with provision of quarterly transfer of the interest to S.D. Account. The KSS approved the same.

(C) Proposal to transfer Rs 25000/- from the Pracharak Pension Fund in a fixed deposit account. The KSS approved the same.

(D) Proposal to grant relief to all pensioners inclusive of retired pastors/widows and retired pracharaks/pracharikas at the rate of Rs 15/- each per month with effect from 1-4-91. The KSS after some discussion approved the proposal.

(3) (i) Proposal to amend the existing rate of contribution to P.F. and Pension fund. The finance committee has proposed to raise the rate of contribution of P.F. from the existing 0.8 paise to 0.10 paise per rupee for both pastors and the paying body, and to raise the rate of contribution of the pension fund from the existing 0.4 paise to 0.5 paise per rupees on the basic salary per month for both pastors, pracharaks and the paying body. The KSS after thorough discussion the matter, approved the proposal.

(ii) Financial Year : - It was decided to maintain financial year from April to March. It was also decided to make a scholarship fund in the church level.

(4) Proposal to enable the candidates to be the members of the pension fund from the date of their joining service : - As per existing rule they are eligible to contribute to this fund from the date of their Ordination. The KSS agreed to amend the rules and approved the proposal.

(5) Refund of loan to P.F. Account : - It was resolved that the loan approximately Rs 300000/- taken from P.F. account during 1983 to 1987 be refunded to the said account in instalments in such a way that the whole amount be liquidated in about two or three years time, and that the first instalment of rupees 50 thousand immediately be refunded from the balance amount of the income of the Bd. of Properties.

(6) Proposal for creation of Endowment Fund for Theological Education : -

After some discussions the members unanimously agreed to consider the matter along with the budget of the Theological College for 1991 - 1992 as submitted by the Principal.

(7) Proposal to deposit Rs 200000/- from the foreign contribution money in a short term fixed deposit scheme. The KSS approved the proposal.

(8) Gossner Mission special grant for Women Work : - It is stated that a sum of rupees 60252.60 has been received from the Gossner Mission for some women welfare projects. The KSS decided to allot the amount in the following manner : -

(i) GEL Church Hd. Quarter Congregation Mahila Samity (Anugrah Bhawan) - Rs 15000.00.

(ii) South East Anchal Mahila Samity Knitting & Sewing Training centre Govindpur - Rs 15000.00.

(iii) G.E.L. Church Mahila Sangh including (Mahila Samities of different Anchals) - Rs 30252.60.

It was also decided that projects for grant of financial assistance from this amount for women work be invited from the Anchals.

(9) Proposal to keep the church construction revolving fund in a separate bank account : - It is stated that a sum of Rs 24114.01 is at hand as balance. The KSS agreed to deposit the same in separate account. During discussion it was given to understand that B.S. City congregation as per instruction from the former Pramukh Adhyaksh paid Rs 5000/- and Rs 10000/- to GEL Church Muri and south East Anchal Hd. Quarter respectively.

Out of the refundable money granted to them from the revolving fund, the KSS decided that these two congregations be asked to refund the amount to the fund. Further, the proposal of the finance committee to transfer the sum of Rs 24114.01 to GEL Church fund A/c. No. 604 in the Central Bank of India Ranchi which has an existing balance of Rs 3156.50 (which should also be treated as church construction revolving fund) is also approved by the KSS.

Staff Matters From Finance Committee :-

(i) The KSS approved the proposal for appointing Mr. Sursen Surin as assistant accountant with effect from 1-6-91 in the scale of Rs 900-25-1025-30-1175-35-1350.

(ii) The KSS is also approved the proposal to sanction an ex-gratia grant of Rs 500/- to Mr. Daud Aind, the peon of the KSS Office and also allowed the amount of Rs 29853.81 which was snatched away by some miscreants from the possession of Mr. Daud Aind. While coming from the bank to be kept under suspense in the account of B.E.L.

It was also decided to move the Govt. authorities to take necessary steps for restricting the anti-social elements within the area of G.L.L. church compound, Ranchi.

As desired by the members, matters coming from the Bd. of Properties were again taken up for consideration and after some discussion all proposals and action taken by the Bd. of Properties on various matters as detailed earlier were approved. As the Bd. of Properties has also proposal for construction of a guest house on the western side of the Lal Bunglow at a cost of Rs 20,0555/-, the members unanimously expressed their desire that the existing old building which is being presently renovated within the KSS Office premises be completely reconstructed with double story provision, so that the upper story of the building may be utilised as guest house. The KSS approved it and authorised the Bd. of Properties to proceed on with the project.

Regarding Purulia Land : - While approving the action taken by the Secretary, Bd. of Properties the KSS decided that the local taxes etc. of the Purulia land be arranged by the Purulia Congregation and that the proposal for sanction of any extra requirement in this regard be sent to the KSS through proper channel.

Proposal of the Bd. of Properties to construct some residential buildings on the eastern side of Jubilee Bunglow has been kept pending for the time being by the KSS. The KSS decided to recommend to the Bd. of Properties that demolishing wall be constructed between the Lal Bunglow and the Women Teacher Training Institute premises at an early date. For proper work in the sanction of Property Bd. of the KSS Office, the K.S.S.

decided to allow Sri. Sursen Surin as an assistant accountant of the Property Board to deal with the under Hd. Accountant. The KSS has also allowed. Conveyence allowance to rent collectors Rs 30/- per month each Mr.J. Kujur and Mr. J. Minz Two rent collectors are also allowed the P.F. and Pension benefit with effect from the date mentioned. The KSS also approved the proposal to allow the vacaed land on the club road in small plots on land rent basis to desirving candidates and the property manager should take necessary steps.

(C) Election of Chairmen for different Boards : - The chairmen informed the members that only three Anchals namely Assam and S.E. Anchal have till today sent their coroborative dicision. It was decided that the remaining three Anchals namely the M. Anchal, N.W. Anchal and Orissa Anchal be requested to sned their decision latest by 31st. July, 1991, failing which their silence will be treated as their positive coroboration.

(D) Matters from M. Anchal : - It was decided that a three men commission with the up-pramukh Adhyaksh Rev. S. Toppo, Rev. S.K. Jojo and Rev. J. Topno be sent to M. Anchal to settle the matter connected with the two pastors namely, Rev. J. Kullu and Rev. E. Ekka. Rev. S. Toppo shall be the convenor of the commission. The commission shall submit the report before the next KSS meeting.

(E) Ordination of the candidats : - The chairman reported that the candidats from Orissa Anchal were ordained on 16-6-91 in the Christ Church Ranchi. The candidat from Assam Anchal could not avail this opportunity. The KSS decided that cnadidat Niral Bhuinya be ordained in the month of July, 1991 at any congregation in Assam.

(F) The Sunday School Syllabus Committee : - The report of the Sunday School Syllabus Committee was read out which has recommended for acceptance of the sunday school syllabus prepared by the Ranchi Ilaka of the N.W. Anchal. The KSS approved the same and authorised Rev. Cyril Hembrom to prepared the sunday school teachers, Handbook on the line of the same syllabus.

(G) The Promotional Sub-Committee's Report :- The report was read out and it was accepted with thanks. After discussion it was resolved that the report of the promotional sub-committee be sent to promotional committee to consider and bring proposals to the KSS for approval. Accordingly the report of the promotional committee was read out and the recommendations were approved. The KSS also authorised the promotional committee to discuss the matter with the UELCI and N.W. GEL Church on the line of these recomen-dations.

4. Matters from different Boards and Promotional Sub-Committee :-

Board of Evangelism and Literature :- Report of the board was read out and accepted with thanks and following decisions were taken :-

(i) Liturgy in Bengali : - Decided to print the liturgy in Bengali on receipt of the scripts from Rev. N. Bor. Mr. G. Tiru from Assam Anchal also requested to print the ARADHANA BIDHI & SMALL CATECHISM in Assamese. The scripts of which are ready for printing. It was suggested that the proposal be sent by the Assam Anchal along with the copies of the scripts.

(ii) Project for Reading Room : - It is reported that about a sum of Rs 175000/- is kept in deposit for construction of Reading room-cum-guest house to be constructed near Khijuria Tank. The members suggested that the efforts be made for collection of at least Rs 2250000/- from both indigenous sources etc.

(iii) Five Points Programme (Gramodayasray) : - The constitutions made for the implementation of five points programmes sponsored by the B.L.L. was placed for approval. It was decided that the copies of the constitution be made available to all the members of the KSS and the matter be brought up for discussion and necessary approval in the next KSS meeting.

5. Report from the Pramukh Adhyaksh and Anchal Adhyaksha :-

The report of the Pramukh Adhyaksh and Anchal Adhyakshas were read out and the same were accepted with thanks. The following matters from the reports were taken up for discussion and decisions taken.

1. UELCI 10 years plan : It is decided that a committee be formed with the following persons to prepare a plan for ten years training programme for the UELCI immediately and be submitted to the Pra. Adhy. before 24th June, 1991 : -

1. Rev. C. Hembrom
2. Mr. U. Sanga
3. Mr. C.S. Tigga (Convenor)

2. Problem from M. Anchal (Jatatoli) : - It was decided that be report of the commission constituted previously for the purpose some time in 1986 be first made available by the office enabling members to take necessary decision on the matter. Ordination of candidate Anjor Dungdung : - The matter related to this was approved for necessary action.

3. Matter from Orissa Anchal :- The officers of the KSS were authorised by the members to circulate CHAR ANI PATRI among the brothers and sisters of Orissa Anchal explaining to them about the real situation.

4. Purnapani Dispensary : - It was reported that Purnapani Dispensary has been reopened at the initiative of the local congregation and that Dr. Horo from Amgaon has also given assurance to visit the same time to time.

The KSS sanctioned an ex-gratia grant of Rs 2000/- to enable the dispensary to meet its immediate urgent need as requested by the local committee.

5. Matters from N.W. Anchal : - It is reported that a sum of about Rs 70000/- being the P.F. money of the Pracharaks are lying with N.W. GELC. It was decided that a list of such pracharaks be furnished to N.W. GELC with request to transfer the amount to N.W. Anchal.

6. Matters from National & International Church Organisation : -
Matters from Bible Society, Ranchi - Rs 5000/- being the dues from C.C.P. House secured during the time of Sri. A.D. Topno be paid to the Bible Society in instalment and the land rent due to be paid by the Society to the KSS in respect of land rent be also realised. Further it was resolved that the land rent also be enhanced with immediate effect.

(ii) Gossner Mission Matter : - It was stated that there is a possibility on the part of G.M. to divert some portion of the BLL money to the N.W. GELC, which was objected to by Rev. Dr. C.K. Paul Singh member Kuratorium from Gonner Church. The views expressed by Rev. Dr. Singh and the action taken by him in this respect is approved by the KSS.

7. Letters and Application : -

(A) The chairman informed the KSS that one candidat and one pastor one Miss. Nutal Bage have already left for Gurukul Madras for B.D. Course which requires approval. He has also stated that one more application received from Nelson Lakra from Assam Anchal is to be considered. After some discussions the KSS decided that the case of Nelson Lakra be forwarded to Gurukul only if the source of his scholarship is ascertained. The applications of three persons are approved.

(B) Extension of the services of the pastors : -

(i) Rev. D.D. Toppo : Kept pending on request from members N.W.A. for want of formal approved by the Anchal.

(ii) Rev. J.S. Soy, S.W. Anchal : This being the case of first extension the KSS allowed the extension of one year to his service.

(iii) Rev. D.D. Tigga, N.W. Anchal : Rejected after due consideration.

(iv) Rev. N. Surin, M. Anchal : This could not be considered for want of Anchals recommendation.

7 (A). Financial Matter :- Already taken

8. Matters from Building Construction :- No report has come from construction committee and as such the matter could not be taken up.

9. Other matters of Importance : - (i) Inter Anchal Transfer :

(a) Rev. Martin Horo, Assam Anchal : His case is dully forwarded by the Assam Anchal with recommendation.

The KSS allowed him to be transferred and posted in South East Anchal with effect from 1st August, 1991.

(b) Rev. Nehemia Topno, S.E. Anchal : - The KSS allow him to be transferred and posted in Head Quarter Congregation with effect from 1st July 1991, in place of Rev. Hemant Baba.

(c) Rev. Santosh Surin, S.E. Anchal , - His case could not be considered as the H. Anchal has raised objection in accepting him.

All the above cases was duly considered and forwarded by the transfer committee.

(2) Application from Assam Anchal : - Assam Anchal has applied for grant of ex-gratia relief to minor girls of one of the Lutheran congregations of Assam Anchal who fell victims of military atrocity during early part of the President rule in that state. The KSS authorised Assam Anchal to release some financial grant to the said victims out of the sale proceeds of land of Tejpur and to report the matter to KSS.

(2.) Appointment of Candidates :- The KSS was informed by the Adhyakshas of the concerned Anchals that all the candidates except ~~Candidat~~ Peter Topno are being absorbed in the respective Anchal. The candidates were observed by the following manner : -

Candidat R.K. Topno of Hd. Quarter Congregation is allowed to be appointed as honorary Youth Director of the Hd. Quarter Congregation. His expenses towards travel or visitation be paid by the Hd. Quarter Congregation.

(3) Get together of retired pastors :- The application for holding a get together for the retired pastors of the church have been received but the same could not be considered now for want of fund.

(4) Application from Assam Christian College : - The general Secretary Assam Christian College Association Tejpur has sent two application, one addressed to executive Secretary UELCI Madras and the other addressed to the Chairman Gossner Mission Auditorium for financial assistance for the development of the college. The members after some discussions

allowed the application to be forwarded to the respective organisation by the Pramukh Adhyaksh.

- (5) Application from Principal Bethesda Women's B.Ed. College, Ranchi : -

The principal has requested for a grant of Rs287000/- to meet the expenditure of college building. The application could not be considered immediately for want of fund and budget provision. It was suggested that in future some provisions should be made in the budgets of the church for such grant-in-aid.

- (6) Letter from the Secretary N.W., G.E.L. Church : - The NW-GELC has requested for providing seats to seven students of their group in the current session of Gossner Theological College. It was observed that no action could be taken on the matter until the Promotional Committee achieve some positive progress in dialogue with NW-GELC.

- (7) Appointment of office superintendent : - The report of the interview committee was received however the members after some discussions about Sri. Martin Tirkey a retired employee of Tele-com-Department allowed that the applicant be appointed as an associate office superintendant to work under the existing office superintendant for a specific period of one year with effect from 1-7-1991 in a fixed monthly amolument of Rs 800/- only.

- (8) Head Accountant : - It is decided that the present Hd.Accountant Mr. A. Barla should continue in his service upto 31st October, 91.

- (9) The KSS decided to revise the travelling T.A. rule for the members of the KSS as below : -

(i) For Assam actual plane fare or first class railway fare if second class accomodation will not be available actual rickshaw and porter expense and Rs 40/- as fooding allowance for every 24 hrs. of journey.

(ii) For others actual railway or bus fare, porter and rickshaw fare Rs 15/- as fooding allowance for every 12 hrs. of journey.

- (10) Confirmation of the minutes :- It was decided that the minutes of the KSS meeting held from 16th to 19th June, 1991 be confirmed by the KSS officers and other available members.

There being no other business the meeting ended with vote of thanks and a short prayer led by Rev.Junul Topno.
