Thank you very much for your kind letter (dt.19.10.79). Before this, a letter written by your and sent along with the copies of letters written to Rev.M.Tete, and Mr. B. Topno (Lita Bhai) seemed to be taken out from the envelop cut with a blade, only the copies were inside. I suppose, someone might have taken the letter out. Thank you for the letters.

First of all I would like to tell you something about the big meetings :-

- 1) The General Meeting (Am Sabha) was attended by some 120-130 christians f from all Anchals and Ranchi Hd. Qtrs.Cong, from Assam only the Adhyaksh was present. Specially the present crisis of the church was discussed after some detail informations and lectures on church unity. The Meeting was meant specially for informing the people about the actual position of "NW-GELC" and how almost in all Ilakas congregations are coming back after they knew that "NW-GELC" is going to form a new church with Bishop and relationship with America.
- 2) This General Meeting was followed by the Kalisha Sangh a constituational meeting in which representatives from all Anchals, Ilakas etc. were present. Reports from KSS officers, Boards Central Institutions and Anchals were received and discussed. Certain recommendations were made to the KSS for actions. But is I have seen many of these recommendations would remain on papers only as in past times.
- 3) KSS meetings: As per schedule central Boards had their meetings. As the Madhya Anchal has given negative votes to the elections of the different chairman of the Boards, the Pra. Adhyaksh has to chair all the Boards. In Boards meeting itself started about the representation of NW Anchal Dr. Tigga and other Rev.Toppo. But after hide and seek situation the Bds meetings were conducted.

Thereafter KSS meeting like two Boards meetings were to be conducted in Bethesada Training College. In the agenda of attendance representation from Madhya Anchal was questioned. Rev. Tete who did not go to Khutitoli when he was elected Anchal Adhyaksh; he is again elected as "Honorary Anchal Adhyaksh". This was said to be unconstituational and it soon became a subject of hot discussion. It seems that Rev. M. Tete would be elected.

The Guests, under the leadership of Frau Friederici; were here and I hope they have enjoyed the visit as we also did. We were facing some difficulties as the "NW-GELC" friends had informed the local and the higher police officers warning them of break of peace. But nothing serious happened.

Your intended visit to Nepsl and also to India in March/April/May 1980 may be better to finish latest by the 2nd week of April. Lent season amay be good to meet people and to talk with other leaders, because in lent season we do not have other programmes. It would be good if you would write to the Pramukh Adhyaksh for such possibilities.

Thank you very much for your kind letter dt.20.9.79 along with blind copies of other letters.

As you have mentioned in some letters and also in the "Gossner Mission" (BIENE) about my not candidating for membership in the Kuratorium, I would like to clarify my stand and principle, so that you may have note of my position for any membership in any committee or board. I feel myself responsible to be member or officer in any committee, I do not understand it as my privilege or chance, therefore where ever there is a competition or rating afor talking one of the other, I voluntarily withdraw myself. Till new I have been able to keep this principle, and I have accepted only those posts, which have been unanymously decided. In reference to our particular case, I thought it to be fitting not to candidate, when the director himself has proposed another's name with good reasons and also the KSS decided to elect its own representatives perhaps with evil intention!

But I am happy that Dr. Bage has been elected and I do hope, he will accept the membership to serve the purpose on both ends. At this point I would like to say that as 'Kurator' he will automatically get the membership in the FTC Trust and also visitor membership in the UMN, Please inform him and the concerned officers with this regard.

I hope by this time the Pramukh Adhyaksh Rev. Soreng has informed you about the same new Beak a/c No for BEL. In my one letter I have already informed you about the same. I am not quite clear whether I can pay all the workers even with this facility of new Bank a/c . Because the KSS has decided in its meeting that all bills must be signed by the Anchal Adhyaksh for payment by the BEL, i,e, if any field would directly submit its bills - like NW, GELC, such field would not get the payment. By now all workers in Surguja are being paid up to date and it is very likely that workers of Udaipur also shall be paid very soen. The workers of Udaipur field have been paid up to June 79 - ca Re.50,000/- from the

workers' P.F. and Pen.F. account kept by the field itself. This amount

has to be accounted for when the payment from BEL will be made.

It is not true that I have ever forced the superindendents to sign any paper of loyality to Rev. Soreng before they would get their pay, on the contrary I had always tried that they should get their salaries. With this intention only I wanted to visit the fields, but they denied even my authority. The truth is that the KSS has decided that all bills should come with the signature of Anchal Adhyaksh, and accordingly I am unable to do any procedure. Meanwhile some of the workers of Surguja came to know that they have been kept under "NW - GELC" and therefore they were not getting the salaries, so along with pastors they applied for payments and also expressed their loyality to KSS, so Rev. Toppo Superintendent, joined with all workers gets payments. This all was done when I was in Serampore. Now the workers of Udaipur are also trying to do the same - except Rev.S.Tirkey, Superintendent and some other, Rev.O.Toppo told me last week that workers of Udaipur met him for advice and it seems that they are ready to do the same as the workers of Surguja.

The whole matter is not yet quite clear. But from 15th Oct. we have the x Am-Sabha- the general meeting -in which every one can participate of his own and xmay be allowed to put questions, specially about the "NW -GELC" and GELC matters, thereafter is the Kalisha Sangh (according to the constitution) - where the laymen have the voice. These two may reccommend certain things- also in regard with the "NW - GELC" matters and the KSS is to sit for this first after these two confrences to take necessary decision and I hope BEL as well KSS has to take specific decisions in regard with payments and future policies, because I have also certain plans for the mode of work of the BEL. One of them bring the use and importance of a Separate Bank a/c for BEL. Certainly this new a/c shall help to guard the BEL money so far very often used also for other purpose.

After my teaching time in Serampere I and 14 students with me in Chakradharpur, area Mission field and therefore after in Ranchi also for the

Thank you very much for the reports of your visit to our GELC, at this point I am not making any comment, however, when time comes and if it will be necessary I shall make some observations. As Dr.Bage knows German and as he would my successor in the Kuratorium I have given the report to him that he may read and form his own opinion and guide the KSS and other committee members along with some suggestions acceptable to them. As you might have come to know that for the current KSS term in the pramukhship of Rev. P.D.Soreng I have withdrawn myself from KSS Bds, committee, except the BEL, so I have no time and plateform to speak out some of your suggestion, though time and again I have pronounced some unofficial statements and my opinion.

The situation in the church is almost the same, except that the Missionfields in Madhya Pradesh; i.e. Udaipur and Surguja are gone to the NW GELC. I could not conduct the Refresher Course for them, they also have not received their amount due, I did not get Bills, or any letter concerning to their payment, they also did not come. I do not know what to do, however I may visit in the first week of February and try to find out their arrangements if any. I also not know, whether they get any help directly from other sources.



Thank you very much for your kind letters and also copies of some letters written to the church leaders. As I was for the most time in past month in Serampore I could not reply you. On 9.9.78 I came.back from Serampore and shall be staying now here attending my duties. So this is the first letter I am writing after coming back. Yesterday I was quite busy to sign some of the bills and talking to various persons with the problems.

I had a nice time in Serampore and it was a quite different experience with some international and interdenominational teachers with students almost from all parts of India. As paster Kloss, who is now in Berlin is unable to come for Oct. - Dec. term the College wanted to retain me for that terms also, but as I have already set programmes for here I shall not be able to stay there. Of course College would be very glad to retain me for more years . This I could not say, as at the present situation of our church I do not like to leave the church. Any how the matter is still open. According to the programme you are also expected to vigit Serampore on your way to Assam. The College is contacting different Missions for support. As we have planneding for you to vigit Assam but it will be necessary that you have to obtain permission to vigit Assam. Pastor Seeberg can tell something more about this. I would like to suggest that it will be good if you can first go direct to. Calchtta and aply for the permission and from Calcutta come to Ranchi. As per your advice we have agreed to conduct the Pasters Refresher Course from Nov. 5 (arrival) to 7,1978. We have discussed the matter with the Pramukh Adhyaksh and it has been agreed upon that the invitation would go to all the pastors, including that of the "NWA-GELC" ... But most probably they may not jamn us. As you have written to Rev. Ekka that you would like to have the Refresher Course with other paster also, even separately. Of course they will be glad, and they may interpret it for their recognition by you (and the Gossner Mission) of their separate Church, At this point I am unable to suggest any thing. As you have almost indicated that you would help them in future also even of separated. For us the matter is rather difficult for Court-Case purpose. If they will actually separate themselves from Gossner is,

we may not have any difficulty to corespond, sit and talk together, difficulty for us is that they are still crazy for GELC, they still attach themselves to GELC. They have prepared new constitution for themselves, but still now they do not dare to elect their officers on according to that new constitution, because they fear, with this action they may be totally out of GELC.

I hope when you will be here, you will get more clear picture.

During Nov.19-25,78 I have a programme in Madras, this may require
me from Nov. 16-28,78, and thus I may not be able to accompany you
in your tour. Do you prefer that I should accompany you or you can
manage with others also? I have a substitute also, who can go to
Madras in my place, if you think that I have to accompany you in the
tour programme. You may write either way after dicussing with pastor
Seeberg. According to the programme you are to stay omly for few
days, what is your openion do you like to astay in any hotel or in
Lai Bungalow? It will be good if would express your wish so that
arrangements could be made accompany.

We are really thankful for your vigit and many are expecting that you will be able to settle the problems of our church. Though I have told the friends here that your vigit has different purpose. Herewith I am sending our Half Yerly Report 1978 (Jan. - June) for your information and record. At this point I would like to add if the 3rd instalment of the Grant for Mission work has not yet been sent to our account, please instruct your office to do the same. SHORT REPORT OF MY VISIT TO GERMANY

(Rev. Er. C. E. Paul Singh).

As per schedule I was to attend the Euratorium meeting of Gossner Mission to be held on 27th/28th April '78 at Mainz. Accordingly I left Ranchi for Gormany on 25th April and reached there forenoon on 26th April, 78.

On the 27th afternoon India-Committee of GM was scheduled Basides the Missiendirector P. Kriebel and the Ref. Frau Friederici, Chairman Bishop Scharf(i.R.) LSP Peters, Dr. Grothaus, Sup. Wesner, Dr. Hunge, Dr. Mess, Dir. Fugmann and Herr Vegeli were present. Minutes and matters from previous meeting in Hanover were reminded of and thereefter Missiondirector P. Kriebel and Ir. Runge reported the later developments after the meeting in Manover. Later on I was asked to give report on the then contemporary situation in the GELC - specially in regard with the relationship between Gossner Church and Cossner Mission along with the churches in Germany. Discussions were based on and around my verbal report, written report(German) of Mr.J. Lakra, "agreed document", letters of Borutta, Promukh Adhyaksh Rev. S. Barla, Bishop Kruse, Minutes of KSS, etc. sent by the Pranukh Adhyaksh etc. There were long and thorough discussions for understanding the puzzling contradictory 'Direct Relationship' or 'Relationship through GM'. Due to contradictory situation in GMLC and letters the members of the India-Committee were at fir. After very long and thorough discussion it was arrived at and recommended to the Kuratorium that (1) the Director and Chairman, GM, be sent to visit the GELC in the next fall (2) a letter be sent to Rev. Borutta and also to GELC for further clarifications and exhertations.

On 28th April Kuratorium had its meeting under the Chairmanship of Bishop Scharf(i.B.) D.D. Many topics were discussed and decided in regard with Zambia, Nepal and In-country works and also accordingly personnel and financial arrangements were made. In regard with India/GELC there was again long and therough discussions on the recommendations and report of India-Committee. Finally the recommendations of India-committee were approved. Arms A very askward situation has arisen before the Kuratorium due to the "agreed document" on the one side and the minutes and letters from ESS/Pranukh Adhyakah on the other side.

In course of my stay in Germany, Mr.J. Lakra came to Berlin to have discussions with me, specially in regard with the "agreed document", his report, later development of the situation in the Church and the decision taken by G.M.

During our discussion I tried to explain my standpoint and that of OBLO/KSS in regard with the "agreed document" expressing my concern for the developing and poculiar situation in the Church due to the "agreed document" and the way it was prepared, the actions of individuals and groups to worsen the situation.

During my programmes in Germany I had chances to meet Christian groups on different occasions,i,e.family visit, missionfestivals, group functions, church services, official meetings, etc. I could experience time and again the love of our German friends for GELC. Two times I visited also East Berlin to participate in different functions representing India/GELC.

Besides these I happened to be in Berlin while two representatives(LWF/CBS) were on courtesy visit in GM effice. It was a good meeting for information and mutual understanding of works and situation in different countries on different levels.

When I look back my visit to Germany personally and collectively I feel my visit was useful and successful.

Subj.- Repairs, alterations and extension in the Southern Part of the Jubilee Bungalow, GELC, Ranchi.

Dear Sir, Most humbly I beg to state that due to certain old damages and new arbitrary damages to the properties and status of Jubilee Bungalow, there are immediate needs of repairs, alterations and extensions in the southern part of Jubilee Bungalow - I have nothing to say for the northern part, because Framukh Adhyaksh himself is the occupant of that part, Therefore I am requesting you for your kind favour to carry out the above mentioned items at your eraliest. I REPAIRS: The Kitchen (roof) as well as the concrete ceiling in the eastern wing of the said part have been very badly damaged, and if it is not repaired in due time, it will not only cause inconveniences to the occupants, but there is a danger of colapse also causing much loss of property and life. Therefore immediate actions for repairs is needed! II Alterations: This is very urgent in terms of hygenic and convenience sake. I due to shortage of water the toilet(latrine) and bath room are causing unbearable havoc. Cause? - From relaiable sources I have come to know - I don't know whether you and other authorites know or do not like to know the fact that wate connection from 'Ranchi Water Suply' connected to the Bungalow has been in two places branched off. This has been done unauthorisedly, ignoring the authorites and the concerned persons and is an act of sabotage and a theft case. Due to this arbitrary action water is not coming up to the Bungalow - nothing to say high up to thelatrine flush. Therefore arrangements have to be made accordinglywithout alterations of latrine system or without suply of water is a denial of my existenz. Here is a matter of my existenz!
May I at this point clarify the matter? Since I moved into this part of the Bungalow, I know, that this Bungalow has been treated very special by the RCP and accordingly necessary arrangements and repairs have been carried out including that of water suply. The rent has been also fixed accordingly which I m paying v very regularly. I remember that two wter pumps (maschines) have been fixed one after another in the well for suply of water and also that these maschines wer given for repair but were never returned. Meanwhile inspite of my objetions some water pipes of the connection from Ranchi Water Suply Sytem were taken out - till for unknown reasons and pupose! Later on from this main connection a bran connection was taken out by Miss S. Hemrom (&others ?) This was that tame objected by the RCP and thereafter plan and estimate were made to complete this main connection to the Bungalow. But the passed plan and estimate were suddenly dropp I took up the matter in my hand - partly because I was personally interested and party because that time I was the Actin Framukh Adhyaksh - and the pipes were complete with my own cost , totaling the amount of Rs. 3657.25 only. Later on I wrote a letter to RCP about this and requested either to refund the amount or adjust it to my house rent, till now nothing has been done. Now 3500 it has ec to my knowledge that Miss. Hemrom has again branched a pipe connection from this main line arbitrarily. About two weeks ago Mr.S. Bhengra , the Hd Accountant has also taken out another pipe connection from this main line without consulting the gouthorities or the affected persons as if they do not exist. This is not only unchristian but totally a foelishness ignoring the existence of others.

The items I & II as mentioned above be done very corn preferabl within the comweek, before it be too late to mend the things and the situation. If the works : ere not started in the coming week, I be kindly permitted to do the needful and later on I should not be blamed for unauthorised and arbitrary actions. This may alse the case with item IIII.

This lotter be kindly considered first and foremost as my request, then as my test only thereafter as my demand and ultimatum.

Dear Brother P.Kriebel,

Herewith I would like to inform you that I reached here without much problems. I had some difficulties at Delhi, due to customs formalities - but not personally involved.

As there was more than 1½ hrs time to catch my plane on the same day for Ranchi the AIR INDIA representative argued that I shall not have Nighthalt facilities on AIR INDIA cost. They walso said that they had no information from Berlin, so I had to arrange by myself. I stayed in YMCA International Guest House.

When I arrived at Delhi the climate has already become cooler, because it already started raining. In Ranchi also it is almost raining every day since I arrived here.

I have already given my oral report to the Pramukh Adhyaksh about my visit and talk in Germany. I hope he will write very soon as reply to your letter.

The training of a nurse for services in Nepla under UMN is almost failed. The UMN wrote to me that her husband can not be appointed in Nepla Nepal with his present qualification. As such wife (Nurse) also cannot be taken to UMN service. To this effect I also wrote a letter to Frau Friederici, Mainz. Only if she (Nurse) agreed to work in xxxx our Church in any of the dispensaries she can be deputed for training with the help of Gossner Mission.

Dear Frau Friederici,

It is to inform you that I arrived here without much difficulty. I had some troubles in Delhi, due to delay in customs clearance, though not personally.

It was very pleasant for me to be back in my country, that is in a very milder climate. In Delhi was much rain, so that temperature has come down to 240. In Ranchi also it rains daily and the temperature has become very pleasant.

Meanwhile two letters have come to my office are from Delhi Nursing Training Centre informing me that our candidate can be admitted for the Public Health Nursing and the expense is ca.Rs. 300 .- the initial expenses are extra - may come to Rs 1000 .- we have to reply very soon, whether we would send our candidate for training or we would drop the matter.

Another letter I received is from UMN, in which they write that Nurse is well qualified and she can be taken but her husband is not up to the mark for appointment in Nepal. The UMN can only consider acceptance i.e. of any married worker provided husband and wife wire were equally suitable, were both offered as workers, and were able to be assigned to the same location. According to this letter it seems that the Nurse can not be send for training, because she would be able to go to Nepal. Your opinion to this matter will be highly appreciated. Because it is the Gossner Mission, who will pay her expenses. Please therefore advise me, whether to send her for higher training or not.
