



## OFFICE ORDER

With reference to representation of Rev Paulus Minz, his pay fixation case in the revised scale introduced w.e.f. 1.1.1983 has been reviewed. In para 4 of the Rules of Implementation of the Revised Scale it has been laid down that "All allowances wherever it is in force to any category of Church workers be immediately stopped except the allowances fixed in pay scale item No VIII (Gossner Theological College)".

It is noted that Rev P. Minz would have been getting Rs 375/- on 1.1.83 in the existing scale (Pay 270 + Special Pay Rs 30/- + Allowance Rs 75/-) but for the implementation of the new pay scale. As no one can be put to loss of emolument on implementation of new scale - as in Government and Semi-Government Institutions - it has been decided to protect the pay of Rev. P. Minz by grant of personal pay detailed below:-
