I.Item 14. The actual expenditure on working charges exceeded estimate I by Rs. 98, 12, -.

II. Estimate I and II make no provision for nails, cement, lime, metaland transport charge. The actual expenditure on these items amounting to Rs. 98/-/- are seen in estimate III items 15,16,18,19,21,22.

III. Sawing charges: When preparing estimate I and II we could not discover that most of the battas had got retten and had to be replaced. Thi explains item 20 of estimate III.

IV. The first estimate was prepared before the Hailstorm, did great damag to the tiles. This explains item 17, namly Rs. 120/-/-

V. Items 3-7 proved to be insufficiently provided for in estimate I and II. There was an additional expenditure on wood amounting to Rs.73/15/-.

We are really sorry that we could not foresee all the repairs necessary, so that we have now to place before the Board a new estimate exceeding estimate II by Rs.495/7/-

We wish to make it clear, that these Rs.495/7/- are not meant to purchase asbesto sheets for a ceiling. We ask the C.C., if phis ceiling cannot be provided at present, to make provision for it as well as for the floor in next year's budget. The present ceiling gives us no sufficient protection
