THE TECHNICAL SCHOOL, RANCHI.

Report of Inspector of Technical Schools, Bihar and Orissa
21st January 1935.

The school is working only approximately on the same system as the other Government schools. The principal difference is that nearly all entrants are either passed Middle English or having an equivalent knowledge of English. Where the vernacular is used it is Hindi which is not the native language of the bulk of the students. There are lectures on "Workshop Processes" which are not taught by means of lecture elsewhere. There does not seem to be any very definite course of instruction in this or any other subject. English is taught on the direct system in last two years of the five years course. This was the original plan, but I have found it necessary to give at least one hour a week from the beginning. The direct system is good, but I would suggest Basic English for the vocabulary and grammar. As in the Orissa School of Engineering, the whole of the teaching of accounts seems to be elementary double entry book keeping.

Similar criticisms might be made in other subjects, i.e. that the syllabuses are incomplete, and do not seem to have been fully laid down. To a certain extent this was natural, and right in the first few years of the course, but with the experience now obtained it should be possible to lay down a complete, and definite course of study covering the whole five years.

The workshop is excellent in all departments. It might be noted incidentally that there is no difficulty in getting as much carpentry work as is required to provide all the training required in that subject, at the same time avoiding competition with the bazar. The Superintendent is very sound on this point, namely that as soon as work of any kind begins to be done outside in local workshops, the local Government school should move on to something else, at first to work of a higher standard, and finally to altogether different work.

The Battery installed in 1926 is on its last legs. The ordinary life of a battery is about seven years. Any proposal to renew a few cells at a time should be sympathetically considered. The proposal to extend the brick on edge plinth to North of the Hostel is also reasonable.

I visited the Ranchi Technical School accompanied by Messrs Lall & Dhar on Tuesday, the 21st May 1935. It is difficult for me to say much about the theoretical training which is given to the students, but the class room and the equipment were satisfactory and the teachers appeared to be keen and intelligent. The workshop was clean and properly organised. The course of practical training and the work which I saw the students doing satisfied me that they will at the end of of the five years' course acquire sufficient technical knowledge and practical experience which will enable them to find employment as foreman, chargehand or journeyman and some of them may rise to higher and more remunerative position. The students struck me as healthy, clean and disciplined.

Reservation of a fixed percentage of seats for the
aboriginals of Chota Nagpur in the Ranchi Technical Schools.

With reference to your letter No. 9704, dated the 27th June 1935, I am directed to say that the Government of Bihar & Orissa (Ministry of Education) consider that in view of the decline in the number of aboriginal students in the Ranchi Technical School, a reservation of seats for this community is necessary. A reservation of 70 % of the seats in the Industrial Diploma class as recommended by the Managing Committee of the School appears, however, to be excessive. Government are therefore pleased to accept your recommendation that 60% of these seats in the school should be reserved for the aboriginals of Chota Nagpur.

With reference to the second and third paragraphs of your
letter No. 2473 of the 28th September, we give below a note
on the students of the Ranchi Technical School who have undergone
a course of practical training with the Steel Company:-

In accordance with an arrangement made with the Department
of Industries, Bihar and Orissa, the Steel Company in 1929
accepted the first batch of students from the Ranchi Technical
School for practical training in the works for a period of 2½
years. This batch was followed by two more batches in 1930
and 1931 respectively. The arrangement terminated in 1932 and
no more students were accepted.

The total number of students who were accepted for training
from the Ranchi Technical School, was twenty three. Of this,
twentyone successfully completed their course, and two were
discharged for continuous absence.

In regard to their progress in the Works, ten out of the
twentyone students who completed the course, were reported to
be above average standard and the rest average. This is very
creditable performance and one the School may well be proud of.
We have therefore no comments to offer in respect of the School
curriculum.

I am pleased to inform you that eleven of these students
have now been employed by the Steel Company as follows:-

RANCHI TECHNICAL SCHOOL.
Report of Inspector of Technical Schools, Bihar & Orissa,

January 1934.

The admission examination was in progress. Ninetyeight applicants were sitting as compared with 79 in 1933, and 69 in 1932. Of those admitted in 1931, four have left without completing the course; of those admitted in 1932, three; of those admitted in 1933 none. Twenty five are officially entitled to stipends on the scales agreed on in the meeting on 6th December 1930. Thirty are admitted annually and percentage attendance being generally about 75 % the forfeiture of missed days stipends has made it possible to provide all 30 with stipends without exceeding budget allotment. This procedure though perhaps not contemplated by Government. originally, has the approval of the Managing Committee.

Recommendation:- Other institutions working the Industrial Diploma Scheme should be advised to do likewise.

I saw the correspondence on proposal to utilise the accumulation of forfeited deposits in the construction of a gymnasium. As regards the suggestion that physical exercise is not required for students whose regular course includes much workshop practice, I can say from personal experience that this is a complete delusion. I began my own professional career with an apprenticeship of five years in a ship-building yard with much over-time. This kind of work makes a man enduring but not specially strong or well developed. I was brutally bullied for the first three year (16 to 19). I then took up Sandow's dumbbell exercise and in about 18 months was much stronger and well developed than men who had been 20 years in the workshop. Physical exercise is effective in increasing strength only if planned for that purpose. My experience is that twenty minutes daily to the limit of ones strength is much more effective than all day and every day on monotonous work.

Recommendation:- The proposal is reasonable and indicates a useful disposal of the money.

There is nothing else that requires comment.

The figures quoted above show that the Industrial Diploma Scheme is as successful here as elsewhere, though it is not yet attracting the Bhadrolog class. Probably that will come.

(i) Employment which involves the use of tools, and particularly employment which involves tending machines, habituates the employees to a stereotyped series of movements or actions and results, if uncorrected, in a one sided physical development and often in a stunted physique. When employees are boys or young men it is particularly desirable to correct this by healthy physical recreation. Organised games offer such recreation, but only in an intermittent and spasmodically violent form. A gymnasium can be used daily and for briefer periods of time.

(ii) The Industrial Fatigue Research Board, which was at work in England

England during and after the great War came to the conclusion, or rather confirmed what was already the belief of medical men, that industrial fatigue is not a condition of the muscles and is not commonly brought about in factory work by muscular effort alone. It is a condition of the nervous system, and though in part it proceeds from muscular exertion it proceeds in greater part from mental concentration on the task; and that where there is no feeling of anxiety or tenseness about the result which the muscular exertion will produce, the fatigue is very slight, unless the muscular effort has been abnormally great.

Monotony also was found to play a great part in the production of fatigue and a change from one kind of work to another which required no less muscular effort, was found to reduce fatigue.

These results, though based upon modern scientific tests, merely confirm the old adage that "All work and no play makes Jack a dull boy". It would appear also that, unless it is proposed to make games and gymnastics compulsory any occasional case of truly muscular fatigue would be met simply by the boy himself yielding to a natural disinclination and avoiding physical exercise on that day; while the majority of boys, whose fatigue is composed as reported by the I.F.R. Board, would be free to get the care-free exercise of different sets of muscles-in fact healthy Play*

This argument meets the objection that "a gymnasium can hardly be said to be suitable provision for recreation to boys who are using their muscles all day in the workshop and who might, therefore, prefer something more diverting than exercising their muscles on horizontal and parallel bars".

(iii) A gymnasium also provides means of healthy exercise in rainy weather, when nothing much else is practicable. There can also be added to it Badminton and various table games and pastimes likely to be a source of pleasure like table-tennis, etc.,

In continuation of my Memo No. 12383-84 dated the 5th December 1933, I have the honour to say that the question raised by the Managing Committee with a view to providing recreation facilities to the students of the Ranchi Technical School is under the consideration of Government. They consider, however, that a gymnasium can hardly be said to be suitable provision for recreation to boys who are using their muscles all day in the workshop and who might, therefore, prefer something more diverting than exercising their muscles on horizontal and parallel bars. The matter should, therefore, be placed again before the Managing Committee and their opinion obtained as to what would be most suitable form of recreation for the students of the Ranchi Technical School. If they consider that a gymnasium would be best for the students, would be glad to have their reasons for this opinion. In any case, the scheme advocated by the Managing Committee should be submitted with detailed proposals including plans and estimates for sanction.

Copy of letter No. 1863- D dated the 23rd November 1933 from Government of Bihar & Orissa (Ministry of Education) to the Director of Industries, Bihar & Orissa.

I am directed to refer to Mr. Gupta's letter No. 15506 dated the 23rd December 1932 in which he stated that under Rules 5 and 19 of the Rules and Prospectus for the Ranchi Technical School a part of the stipends awarded to students which is held in deposit in the Savings Bank is liable to forfeiture under certain conditions. He also reported that in course of the last audit of the accounts of the school it was detected that a large amount out of such deposits has become liable to forfeiture and that it was suggested by the Examiner of Local Accounts that the said amount should be forfeited and credited to General Revenues. The total amount which has so become liable to forfeiture in course of the last ten years is reported to be Rs . 1170-9-1. The Managing Committee of the school resolved that the above accumulated amount should be credited to the games fund of the school with a view to provide a gymnasium for the school, the approximate cost of which is estimated at Rs . 3000/- . The amount available from the students' deposits is quite insufficient to meet the charge. Further Mr. Gupta considered that a gymnasium was not very essential for technical students who get a fair amount of physical exercise in the performance of their work in the work-shop. He did not therefore support the resolution of the Managing committee but agreeing with the view expressed in the audit report recommended that the accumulated amount, liable to forfeiture, might be credited to General Revenues.

2. In reply I am to say that the Government of Bihar & Orissa (Ministry of Education) are pleased to accept the recommendation in view of the ruling given by the Examiner of Local Accounts. They are however separately considering the question raised by the Managing Committee with a view to provide recreation facilities and you will be separately addressed on this point in due course.

3. The forfeited amount (Rs. 1170-9-1) should be credited to the head " XXV Industries- Technical Education" in the civil budget estimates.

Copy of letter No. 6013/9/1/9 dated the 28th November 1933 from the Principal, Bihar College of Engineering to the Superintendent, Ranchi Technical School.

I have the honour to inform you that one Md. Nezamuddin, a student of our 2nd year Industrial Diploma Class, is compelled through family troubles to transfer his residence to Ranchi. If you are able to receive him in the corresponding class of your school, I will on hearing from you, transfer to you his accumulated half earnings and particulars of his record up to date.

Copy of Inspection Note. of Ranchi Technical
School.

I inspected the Ranchi Technical School this morning (18.10.33) and went around the classes, the workshops and the hostels with Mr. Briant, the Superintendent. I was much impressed by the businesslike manner in which the boys were at their work. The discipline and order which is maintained does credit to this institution.

The theoretical classes appear to be progressing satisfactorily and, as remarked by the Inspector of Technical Schools, the drawing and sketching is very good. The arrangement of the workshop has been well thought out and I was particularly pleased with the neat arrangement of stores, which should facilitate stock-taking very considerably and enable the store-keeper to lay his hands quickly on any particular article which may be required for use. The shelves have convenient ~~xxx~~ subdivisions, each of which has a number. As this number is also entered in the stock book it is possible to find any article without delay. The Superintendent is anxious to pave with brick the front of one of the hostels so as to secure greater cleanliness. If he will write to me officially I shall consider whether I can spare the amount required out of my minor works grant.

There are 135 students in the school including 5 Improvers and 9 in the leather class. All of them receive stipends varying from Rs. 5/- to 15/-. They are given a five years' course except in the Leather class which is for 2 years only. The amount spent on stipends is in the neighbourhood of Rs. 850/- per mensem. The monthly attendance appears to be satisfactory. Practical training is given in carpentry, furniture making, metal work, motor repair, vulcanizing, painting and polishing and leather work. I am glad to hear that the standard of workmanship is improving.

While there has undoubtedly been considerable progress, the receipts for work undertaken by the school have fallen rapidly in recent years as will appear from the following figures:-

The Superintendent has explained that several factors have contributed to this decline in receipts, Viz:-

(i) The fact that formerly stores were sold by the school to the public, which are now obtained from the bazar which had developed to a great extent in recent years;

(ii) easier and more profitable work is now done in the bazar which has absorbed some of the passed students;

(iii) the fact that work is taken up more with an eye to the training of the students than to profit, and

(iv) The revised curriculum and the introduction of the Industrial Diploma classes.

While I fully appreciate the reasons for the fall in income and the fact that in institution like this must look more to the training of its students than to profit, I consider that the downward trend should be carefully watched. In these days of acute financial stringency it is impossible to expect Government to give more money for the expansion and development of the school if the cost per student shows an increase. I examined some of the costs sheets which appear to be carefully prepared under the supervision of the Superintendent. The cost of materials presents no difficulty but the cost of labour must inevitably be somewhat of a guess-work. The estimating is done by the Superintendent and I understand that as far as practicable all relevant factors are taken into account. It is important that the institute should not undertake work at too cheap a rate as this would interfere with private enterprise which, in my opinion, is undesirable.

It is a source of great satisfaction to me to find that this institution is building up a reputation for its work and the successful training which it has been able to give to its students. The Superintendent and his staff deserve credit and I hope this record of improvement will be maintained.

Minutes of a meeting

1. Mr. Brady having been asked to take the chair, read the resolution of the Ranchi Technical School Committee appointing the Sub-Committee, and the resolution concerning the proposed training in accounts. Mr. Brady said he personally had not assented to the decision of the Committee against the teaching of accounts in English. The Diploma holder could scarcely call himself an Industrial Engineer unless he had some knowledge of accounts, and in English. Doubtless not every boy could master this subject, but it was not intended, as he saw the scheme, for every boy to get the Diploma. The essence of it was that only the cream of the boys would win through to the Diploma. If the competitive characteristic of the scheme were relaxed, either in this particular matter of accounts or in engineering technology, the Diploma would not have the value which they all hoped it would have.

2. After reading the previous correspondence between the Director of Industries, the Inspector of Technical Schools and the Superintendent of the School, and discussing the question at some length, we record the following criticisms of the syllabus:-

(a) We think it probable that very few Middle English boys will be able to go through the whole course, and therefore our hope of producing a good number of Diploma men depends on a revival of the recruitment of matriculates, which has dropped off since the mechanical apprentice classes were abolished.

(b) With regard to the preliminary examination, we agree to the rule that a second attempt should not be allowed at this examination considered as the preliminary examination in the Diploma Course. A candidate who fails to pass it should be considered to have forfeited his claim to higher theoretical instruction, the inference that he would not profit by it being very strong. But regarded as the one and only examination for the Charge Hand Certificate, the case is somewhat different. The examination is in our opinion rather advanced for our artisan type of boy. Considering this, and considering that these

examination, it seems to us advisable to let the failures try again at the end of the five years. If this is not done, a boy who has failed at the Charge Hand's Examination in his third year can say with considerable force that he is being classified as a workman as the result of an event long past and that with his further experience he could retrieve if given the chance. We recommend therefore that a second chance may be given in the fifth year at the discretion of the committee.

3. We recognise the great value of having as much uniformity as possible between the syllabuses of the several schools, and the importance of settling the syllabuses promptly. We therefore do not press for any modification which the Director may find embarrassing, and would be satisfied to start on his lines and let any defects be revealed by experience.

4. Mr. Brady suggested that in proportion as this new scheme of training became successful, so would it be of increasing importance to ensure uniformity, and that to this end he thought it would be useful if the Director would approach the Institution of Engineers (India) to ascertain on what basis they could co-operate with schools to give these Diplomas a value that would be more than local. It was unanimously agreed that the cooperation of some body whose influence is more than local would confer great additional value on this Diploma, and that the Institution of Engineers would be the most suitable body for this purpose.

Administration. I was in charge of the school throughout the year. Due to the reconstitution of the Managing Committee, only two meetings were held during the year under report and several matters of immediate and ultimate benefit to the welfare of the school were discussed and disposed of. As in the previous year, the Managing Committee also appointed a Sub-Committee to interview and select candidates for admission to the school in January 1932.

2. Staff. Details are furnished in the Annual Returns, which are attached. There has been no change.

3. Admission. During the year under report 45 students were admitted as against 50 in the previous year. The admissions were distributed among the following classes and for comparative purposes, the admission for the last report year are also entered:-

6. Athletic. The encouragement of sport and the spirit of healthy competition and rivalry which the students display in this form of activity continue with commendable results. 7. Health of students. The health of the students has on whole remained very good despite the regrettable loss of one Mohamadan student who died at Patna.

8. Equipment and Buildings. There have been no noteworthy addition to these during the year under report. Some improvements were done to the part of the workshop yard by tarring and pitch macadamising while due to financial stringency, no new projects could be entertained.

Subject:- Periodical audit of the accounts of institutions under the control of the Industries, Department.

I have the honour to say that the audit of accounts by the Local Audit Department under the Accountant-General is done generally on a percentage basis only once in three years with a view to avoid risk of possible loss to Government through inadequate check and supervision of the accounts, it has been suggested by the Public Accounts Committee that the audit of the accounts of the institutions under the control of the department of Industries should be carried out quarterly by one or two members of the staff of the institution concerned who may also be members of the Managing Committee and that the audited accounts should be finally approved by the Managing Committee of the institution. Will you please let me know if there is any objection to the above proposal? It is reported that this practice is in vogue in some of the colleges under the Education Department.
