Sir,

It has been reported to me that the newly constituted Lohardaga Illaka Sabha (Local district church Committees) of the G.E.L. Church has dissolve the Managing Committees of the above mentioned schools on the plea that recently adopted New Constitution of the said church requires such action. The said church body has, it is reported, even formed new Managing Committees for those schools and they have begun to function.

In this connection I have to state that the adoption of the New Constitution of the Church does not necessitate dissolution of Managing Committees of schools. Managing Committees/ can be reconstituted or reshuffled and that also as per rules laid down.

There is no rule to dissolve any Managing Committee, which consists of representatives of the Church, guardians, teachers and backward Communities.

The above named schools are under my supervisory control and the action taken by the local church Committee are without my consent and knowledge, and are unconstitutional.

The existing Managing Committees of these schools of which I am the Chairman and Rev. C.H. Tirkey is the Secretary will therefore continue to function. These Committees will also operate on the bank or Postal Accounts of the Schools as usual.

There seems to be some confusion regarding the Managing Committees of the above named Schools. These Schools are under my supervisory control and the existing Managing Committees with Rev. Recently the newly formed local church committees had tried to dissolve these committees but their action is completely unjustified. Neither the Church Constitution nor departmental rules would admit any such action. It is therefore requested that the official relationship as before should continue in the interest of these institutions.
