Dear Rev. Jojo,

We are in receipt of a letter of Mr. S. Bengra, No. 227/80/KSS-56 B dated 6.5.1980, along with statement of accounts of all the money received by you/for KNH for the Homes affiliated to us. Detailed *Li 1979* comments on this will be sent to you on scrutiny by our Accounts Officer. However in the meantime I would like to raise one question regarding money held by you for Home 1830 - Kinkel.

Your statement says that you paid Home 1830 Rs. 20,868.93 and for construction work Rs. 4,523.00.

I do not understand on what grounds and with whose permission the amount of Rs. 4,523.00 was used for construction work at Kinkel. We have not given any permission, nor have we sent any money to you for this Home's construction work. On the other hand, the money of Fostership grant is not to be utilised for construction work.

Secondly, the statement says that the balance with you is Rs. 5698.62 which added to the amount spent on construction Rs. 4523.00 gives us a total of Rs. 10,221.62.

According to our records you should have - - - Rs. 9979.20 Fostership grant
Christmas gift for 1979 - - - - - Rs. 951.65
Rs. 10930.85

whilst you show only - - - - - Rs. 10221.62
Rs. 709.23

which means Rs. 709.23 less than what it should be. I request you to kindly explain this discrepancy.

In our letter to you EG/rj dated June 21, 1979 we had instructed you to return the whole amount of 2nd quarter fostership grant to our Bangalore Office IMMEDIATELY. This has not been done upto date. Besides, you have used some of the amount of fostership grant for other purpose without permission.

I wish to inform you that since you failed to refund the money upto date all the amount of 2nd quarter 1979 Fostership Grant and Christmas Gift (which, however, should had been given to the Home in December) that is Rs. 9979.20 + 948.65 = Rs. 10927.85, will be deducted from the total of Fostership Grant to be sent to G. E. L. C. Homes next time. Whatever adjustments are to be made, we shall make them ourselves.




