Minutes of the meeting held on 25.9.95 of Board of Properties, G.E.L. Church in KSS premises.

The meeting was started by saying short prayer by Rev. J. Topno, Secretary, Board of Properties.

The following members were present :-

Following matters have been discussed :-

Previous Minutes dated 27.7.95.

Item 7 G.E.L. Church Press.

It was intimated to the members that Sri R K. Surin, Lessee, G.E.L. Church Press has agreed to pay Rs. 20,000/- P.M. from the income of Printwrite Block. Written agreement be executed with him at the earliest.

Item 9 Req. Tank (Khajuria Talab).

Decided that Sri U. Toppo, Advocate may be asked to surrender the agreement of Khajuria Talab to The Principal Gossner College and information may be given to the Board of Properties.

Item 11 Road Repair work.

Two persons namely (1) Shri Jaywant Kachhap and (2) Sri Haniel Toppo are objecting demolition of encroached compound wall as such difficulties arose for making straight 'Nala'.

Decided that the Manager, Board of Property will again request them to demolish the encroached compound wall. If necessary, to demolish the encroached was, Police help can be taken for all encroached land. The electric pole also be shifted and expence also be made.

Item 16 Orissa Anchal - Regarding sale proceeds of land (Jharsaguda).

The manager will again write to send the details of the sale land of Jharsaguda.

Item 19 Construction of new shed - KSS premises.

Decided that the Contractor of BEL may be approached for construction of the shed without further delay.

NEW ITEMS.

Item 1 Land occupied by Shri Acharya, GEL Church Comp.

Decided that the Agreement Paper may be made with Acharya and following may be realised from it.

- i) Arrear rent of Rs. 1,000/- may be taken upto 1994.
- ii) After measurement of occupied land, rent may be taken at the rate of Rs. 00.10 (Ten paise) per Sq.Ft. per month and Municipal Tax will be paid through the Church by Shri Acharya. Rent will be taken from January 1995.

- iii) Donation of Rs. 1,000/- may be taken .

Sri Niral Hemrom should be replied that his application is regretted and he should be directed to make a rental agreement for the premises occupied by him.

Item 2 Re-newal of lease deed to S/Shri Devi Chandra Sahu, Jogendra Singh and Md. Ashlam.

Decided that the lease deed which was given to the above party expiring on 3rd December 1995 may be Re-newed, allotting their old shop in same place and plot, where they exists.

Item 3 Qrs. for Teacher's, Gossner High School and others.

Decided that along 9 Teachers, following persons may also be allotted land in the same plot :-

The land may be allotted as such that all can be accommodated there.

Item 5 Application of Asha Sewa Niketan, P.O. Rajgangpur in Orissa Anchal.

Decided that the application should be submitted with recommendation of Anchal Samittee, Orissa Anchal as well Adhyaksh, Orissa Anchal.

Item 6 Allotment of land for shop purposes.

- i) Application dated 9.10.94 of Shri Ram Khelawan Ram.

Decided that the Manager, Property Board should enquire about the land occupied by Late Phillip Tigga (Mrs. Premi Tigga) and appropriate action may be taken. Board agreed on principal to allot land on the same premises.

Decided that half portion of the Bethesda play ground may be allotted to Head Quarter Congregation for Grave Yard purpose.

Item 12 It was observed by the members that the plot of land on Club Road measuring much more than actually decided was allotted with registered lease deed to Dr. Mrs. Jiren Mundu. The officers could not give clarification to the P.B. members.

Item 13 Application received from Madhya Anchal forwarded to the KSS for necessary discussion.

As there were no other matter for discussion, the meeting was closed with Prayer.

5. The Central Council will normally meet once a year.
6. The Dy. Moderator shall be elected from among the Bishop by the Central Council as per election rules provided in the Constitution.

3. GENERAL SECRETARY

The Central Council shall appoint a full-time General Secretary and other departmental secretaries if necessary under the terms of service to be framed by the Central Council.

A full-time paid General Secretary preferably a lay person appointed by the Central Council for a period of six years at a time, will serve as the Secretary of Central Council. He/She shall prepare the agenda for Central Council meetings in consultation with the Moderator and call the meeting of Central Council with two month's notice.

The Central Council will normally meet once a year. The General Secretary will present a report of activities. The Central Council will hear from the Diocesan representatives information on their life and work.

General Secretary's function :- The following shall be the duties of the General Secretary

1. The General Secretary shall maintain a true and faithful record of the decisions taken by the Central Council and of the Office bearers meeting and shall keep its records and files.
2. He/She shall conduct correspondence of the Central Council with Diocesan Councils, standing committees, adhoc committees, Commissions, Central Boards, Central institutions and other organisations and notify bodies and persons concerned of its actions.
3. He/She shall forward to the appropriate Board commission, Or Committee of the Central Council any matters referred to him and which required urgent attention of that body.
4. He/She shall prepare minutes of the Central Council and send them to all members of the Council.
5. He/She shall in consultation with the Moderator send notice of meetings of the Central Council and of the office bearers' meeting to all concerned.

shall inform the Moderator. The Moderator, on receiving the information in writing, shall consider and deal with the objection, and if necessary, may put it before the Court of Arbitration of the Central Council.

- k) He shall together with two other bishops of the Church consecrate as bishops those persons who shall have been duly elected or appointed and whose election or appointment shall have been duly confirmed according to the constitution of the Church.
- l) Whenever a Bishop has been elected, the Secretary of the Electoral Body shall communicate the proceedings and results of the election to the Moderator for necessary further action.
- m) He shall be the official representative of the Church during his terms of office in all relations and matters affecting other Churches or organisations in and outside India. However, he will depute and authorise the person appointed by the Central Council to represent acumenical, national or international meetings.

B. Deputy Moderator :-

- 1. The Deputy Moderator shall preside at meetings of the Central Council or of Central office bearer's meetings and perform other duties of the Moderator during the absence, illness or other incapability of the latter.
- 2. He shall perform such other duties as may be assigned to him by the Moderator under this constitution.
- 3. In case both the Moderator and the Deputy Moderator are unable to preside at the meeting of the Central Council, the body concerned shall elect a president pro tem from amongst the diocesan bishops present.
- 4. The period of membership for the members elected from the Dioceses and the Head Quarter Congregation Ranchi for the Central Council and that of Moderator and Dy. Moderator shall be for five years at a time.

- i. Whenever a bishopric of the Church falls vacant either due to emergency or otherwise, the care and charge thereof shall devolve upon the moderator. He shall appoint a senior and experienced pastor below the age of retirement, from within that diocese, to act as his commissary, to carry on the day-to-day administration of that Diocese on his behalf and under his direction. The Moderator may revoke such an appointment if deemed necessary and may make a new appointment. The commission shall be in the prescribed form as approved by the Central Council.
- ii) The appointment of the moderator's commissary shall terminate when the new bishop of the Diocese is installed, or when the commission is revoked by the Moderator earlier. The moderator shall inform the Diocesan Council concerned regarding such appointments and their terminations.
- iii) In the case of urgency when a Bishop, Vice President of the Moderator's diocese is absent from his Diocese without having appointed a commissary, or being in the Diocese is, for any reason unable to act, the Moderator may, on application from the other office bearers of the Diocesan Council, appoint a commissary as provided in the bye-law.
- iv) In the absence of the Bishop, Vice President of the Moderator's diocese, should any emergency arise for which the commission given to the commissary does not provide authority to act, the Moderator may on application from the commissary empower him to deal with the matter.
- v) In the event of a commissary being nominated as a candidate for the episcopal election for the Diocese in which he is Moderator's commissary, the Moderator shall terminate that appointment and appoint a new commissary in his place.
- j. When any objection against the election of appointment of a bishop is raised the objector shall submit the same in writing to the General secretary of the Central Council, who in turn

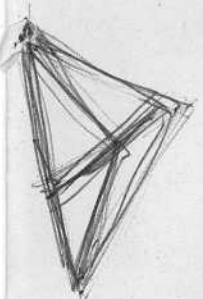
