

3. The third category covers associations having a definite cultural, academic, religious or social programmes. They are required to give within the prescribed time intimation to the Central Government about the amount of foreign contribution received by them, source from which and manner in which such foreign contribution was received and the purpose for which and the manner in which such contribution was utilised by them.

We believe that all our partner organisations belong to the third category described above. This means that you will have to find out from the authorities which is the prescribed time within which you should intimate the Central Government and have all the required information ready for submission.

In case some of you regard yourselves as belonging to category two, i.e. having association with political parties, we ask you to follow the regulation and seek permission to receive further funds.

In order for you to give detailed information about "Bread for the World" to the authorities concerned we give you below a brief description of our principles and aims:

"Bread for the World" is a campaign of all Protestant Churches in Germany receiving its funds through church collections and free will offerings from people all over Germany. Its partners are churches, voluntary agencies, development agencies in all developing countries. Through these partners "Bread for the World" supports projects in the following categories: Social and economic institutions, vocational training, cooperatives, health, education, personnel, study projects and emergency relief. Priority is given to projects with a strong component of peoples participation and target groups belonging to the poorest strata of society regardless of their religion.

For your own interest and for the sake of the projects you are undertaking we ask you to get a copy of the Regulation Bill and to acquaint yourself with it in all detail. It will be necessary for you to have audited statements of accounts available covering the past few years and showing the funds received, from which sources, and for what projects.

We feel confident that if you take the responsibility seriously which this Foreign Contribution Bill places on you our continued good co-operation will not be jeopardized.

## RESTRICTIONS ON FOREIGN CONTRIBUTIONS.

NEW DELHI AUGUST-5:-

The Act which regulates foreign contributions and hospitality certain categories are totally barred from receiving them-came into effect to day. A gazette notification framing rules under the Act has been published.

The Act envisages three kinds of restrictions of a prohibitory or regulatory nature. The first bans acceptance of foreign contributions or hospitality, the second requires prior permission of the Centre, and the third makes it obligatory to render accounts to the Government after receipt of contributions.

Recipients of foreign contributions have been grouped into three categories. The first includes organisations and individuals of a sensitive and important category in our national life (like officials, legislators, journalists and politicians). They are "totally prohibited from receiving contributions".

The second covers organizations "deemed to be of a political nature", which "shall not accept any foreign contribution except with the prior permission of the Central Government".

The third includes cultural, academic, religious or social associations, which are required to inform the Centre of the amount of foreign contributions received by them, its sources and the use is put to within a stipulated period.

The Act defines foreign contributions to mean "the donation, delivery or transfer made by any foreign source of (1) any article given to a person as a gift for his personal use, if the market value in India of such article on the date of such gift does not exceed Rs. 1000/- (2) of any currency whether Indian or foreign (3) of any foreign security as defined in the Foreign Exchange Regulation Act".

The Act defines the foreign hospitality to mean "any offer, not being a purely casual one, made by a foreign source for providing a person with a cost of travel to any foreign country or territory or with free board, lodging, transport or medical treatment."

The following is the text of a press note issued by the Home Ministry.

The Foreign Contribution (Regulation) Act 1976, has come into force with effect from August 5, 1976. A notification to this effect was ~~framed~~ along with the rules framed under the Act has been published in the Gazette of India Extraordinary. The Act, as passed by Parliament on March 29, 1976 was assented to by the President on March 31, 1976.

The Foreign Contribution (Regulation) Act was passed for ensuring that our parliamentary institutions, academic and other voluntary organisations as well as individuals working in important areas of national life function in a manner consistent with a value of a sovereign democratic republic. The Government was aware of the scope for foreign agencies to influence organizations or individuals in the country through financial aid. It also had kept in view the need to regulate the acceptance and utilization of foreign contribution or hospitality.

The Act envisages three kinds of restrictions of a prohibitory or regulatory nature.

The rules also provide that in the case of persons receiving scholarship stipend or any payment of the nature residing outside India the intimation shall be given within 60 days from the date of receipt of such scholarship stipend or other payment of like nature.

In respect of foreign hospitality, on the acceptance of which prior permission of the Central Government is necessary under the Act the intimation has to be given within 30 days from the day of receipt of such hospitality specifying the particulars as to the receipt of such hospitality and the source from which and the manner in which such hospitality was received.

The rules also provide that the case of any citizen of India receiving scholarship, stipend or any payment of like nature from any foreign source which does not exceed Rs.3,600/- during an academic year It shall not be necessary for him to give any intimation.

In calculating this amount, the assistance he had received for the purchase of books, clothing and equipment and for sightseeing in a foreign country should be taken into account. But the amount spent on travel by air in an economy class from India to a foreign country ~~shall not be taken into account~~ and back to India from such a foreign country shall not be taken into account.




We are at the distance of 7 miles from Ranchi. This can be very verified very easily if you advise the church — authorities of Ranchi.



Dear Brother Singh,

I am approaching you in your authority as director of the Board of Evangelism and Literature. Since long the GEL Church and Gossner Mission agreed to envisage a co-operation with the United Mission to Nepal. May I remind you that Gossner Mission officially became member of the United Mission to Nepal in 1969 and accordingly sent since then two missionaries to work with the United Mission to Nepal. The plan to send Indian missionaries to Nepal too was not yet cancelled but could not be realized due to certain difficulties in the GEL Church but several leaders of the GEL Church became acquainted with the work of the United Mission to Nepal during the last years. Now Gossner Mission wants to encourage the GEL Church once more to begin the practical co-operation.

The first step is a formal application to the GEL Church - either by the Acting Pramukh Adhyaksh or the Director of the Board of Evangelism and Literature - addressed to the Executive Committee of the United Mission in Kathmandu to become member of the United Mission to Nepal. As all parties within the GEL Church will agree to this it could be possible to submit this application already to the next meeting of the Board of Directors of the United Mission taking place in early April this year.

The second step, of course, would be to send missionaries from the GEL Church to Nepal. This has to be prepared and the preparation may need more time.

Gossner Mission ensures the GEL Church to give all financial assistance for the time being in case the GEL Church becomes official member of the United Mission to Nepal and sends own missionaries to Nepal,





Dear Brother Pastor Seeberg,

As promised I would like to inform you about the latest development in the Church. The KSS Samiti had its meeting on Aug. 27+28, 75 to decide finally to implement the new constitution after taking advices from a Retired Christian Judge in Madras, who is also the treasurer of UELCI/FELCI. But the Judge did not come. So we had to take advice and have dicussions with local christian and senior advocates, and decided that due to legal difficulties the implementations of the new constitution is kept pending and elections are to be held according to the existing constitution, thus I have to continue till the new elected Pramukh Adhyaksh takes over charge on the 4th Nov. 75.

At present there are many tensions within ourselves due to many important issues i.e. college building, opening of science classes in theological college, finance etc.

Meanwhile we received the receipt of money transaction from Hamburg refering to your letter to me dt. 19th Aug. 75, But I have not yet received the letter, therefore please send me the copy of the same, so that we can adjust the amount according to your advice.

Last but not least, I would have mentioned earlier, the KSS Samiti notes its deep sorrow upon the premature and sudden death of you daughter and the KSS Samiti on behalf of the Church sends its heartfelt condolence.

From August 75 Rev. C. S. Royan Topno from Theological College has been deputed as assistant in BEL office. He has to learn much about the mode and work of the BEL.

Lieber Bruder Singh!

Als ich am 5.d.M. Ihren inhaltsschweren Brief erhielt, habe ich Ihrer herzlich gedacht und schrieb daraufhin die Briefe an die Anchal Adhyakshas sowie an den Lutherischen Weltbund unter dem 6.d.M. Ausserdem wollte ich einige Tage überlegen, welche Massnahmen wir in Berlin treffen sollen.

Inzwischen habe ich den Brief von Dr. Hellberg vom 7.d.M. an Sie zur Kenntnisnahme erhalten. Hellberg kommt also nicht nach Ranchi und sieht für seine Person also keine Möglichkeit, in den Streit in Ranchi einzutreten. Ob damit der Lutherische Weltbund insgesamt alle Massnahmen ablehnt, wird sich entscheiden, wenn Dr. Rajaratnam Kenntnis von der Angelegenheit erhält und von Madras entweder nach Ranchi kommt oder direkt nach Genf zurückkehrt. Jedenfalls werden Sie, so wie die Dinge im Augenblick liegen, keine besondere Hilfe vom Lutherischen Weltbund erwarten können.

Diese Tatsache erleichtert unsere Situation in Berlin ganz und gar nicht. Im Augenblick sind wir der einzige europäische Partner, der versucht, Ihre Sorgen und Probleme zu bewältigen. Ich hoffe aber, dass die von Ihnen ebenfalls angeschriebene Vereinigte Lutherische Kirche Indiens jemand schicken wird. Diese Brüder haben ja den kürzesten Weg.

Die Mitglieder des Kuratoriums der Gossner Mission haben sich bisher noch nicht geäußert, aber ich erwarte im Laufe dieser Woche ihre Ratschläge. Meine persönliche Meinung, die ich mit meinen Mitarbeitern in Berlin diskutiert habe, sieht im Augenblick wie folgt aus:

Ich bin mir der Verantwortung bewusst und weiss, dass die Zukunft der Gossnerkirche auch durch die Gossner Mission beeinflusst wird. So wie in früheren Jahren wird es auch heute und morgen so sein, dass wir in Berlin durch unsere Korrespondenz und durch unsere finanziellen Beiträge positiv oder negativ wirken. Ich habe Ihnen wiederholt gesagt, dass nach meiner Überzeugung grössere Geldzuwendungen mehr schaden als Nutzen bringen. Diese These ist bei Katastrophenfällen sicher nicht anwendbar. Ist eine solche Katastrophe jetzt eingetreten und soll die Gossner Mission jetzt für die Zentralverwaltung der Kirche Mittel aufbringen? Wir haben dies 1974 und 1975 zu einem gewissen Teil getan, weil die Interimszeit überbrückt werden musste. Wenn es jetzt so aussieht, als würde diese Interimszeit auf unbestimmte Zeit weitergehen, dann habe ich grosse Zweifel, ob wir uns an der Finanzierung der Zentrale beteiligen sollen. Ist es möglich, dass sich die Brüder im KSS nicht geeinigt haben, weil irgendwie die berechtigte Hoffnung bestand, dass schlimmstenfalls die Gossner Mission einspringen und die nötigen Beiträge schicken würde?

Aber vergessen wir einmal das Geld. - Sie haben geschrieben, dass ich Ende November für eine Woche kommen soll. Eine solche Reise nach Indien kostet natürlich auch einiges Geld, das vielleicht an anderer Stelle bessere Verwendung finden könnte. Ausserdem lässt auch meine Terminplanung nicht ohne weiteres zu, eine solche Reise kurzfristig anzutreten. Aber auch hier würde ich sagen, dass in Katastrophenfällen alles möglich gemacht wird. Doch was könnte ich in acht kurzen Tagen in Ranchi tun? Möglicherweise würde es mir gelingen, die Parteien an einen Tisch zu bringen und ein paar kleinere Probleme zu lösen, aber viel mehr ist in so kurzer Zeit wohl kaum zu erreichen, besonders wenn man allein ist. Darüber hinaus habe ich in diesem Zusammenhang noch eine wesentliche Frage: Der Hilferuf an LWF und Gossner Mission ist vom Rest-KSS, der am 30. Oktober zusammenkam, beschlossen worden. Wie aber ist die Meinung der Brüder, die nicht an dieser Sitzung teilgenommen haben? Sehen diese ebenfalls die Notwendigkeit, dass ein guter Freund von aussen die Probleme lösen sollte?

Sie sehen also, dass ich die Frage, ob ich zu Ihnen kommen soll oder nicht, ebenfalls unter dem Gesichtspunkt betrachte, ob ein solcher Besuch mehr schaden als nutzen könnte. Ich lehne den Ruf zu kommen, nicht grundsätzlich ab wie es Dr. Hellberg getan hat, aber bevor ich mich dazu entschliessen kann müsste ich mehr Gewissheit erhalten, dass dieser Besuch von allen gewünscht wird und dass Aussicht besteht, einen Heilungsprozess in Gang zu setzen. Anders ausgedrückt: Die Verantwortlichen der Gossnerkirche müssten deutliche Zeichen geben, dass sie ernsthaft die Befriedung wünschen und sich gegebenenfalls auch einem Schiedsspruch beugen würden. Ich könnte im Falle meines Kommens nicht nur Diskussionsleiter sein, denn es geht jetzt darum, verbindliche Entscheidungen zu fällen, die akzeptiert werden müssen, was im voraus und öffentlich gesagt werden müsste.

Soviel für heute, lieber Bruder Singh. Ich weiss, dass Sie persönlich eine zu grosse Last tragen und dass Sie durch Ihre Krankheit geschwächt sind. Ihretwegen würde ich viel schneller nach Ranchi kommen, aber es geht jetzt um mehr, denn wie schon gesagt, ich frage, kann mein Besuch mehr schaden als nutzen? Ich wäre Ihnen dankbar, wenn Sie sogleich nach Erhalt dieses Briefe antworten würden, damit ich über die Entwicklung der letzten Tage informiert bin und Antworten auf meine Fragen bekomme. Sobald das Kuratorium sich zu der Angelegenheit geäussert hat, werde ich mich wieder melden, also schon vor Eingang Ihrer Antwort.

Dear Brother,

It is with deep sorrow and concern that I learn about the continued struggle in the Gossner Church. Your letter of November 1, following your cable, was no surprise to me. When Dr. Minz was in Geneva in October, Dr. Rajaratnam and I had long conversations about the problems in your church.

My views are:

1. The roots of the problems of the Gossner Church are of such a deep, partly personal and partly sociological, nature, that unless they are clearly identified and analysed, any efforts by "outsiders" to serve as reconciliators, who can observe the surface only of your problems, are doomed to failure. This was my experience last time I visited you as a reconciliator - an effort that apparently failed. It was only in the second part of that meeting, that I started to be aware of the deep, personal conflicts involved, as well as some of their connections with sociological factors. Whatever positive results that came out of this my previous visit to Ranchi, was just a scratching of the surface - and in a short time the conflict started all over again. The same would happen again unless all concerned now are ready to come to grips with all the roots of the problems.

2. This also involves a reconsideration of the entire structure of your church. Both the previous and the present constitution appear to presuppose a unified church, consisting of people of many different backgrounds. Is there in your church, so diversified in sociological backgrounds, a real wish to maintain the unity? Are the frustrated minority groups having difficulties in expressing within the present structure their own identity within majority groups? Are the majority groups ready to accept that their



opinions must not necessarily be imposed on others, are they prepared to listen and to understand numerically weaker partners in the church? Have you seriously considered as an alternative a federal structure of the church with greater autonomy to each side?

3. Are all those now being on the KSS really representative of the members of the congregations? If so, are they willing to meet in a spirit of reconciliation and without putting group - or personal prestige in the first place? This "spirit of reconciliation" was not very prevailing during my last visit to Ranchi - there were so many personal interests, so much suspicion between the groups, that the now prevailing regrettable result could be foreseen.

I can see no use in my coming to Ranchi unless these and other questions are first dealt with by all the responsible, duly elected leaders of the Gossner Church. Dr. Rajaratnam is informed of your request and will no doubt contact you from Madras, where he is at present. He will then inform me of his evaluation of your situation on his return to Geneva.







Thank you for your kind letters dated June 19, 1975. I am really overwhelmed to find so many enclosures. At present I shall not answer all the points in your letters, this is possible only after the KSS has taken some decisions, we have to wait.

Regarding Mr. H. Here, it will be better to wait for some times, it may depend for which place and for what post ?

Thank you for your opinion regarding the Acting Pramukh Adhyaksh for his setting the matter on account of the handicaps, I think I can find out the way in the given situation, you need not push the matter.

As the Andaman Island-Christians are under the jurisdiction of SE Anchal the KSS could only advice the Anchal. The Paster Rev. Topno is since January 1975 here at Ranchi till these days. He has many ideas for the area, and the work but it seems to me too ambitious, he has also submitted a budget for developing work etc. of an amount of Ca. Rs. 4,00000/-. The SE Anchal has also not yet satisfied itself with the work of the Paster. How can he work in the islands if he remains away from the area for half a year? Just yesterday he came back from Calcutta, saying that he could not get a ticket for the ship. The works for the islands are immense, but they have to be planned and accordingly organised.

The other day I wrote a letter to Drs. Here about the contract and for the future of the hospitals and dispensaries. I have requested him to come to Ranchi for July 11th '75 during which we shall have to discuss the said matters.

Preparations for the 10th July are going on so that the new constitution may be adopted for implementation. Some of the Anchals have already sent their opinions and comments, and they are very much conditional and almost negative. Any how we have to discuss all these matters and see how it works. The rest points shall be discussed, decided and communicated to you.

Thanks for your letter which I received to-day. Good to know that you arrived safe and sound and that the docotor in Barnabas Hospital is taking care for you. It is understandable that the KSS Samiti did not make a better decision regarding the handicap of the Acting Pramukh Adhyaksh within a few hours. Maybe you can settle this matter in the July Session. For the time being I can not help pushing forward the problems in view to the illness of the Pramukh Adhyaksh, he can only strengthen to deal with the different matters or find a person able to do this. Attached hereto you find several letters concerning several points. By this covering letter I want to inform you about Dr. Minz' visit. He is expected to arrive on June 21st in Germany, in Berlin he is expected for 24 hours. The main item of our discussion will be the proposed co-operation between Gossner Mission and Gossner Church in Nepal. Further I want to inform you that I got a letter already some weeks ago from Hardugan Horo. There was no special request from his side but obviously the desire to come into fresh contact with me. I have not yet answered him and do not know whether I should. Can you advise me?

I want to remind you on two matters we mentioned in our talks in Flensburg:

1. that the KSS may consider the visitors exchange programme for 1976 i.e. whom wants the KSS to come as official visitor to Germany and whom does the KSS expect as official visitor from Germany or do you want to interrupt the programme for one year;
2. competition for Bhajans. We decided about this matter and you agreed that Gossner Mission may encourage young people by a competition for new Bhajans and we expect three winners as a result at the end of the year after having published the competition in the Gharbandhu. I do not remember exactly the prices but you may.

Dear Brother Seeberg,

Thank you for your kind letters. I am sorry that I could not write you earlier. To-day we opened our office after the Christmas and New Year holidays. Almost all staff members joined the office here.

We are waiting for the guests from Germany, I have already chalked out programmes for them. As the guests are coming simultaneously we are put in accommodation and conveyance problems. Pastor Hecker is ready to accommodate one couple only, thus we are preparing the Jubilee Bungalow for two couples. As the responsibilities lie on me I have to advance some money to buy some bed sheets, mosquito nets etc. There is almost nothing in the Bungalow. I hope that money will be reimbursed from somewhere. Similarly I hope that we shall get some amount for conveyance, petrol etc. As we have still some time GDR brothers, Schulgen, and Richler may be advised to come in a later date in the area of Gessner Church, because we are heavily programmed. But if they cannot postpone they are welcome in their possible date.

Regarding Surguja matter you have sent the copy of the letter your note to Dr. V. Stieglitz. I am of the opinion that the amount for Surguja be given for the recurring budget, pay scale etc. Meanwhile Dr. Neudecker has remitted Rs. 12500/- for agricultural Development work for the field. If you or any one agrees to give money without much affecting the collection for regular grant of the Gessner Mission. I could not find any reference of my letter as you mentioned. For expenses incurred in the programme for the German guests I have already sent the amount payable to me viz Rs. 3934=50 only. You might have already remitted the amount.

Shri Jaywant Bihari Minz met me and requested me about his project. Since he has no reply from you he requests early reply regarding the subject.

As already intimated we have prepared and accepted a new draft constitution and it is under print. In between I have raised a very practical point for the cooperation of the Adhyakshes financially and administratively, due to which I am put in difficulty. Therefore I have given them ultimatum to cooperate or to arrange otherwise.

As I am busy with my own programme I shall not be able to attend the Kuratorium meeting in Jan. 75. I hope to attend the next one.

Over this amount 25% cost has been increased on account of increase of cost of materials and labour cost during the year 1975-76 thus making the amount to be Rs.12746.00 (Rupees Twelve thousand seven hundred forty six ) only. This case has already been recommended and sent to Curitorium Board in Berlin by Rev. B. Minz, the then Pramukh Adhyaksh.

I take the privilege at this time to place before you a few items of the GEL Church Expenditure which in my opinion need consideration and reimbursement on your favourable discretion. Dr.CKP Singh the Acting Pramukh Adhyaksh, happens to be now in Germany who may be consulted for information and needful action.

1. At the time of purchasing jeep now owned by Miss Ilse Martin, Takarma, the church had to pay more money than was received from Gossner Mission. The excess amount of payment was Rs.3133.01. The increased cost was due to extra body building and other remodelling works. The church should get this money back.
2. The conveyance expenses of German guests, not of 25 guests who came earlier, came up to Rs.1970.88 only. This could not be recovered by the amount of Rs.1120.00 only, which has been received as donation from themselves. The church is entitled to get a sum of Rs.850.88 according ly.
3. Also there is the expenses of Adhyaksh Council meetings, a total of Rs.10064.25 out of which Rs.6500.00 had been donated by G.M. The remaining amount of Rs.3564.35 is to be obtained from somewhere.
4. Then again there is court expenses which up to date adds up to Rs.2895.80 only. May be it will grow more. This out of budget expenses may please be considered to be paid by Gossner Mission.
5. Lastly, held in the year 1974 were three full and two KSS executive meetings which put the church with an expenditure of an amount of Rs.6766.00 only. According to the agreement of Nov.1973 there should have no KSS meetings as it (KSS) had been dissolved by then. Instead of minimising the church has increased the expenses, no fault of any body. The church has no mouth to request for this amount. It would be very kind of you Gossner Mission if half of this amount is granted from Gossner Mission.

Apart from I have requested, I feel necessary to remind you regarding GEL Church deficit of the period before Nov.1973. There is no body but you who can be requested rather prayed for it. We had a vision of a newness in the church by implementing a fresh constitution in the church which has not yet been done till to-day, but all will smash if this mere important thing is not rectified.





Thank you for your kind letter sent through the lady Pastor of your Parish. The days here passed away so quickly that we had little time left to visit. Yesterday we wanted to visit you but due to some misfortune we could not and therefore I am writing this letter at Rameli airport before the friends depart from here. The plane is late and therefore I take this chance to write.

The tourist group enjoyed the stay here. Except for one member all had the chance to visit as many places as they could. In future such a trip should be better organised and more useful programmes can

be arranged for the same. We  
feel that consultations must be  
made with the Gossner Church even  
in these small matters. It is good  
that interest for mission can be  
promoted in this way also and  
so better programmes be chalked  
out for the Gompo in future.

You have asked me to inform  
you about the works in the mission  
fields. The Udaipur field is  
progressing day by day. We have  
promoted Pastor Sunil Tilay as  
the Superintendent of Udaipur  
field and Rev. D.D. Topre is transferred  
to Surguja field. Surguja has  
made a tremendous progress. We  
have a new field supervisor  
Rev. Dhad Topre, a good  
missionary Pastor. We have

good results in Surguja after  
Rev. O. Topro joined the field.  
We have about one thousand  
new converts in a year in  
Surguja field. As you know  
the field is so extensive that  
it needs much care and planning  
to build it up. We have more  
than 65 preachers in the field  
and six Pastors. There are  
about half a dozen honorary  
preachers to lead and  
guide the new converts in  
new places. These are not  
included in the budget for  
1974. But when there is a call  
and people are responding to  
the message of Jesus Christ,  
we must help them as much  
as we can.

There is draught in Chittanagpur area and this has affected the giving of our people. There is a deficit of Rs 11,000. <sup>70</sup> (Rupees eleven thousand) in the Surguja budget. This amount had to be raised in the Gossner Church but we are sorry that we can not do so. Is there any way out to help Surguja at this time.

The Northwest Anchal is raising Rs 3,000 <sup>70</sup> (three thousand) out of this amount but we don't know how we can find the remaining Rs 8,000. <sup>70</sup> (Eight thousand). Kindly see if something can be done for Surguja for 1974 - Nov + Dec.

We all do well here and hope you all do the same. Yisusahay to you and your family and Particulars



In connection with the construction of a Chapel at Barrackpore I may kindly be permitted to place before you our grievances and to say ;

1. That during your last visit to Calcutta you were apprised with about the construction of a Chapel at Barrackpore at the cost of Rs. 25,000/-, a plan for which was subsequently handed over to you. During our talk, with a very high hope, we approached you for financial help and you very kindly promised your help (from the friends in Germany) to the tune of 75% of the total cost provided we locally raised a sum equivalent to 25% of the cost. With this hope and belief we have stepped forward and raised a considerable amount of money. We have already started the construction job and the work has been completed upto PLINTH LEVEL of the building. We would have continued the job of construction but owing to financial paucity we have not been able to go ahead any further.

2. That we have no house or flat to accomodate our Pastor and have been so long keeping him in rented house. In this connection we have suffered a *loft* in the past and we had to move one from one place to another. During your talk with Dr. M. Eage you were also told that we could at best utilise the same plot at Barrackpore for accomodating our Pastor by constructing a flat above the Chapel itself. As such a new plan has been prepared which would be the Church-cum-Pastor's Qr. (Plan enclosed for your perusal). According to the latest estimates the new building would cost Rs.37,000/- (Rupees thirty seven thousand only).

3. That you are quite aware regarding the financial capabities of the local Church members who on their own can not complete the Chapel. As such I, on behalf of the Parish Committee, request your good offices to help us your might in constructing the Chapel at Barrackpore which would be the worshipping place of G.E.L. Church for all times to come.



Dear brother Singh,

I have the pleasure to announce the transfer of the first instalment of Gossner Mission's contribution for the BEL budget 1975. We already ordered the transfer of DM 25.000,-- i.e. approximately Rps 75.000,-- these days. Though we are also short of funds in the early weeks of the year we had in mind the difficulties of BEL concerning payments without having available the amounts re to the new budget.

In one of your last letters (December 10th) you mentioned that the KSS required Gossner Mission to kindly allow the total amount of Chainpur of Rps 50.000,--. I have no objection if I would know what important item was meant by this request. Probably it is meant for the regular expenditures of the GEL Church i.e. for salaries, offices and meeting expenditures in the central Church Government. You may remember that we already have given for these purposes a certain amount in 1974. If the KSS wants to continue this method in 1975 also I want to ask the KSS what timetable there is for normalizing the financial situation of the centre. The KSS knows well enough that LWF stopped the contribution of this part to your annual budget, and it is not wise to expect Gossner Mission to pay the deficit instead of the missing LWF contribution. But again: It is up to the KSS to spend this Chainpur fund for the expenditures of the central office but it is impossible for Gossner Mission to create a separate fund for Chainpur, and as a matter of fact as soon as this fund is spent it is a loss for Chainpur.

Dear brother Tirkey,

threetimes you wrote to me regarding the surplus money for the Chainpur schoolbuilding (April 5th 1975, July 21st 1975 and again now on October 6th 1975).

Before you started this ~~remember~~ I already had correspondence with the Pramukh Adhyaksh, because he wrote to me on December 10th 1974 (No. 545/74/KSS-78) as follows:

"The KSS has required the Gossner Mission to kindly allow the total amount of Chainpur account a/s Rps 50.000,-- and to kindly arrange a seperate amount for Chainpur. The financial position of the Church is still in dilemma ....."

On January 14th 1975 I answered to the Acting Pramukh Adhyaksh as follows:

"In one of your last letters (December 10th) you mentioned that the KSS required Gossner Mission to kindly allow the total amount of Chainpur of Rps 50.000,--. I have no objection if I would know what important item was meant by this request. Probably it is meant for the regular expenditures of the GEL Church i.e. for salaries, offices and meeting expenditures in the central Church Government. You may remember that we already have given for these purposes a certain amount in 1974. If the KSS wants to continue this method in 1975 also I want to ask the KSS what timetable there is for normalizing the financial situation of the centre. The KSS knows well enough that LWF stopped the contribution of this part to your annual budget, and it is not wise to expect Gossner Mission to pay the deficit instead of the missing LWF contribution. But again: It is up to the KSS to spend this Chainpur fund for the expenditures of the central office but it is impossible for Gossner Mission to create a seperate fund for Chainpur, and as a matter of fact as soon as this fund is spent it is a loss for Chainpur".

Thereafter I received your first letter and again I wrote in this matter to the Acting Pramukh Adhyaksh on June 19th - you received a copy - asking him to clarify this matter.

This still is the to-day's situation. As I am not the financial dictator of the Church I can not deal with this matter before having received the clarification. May I advise you to investigate in Ranchi whether the KSS decided anything about since December 1974 or not. I myself can not interfere in this internal matter but if I would be in the position to express my opinion I would like to decide like Salomo i.e. to give Rps 20.000,-- out of the surplusto the Chainpur High School and the remaining amount for central expenditures of the KSS.

I hope that everybody concerned is willing to finalize this long pending matter and that you need not to write anymore angry letters to me but only friendly ones.
