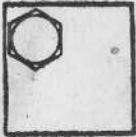

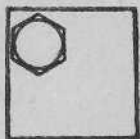

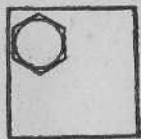

Subject: Urgent Officers' Meeting.

Dear brothers,

This is to let you know that KSS Officers' meeting has become very essential for the following reasons:-

1. Proposal of M/S cromelite:-

A. - Renewal of the lease be made rent free as the company is running in a loss. In place of rent the company will be ready to give 50 % of the profit to the church, or

B. - The church should take over the workshop and run it by herself. M/S Cromelite is prepared to take away all the furnitures produced by the church.

The above two alternative proposals have been communicate to the me by the Director Rev. C.B. Aind on Sept 21, 1971. Immediate action is wanted.

2. Dission of the Governing Body of Fudi T.T.C. -

- (1) - Buildings and machinery are to be placed at the disposal of the Trust.
- (2) - Land property be leased out to the Trust by the GEL Church on a long term basis for a very nominal rent.
- (3) - KSS be requested to pass resolution keeping in view (1) & (2) above to facilitate the Trust for ownership on Land, buildings and machinery on lease.
- (4) - General Body of F.T.T.C. be requested to finalise this issue in October 71.

3. Rev. Dr. N. Minz's bill of Rs.751/- for furnitures for the College.

The above three subjects need immediate dicission of the KSS, but as the matters cannot be postponed till next KSS-Samiti Meeting, Officers should meet immediately. Therefore date for Officers' meeting is fixed on Sept 30, 1971 from 2 P.M. in the Office of the Pramukh Adhyaksh. Rev. J. Topno and Mr. Tirkey were present and consulted to fix the date. You are requested most respectfully to make it a point to attend the meeting. Hoping to see you all on the 30th Sept '71 by 12 noon without fail.

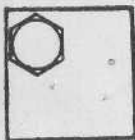
Dear Rev. Bor,
