


Dear Sir,

Dear Sir,

This is to request you humbly to reconsider your order and permit the occupants of those buildings to stay there temporarily on the following grounds :-

- (1) The occupants of the said buildings have no home to stay.
- (2) The two villages within the Rest Camp Area, have been demolished by the Military.
- (3) One of the long Barrack to the North of the Old Hostel has been allowed to Collapse by the military.

The two (2) villages and the long barracks were the main stay for such families, including the Church employees.

It is further respectfully pointed out to you that the Church did not say any thing although the military made use of the following, illegally and it is simply owing to the good understanding between the G.E.L.Church and the military.

- (1) Two Latrines near the Car Park within the G.E.L. Church Compound ^{was utilized} till about the middle of January 1948, although the place has been derequisition on 28.3.47

- (ii) Some M.E.S. employees have been located in the military building within the Gossner High School Compound,

which has been already derequisitioned. This has been done without giving us any notice.


(iii) The Military had illegally occupied for some months, some portion of the Plot No.....

(iv) Now, the War is over, still, the Rest Camp Area is under requisition and it is further said that the portion has been transferred to Government temporarily for the refugees. Here also the consent of the Church of the Church was not taken.

(v) No removal, charge to the occupants of these two villages, teachers barracks, servant quarters etc. had ever been changed.

(vi) Thus far we ~~has~~ have received ~~only~~ Rs. 17,000/- only from the War department (since 2.3.1942). The later assessments of buildings, lands, compensations etc, with retrospective effect, ~~at building~~ have not yet been received by us. We are therefore handicapped to build any building or hut for the people who have been rendered homeless.

Under these circumstances, you are again requested to allow these homeless families to remain there temporarily till some necessary arrangement are made further & also other employees of the Church.



It is a matter for great regret that you took the law into your own hands and occupied military assets standing on land hired by Govt: Strictly speaking you should have no access to the land taken over by the Govt: on lease, though no objection to this is normally raised in practise by us for maintenance of the friendly relations under which this land was hired from you. But the act of occupation of military buildings by you without previous permission of any competent military authority is unjustified, illegal and reprehensible.

2. Now two courses are open to you: (a) either to buy these buildings at market value or (b) to vacate them within a fortnight of the receipt of this letter.

3. The sale price for these buildings in your case, if you decide to buy them, will be :-

Building 143 : 3000/-
Building 144 : 2000/-
Building 40 : 2800/- 7800/-

4. If you like to offer a different price for these buildings you are entitled to do so and your offer will be considered. A personal call by you at my office in this connection may expedite the matter.

5. If you decide not to buy the buildings - and I regret that they cannot be offered to you free of cost as requested by you - then I hereby ask you to please vacate the assets occupied by you within a fortnight of the receipt of this letter, so that they may be disposed of otherwise.
