Dear Sir,

Going through the KSS accounts it is noticed that the fund made available for the Youth Department by the <sup>KSS</sup> completely exhausted after necessary payment up to July 75.

A sum of Rs. 2000/- was loaned to the Youth Department from Education Fund of KSS and a sum of Rs. 240/- was granted from the Head Quarters Congregation Ranchi, to make a fund amounting Rs.2240/- for the Youth Department.

It was assumed that by starting the Youth work with the above fund, the Director, Youth Department would find out ways and means to create a larger fund to establish the Youth Work running.

But it looks the Director could do little in this area of increasing the KSS allotted meagre fund. Hence there is no money left.



An extract from the minutes of the Officers' meeting of the KSS dated 10th Sept '74 item No. 6 is appended below for your information and needful action.






Dear Brother Ekka,

The above bill was forwarded to me by Mr. Bhengra and in reply to it I would like to say the following:-

1. That first of all I express my thanks to the Ranchi Youth Fellowship for allowing to hold the course in the Youth Centre.
2. That the course so organised was the activity of G.E.L. Church to give training to more pastors of our church in which the Anglicans also participated. It was not possible had it been held at Durgapur due to financial and language difficulties.
3. That your bill is quite alright but the question of rent charge was not raised right in the beginning. Therefore I request you not to charge rent for the purpose. However I would like the Youth Fellowship should get some amount of money as donation. In this connection I had a talk with Mr. Bhengra and he suggests to give Rs.53/- (fiftythree rupees) only according to fund available. So I request you to accept Rs.53 as donation instead of rent.

Please consider my point of request and let me know your decision at your earliest.


Dear Sir,
