Dear Mr. Khess,

As per our verbal agreement and understanding I contacted Sri.S.Bhengra, the KSS Accountant, and Sri.A.Panna, Accountant RCP in the presence of Dr.C.K.P.Singh. On my advice Mr.Bhengra has given me a written statement that Rs.20,000.00 (Rupees Twenty Thousand) only loan was paid to the RCP on the verbal request of the then Secretary RCP on 11.6.73. This was done on the approval of the then Treasurer KSS as a temporary loan. He further says that the loan has not been returned to the KSS.

Further Sri.A.Panna the Accountant RCP states in his letter No. BPR/109/104/RC-74 dated 19th June'74 that the loan of Rs.20,000.00 was taken from the KSS against deposited cheque of Rs.20,000.00. This loan has not been refunded to the KSS according to Mr. A. Panna.

On the basis of written statements of Mr.S.Bhengra, Accountant KSS, and Mr.A.Panna, Accountant RCP, I am convinced that the above transaction was made on 11.6.73. Therefore, the RCP has to refund Rs.20,000.00 to the KSS as soon as possible.

As all concerned agreed yesterday that the first transaction in opening the RCP Bank operation should be a cheque in favour of the KSS, I request you to do so. On this condition Dr.C.K.P.Singh will give a required written statement to the Bank which will enable you to operate your RCP A/c.

Wish the RCP all well.
