As we have to take a taxi for Govindpur and as so many sisters from all overthe Church have already assembled at Govindpur, there will be difficulties in our halting for a night. The taxi will charge extra for the halting and besides, there may not be any space left for male folks when the females have already filled up every possible accommodation.

Under the circumstances I think that the group from R anchi should go to Govindpur tomorrow in the morning arriving there at about 9 a.m. and hold the meeting for about an nour in the forenoon. I should like to see the Bible Class for about an hour in the afternoon and at once we all come away in the afternoon tomorrow.

Please try to adjust the tomorrow's routine accordingly. We shall follow the timw which you will fix for the meeting, lunch, a Bible lesson from me and then our departure.

I am indeed so sorry that we could not be in time for the meeting as previously thought of.

I am giving below a true copy of the Inspection Note of the S.D.E.C., Khunti made on 24th and 25th Sept,58 about the finance of the school. I am just now not giving you the copy of the entire remarks. His remark about finance is

important and serious.

"Cash Book-It is written in such a manner that nothing definite can be made out of it. The actual financial position of the school cannot be ascertained from records available in this school. The account records have been maintained in a very perfunctory manner. The cash book shows a balance of Rs 3524/11/3 on 1st Sept. '58. Postal S.B. Account No. 85183 shows a balance of Rs 300/-only on 5-7-58. Neither the Headmaster nor the clerk could tell me anything about the whereabouts of the balance of % 3524/11/3. This is a very sad arrangement of things. The Headmaster will please explain as to with whom or where the balance of Rs 3524/11/3 lies. I tried hard to find out the differences but nothing definite could be found out from the records."

I have to report the following about handing over charge of the Cash Book, Fee-collection Register and the cash if any by the clerk who kept and spent all money hefore I joined and even after it. In the first instance, before I joined and even after it. In the first instance, thnigs, articles and furniture were handed over to me formally except the Cash Book. Shri Surin then told me the account books would be handed over later as they were not ready. I waited for some months but were not handed over. Then Shri H. Topno became Secretary to whom I reported the matter. He tried several times in several ways to get the clerk hand over the account books. Promises were made clerk hand over the account books. Promises were made by the clerk but it was not effected. Once Rev. Topno warned the clerk very sternly but with no result. Then in am M.C. meeting under the Chairmanship of Shri N.E. Horo, the matter was brought up and he became sterner but the still the account books could not be handed over.

In the meantime after three or four months I found In the meantime after three or four months I Tound in gradual process that we two, the clerk and I handle money. Realising that two men cannot handle and spend the money I ceased receiving and spending any money, since I received no charge in a balance sheet. Moreover two auditors. Rev. Topno and SWhri J. Topno appointed by the M. auditors, Rev. Topno and S/hri J. Topno appointed by the M.C. could not yet audit the accounts. Practically I am handling money from June, 58 when earlier in an M.C., the clerk was asked not to handle any momey under the chairmanship of Shri N. F. Horo Refere this month firstly the Shri N.E. Horo. Before this month, firstly the clerk handled all moneyLater for some months, we both handled it. Finding my mistake I gave it up but started it from June 58.

The S.D.E.O.came on 24-9-58 and 25-9-58. Even on The S.D.E.O.came on 24-9-58 and 25-9-58.Even on 24-9-58 someting was incomplete and he asked us both to get it ready for the following day. All the time from my joining till the 24t. Spth I refused to sign in the Cash Book and the Fee-Register knowing the moment I sign, I shall be responsible for the balance, credit, debit or shall be responsible for the balance, credit, debit or nil balance-about either of which I was in the dark till the evening of the 24th. Sept, 58.I found in that evening that if I do not sign, the inside sad story will be discovered by the S.D.E.O. the following day and most probably the M.C.as the Supervising Body would be seriously involved. So on the clerk's asking me to sign all the pages of the Cash Book and the Fee-Register from November 56(the first month after my joining) down to August 58,I expressly told the clerk the risk I ran in signing the Cash Book.On that night of 24-9-58 I got him signed a statement that prior to June 1958 he is soley responsible for all money for some period and jointly responsible with me for later period. Then I signed all the pages of the Cash Book from November 56 to August 58 on the night of 24-9-58.

On the early morning of the 25th max Sept, much before the S.D.E.O.came, I alerted him to be ready with his sound explanation about the huge credit balance of Rs.3524-11-3

shown on 1-9-58 in the Cash Book.

The clerk gave me two main explanations which were entirely or partly disbelieved by the S.D.E.O. The two explanations were:-

1. Bogus entries of "Advance from Secretary" by the predecessors had increased the Cr. Balance.

2. There is some money, Rs 1000/ or Rs 1500/- in the Christian Union Bank besides Rs. 300/- in the School Pass Book.

On the first explanation, the S.D.E.O. was not much convinced and impressed. On the second explanation, the Union Lank Pass Book was brought in the second time. To his surprise and to my surprise, this Pass Book contained a balance of a few odd rupees not worth mentioning. Here he caught us. It was settled between the clerk and me that I would plead that that an entry of some R 500/- has yet to be done by me as expenditure. Since the first two explanations by the clerk stood challenged, I did not , rather could not mention about my entry of some R 500/- on the expenditure side. The other Palpable contradiction is that the Acquittance Roll showed on 25-9-58 that teachers were paid their salaries upto May 58. The argument the S.D.E.O. advanced was in spite of that huge credit balance, how the teachers could be paid only upto XXXXXXXX May 58.

The Cash Book shows similar huge balances month after month from January 1954 right down to 1st Sept 58. I tried to understand these balances by but came to know conclusion. There is no recorded proof that Shri J. Tuti handed over cash of 1491-9-9 in June 56 to Rev. S. Surin. Neither does the clerk give satisfactory explanation to it. According to Cash Book I should have received a cash of Rs. 1253-4-6 but no such transaction was made. It's all in paper. After the appintment of the science teacher on 19-9-58-the last man to complete the staff, I was about to write to you in deatail about the giving and taking over charge of the Cash Book but the S.D.E.O. visited unaware. It seems all the preceding secretaries or mission treasurers can throw light on these balances.

I am simply unable to submit an explanation of the whereabouts of the balance as ordered by the S.D.E.O. The time given to me for submission of explanation is one month. The date of submission is 7-11-58.I am presently giving you the detailed Inspection Remark of the S.D.E.O. together with a separate balances of the Cash Book month after month from January. I shall try to see you some day between the 13th.and 15th.October, 58.

25-9-58 Govindpur High School.
Accompanied by the Sub-Inspector of Schools, Karra, I paid a visit to the Jubilee High School at Govindpur today and found 109 pupils present out of a total of 124 on the rolls. They were thus distributed:Class XI-19/20, X-18/21, IX-29/33, VIII-43/50= 109/124.

Today's attendance is fair. A section in class VIII with 14 students was opened in July 1958 for which no permission was taken from the Authorities with the result that the numerical strength of the newly started section has come down to only 5 today. The number on roll in class VIII is always constant at 50 and whenenever boys from this class leave the school on any account, the names of boys from the newly started section are transposed to the section VIII. This process is objectionable as new-comers cannot be admitted in any month of the year more specially when the current session is for 6 months only.

School-Buildings:-The school building consists of 5 rooms and a hall.4 rooms are used as class rooms for the 4 classes from VIII to XI, the fifth room being used as a class room for students having optional subjects only. The hall is used by the High School and the local Middle School in cases of general prayers, meetings and reception of teachers. The rooms are of Kacheha bricks, walls are plastered and white-washed. The roof is of bamboo frames laid with tiles. Another room which is just in front of the school building is being used for office purposes. There is a hostel containing 19

There are two play grounds, one is used by the High School boys and the other by the Middle school boys. Besides there is a field for Volley-Ball. 1.Sri P.Bara, B.A., Dip-in-Ed. Headmaster. 2.Sri J. KIspotta, B.A. 3.Sri M.B.Horo, I.Com.

4.Sri U.N.Jha, Acharya. 6.Sri Marsall Purti-(app-5. Sri M.P. Kerketta, Matric. eared at I.Sc.) and Sri S. Horo is the clerk. Serial No.5 and 6 above are not qualified for the posts they hold and they should be replaced by qualified teachers.

Furniture and Teaching Appliances: - There are sufficient furniture and teaching appliances which are quite adequate for the purpose. Library: - A Register showing a collection of 576 books for the use of boys was shown to me. Recently the Headmaster has added stock with some useful books. Boys of the school seldom make use of the library as is found from the issue register of the library books. The pupils should be encouraged to make frequent use of the library books.

Managing Committee: - The Managing Committee consists of 11 members formed on old lines. The meetings are not regularly held. The last meeting was held on 1st.July, 1958. Meetings should be regularly held regularly.

Annual Examination Result of the S.S. Board: 1953-2/24, 1954-13/19, 1955-6/7, 1956-6/8, 1957-7/25, and 1958-1/18. The results are very discouraging. Accounts: -(a) Acquittance Roll-Some teachers have been paid up to Feb.1958. From March onwards, the Head teacher, Sri J. Kispotta and the clerk have been paid up to May 1958. Other teachers have not been paid. In june 1958 no payment has been made to any body. In July only two teachers have been paid. In August only the Sanskrit teacher has been paid. In Sept, no body has been paid. This is the state of affairs in respect of payment to the teachers and as such one cannot espect any sincere work from them. I went round the classes and examined the puplis present in Arithmetic, Hindi Text, Social Study, and General knowledge and found the progress of work far below the standard. This is very discouraging. I could not say any thing to the teachers as most of them complained to me regarding non-payment and under-payments.

The School discipline was found quite satisfactory though I was much dissatisfied with the working of the school. I request the Headmaster to see that the accounts are maintained and written up-to-date condition, so that I may see them in order in y next visit.



I am in receipt of your Ref No. 400/60 of 21st March, 60. In this connection, I beg to say that I am now an invalid to make long journeys. If I go to Takarma, I kzzz shall have to take my wife with me. On 7-1-60 I suddenly fell seriously ill and am under medical treatment still. So, I am unable to go take Takarma

In this connection I beg to say that on 24-5-59 I went to Takarma and stayed till the 26th, May and studied the accounts of the school. I revised the totals of all the entries down to the end,

Then I found that I required the copynof the Building Account from the beginning, which caused grave doubts in my mind, I came away with a promise to Rev. I did go but unfortunately found on arrival that Shri Barjo had left in the morning while Rev. Kiro was present. Kiro who is the Vice Chairman of the Managing Committee and who is equally a responsible officer of the Committee. If the account books had been left behind with Rev. Kiro, my purpose would have been fulfilled. I came away disappointed. I want to study the building account. This study would have been ginished long ago. But I could not meet Bri. Barjo then. 

Nirmal Minz, Professor.) did not have to follow the holy code of the Gossner Church Ministerium for ordination. Some of these Oraons have been ordained without wives and the other had to demand or request for ordination. Please why the foreign returned Oraons do not have to follow the holy code of the G.E/G/ L. C. ministerium (c) The foreign returned Kharia (Mr. Martin Tete, Head-master) has to follow the unbiblical and man made regulations for his ordination. The wife has become the certificate for the ordination of the foreign returned Kharia. Please explain to me from the .: Bible that the wife is the certificate for the ordination of the foreign returned Kharia. 1. I thank you for the copy of your letter dated the 23rd. July, 1959 to the Secretary, G.E.L. Church. Until the proper time comes I think I have to keep quiet over the matters put forth in your letter. Here it is enough to say that I am in sympathy with you and would kindly suggest that you accept the membership of the Tabita School Memaging Committee. As far as the adverse criticisms which make you feethat you are not qualified to be a member of this Memaging Committee, I would say that those who have made you member of this Committee consider you qualified and eligible for the office. I must also say that there is no remark against you by any one of Govindpur or of any other place. There is no criticism against you of which I am in the know. As President of the Church I claim that I must be the first man to know if there are any adverse remarks against any one who is a candidate for ordination.

2. I acknowledge with thanks your letter dated the 50th. July, 1959. I note that there are two separate matters in this letter. (a) sent larghtp for Bixal and Matthias: I plead that since the students are already admitted by mutual consultation, they and the College smould not suffer and the name of the Church should be maintained for the good of the Church and for the benefit of these and other future students. I carnestly request you to kindly send money to these students

as much as you can and at your earliest convenience.

(b) Ordination: I can understand why one feels the way you have expressed. Legally and traditionally it is impossible to deprive any one of his right for ordination. If I were you, I would refrainfrom introducing racial matters in this connection. I don't think that the mundas and the Oraons have combined together to injure you in any way. I can admit if proved that, the decision to make you wait for the ordination until after your marriage is a mistake. But this does not in any way warrant a denouncement of maindas and Oraons who sit in the Church Council. You have been very helpful to the Church the Church Council. You have been very helpful to the Church in many ways and the Church cannot ignore your good qualities your efficiency and your abilities. The Mahasabha recognised the

I have to inform you that Mr Nirmal Minz was examined by the Executive Committee of the Church Council on the 11th Feb 1959 and was

unanimously declared a candidate for holy ministry.

Mr Minz has received a call from the Lutheran world Federation to be sent out to Sumatra to be a professor of the Theological Department of the Nommensen University. The federation of Evangelical Lutheran Churches in India had been asked by the Department of world Mission of the Lutheran world Federation to find a suitable person to replace Rev. Devanesan who is at present in the said University. The F. E. L. C. unanimously selected Mr. Minz to be the successor of Prof Devaneson, The Department of world Mission of the L. W. F. asked the Church Council whether Mr. Minz could be released for this purpose for a period of three years or not. The Church Council Executive, inspite of the need of the Gossner Church itself and inspite of Mr. Minz having started his work well here as a professor in the Luth. Theol. College Ranchi and as President of the Gossner Church Youth Organisation, seeing that Mr. Minz. considers this call to go to Sumatra as a call from God Himself, and knowing full well that Mr Minz's service in Sumatra will be a humble contribution of the Gossner Church in the ecumenical enterprise of the Church of Christ, decided to release him for a period of three years with effect from 1st May, 1959.

The Lutheran World Federation also expressed its desires that before going to Sumatra Mr. Minz be married and also ordained. We are happy to recall that Cand. Minz is already engaged to Miss Paracleta Khess one of our students who had her training in Germany. She is now teaching in our Tabitha School at Govindpur Mr. Minz informs the Church Council that they

plan to marry in the first week of May this year.

The Church Council Executive desires that Mr. Minz be ordained on March, 1. 1959 Sunday before the Mahasabha. Revd John Toppo and Director Lokies are requested to officiate as President's assistants at the holy ordination of Cand. N. Minz. 



Dear Sir,

I am herewith applying for headmastership of Jubilee High School, Gobindpur. I could not apply earlier as I got your letter on the 12th inst. and as the Ilaka did not pay and has not yet paid me the money requested by the M.C. The M.C. wanted to know the definite date of my leaving this school. This was impossible as I got no appointment letter from any source. I demanded some money out of my big arrear dues, on receipt of which I promised to leave this school on 1-10-56. Since the Ilaka has not yet baid me any money ordered by the M.C. . I am now uncertain about the date of joining your school. The difficulty on my part is this. In order to live at Gobindour with one of my daughters, I need money for at least one month. The others will live here. I must give them some money again. I have to pay Ruby's college hostel fees of some two months. I have again to pay to shopkeeprs from whom I have bought things on credit. I have to clear the shopkeepers's money before I leave. So I demanded Rs. 500/- out of my arrear dues. .

These are the obstacles in joining your school on 1-10-56. Moreover the Pjaa holidays will start on or from 2nd or 3rd Oct. Maxxix The schools will reopen on or about 15th Oct. So I want to wait for that money from the Ilaka till about the 13th.Oct. If I get it by 13th.Oct I shall be free to join your school on the 14th.i.e.a day before the school reopens. If I don't get money by the 13th.Oct I may be able to join after the 20th.Oct when I expect one months' full salary because the XIth pupils will have to pay fees any atthicks till March 57 before our Pre-Test Exam. But of this marks fees I hope to take some for me as my salary. But I am doubtful if I shall be successful in taking some for me out of it. But on second thought I believe it is abourd to hope for this Pre-Test Fees.

I told my difficulty above. So you can know on what date I shall be able to join. I prefer to join on the 14th.Oct.



Sir,

Early this month the S.D.E.O. (Sub-Divisional Education Officer recently stationed at Khunti finally to replace the District Ins-Inspector of Schools) came to this school in surprise visit. In the course of his inspection of records, he found to his sorrow, that the Cash Book was not even closed for March, 58. Then he addressed me and said, "If you keep the records in such state, you will have to flee from this school and place". His remarks were justified.

We, the Headmaster, the clerk and the Secretary are directly in charge of running the school smoothly. The clerk is responsible for proper maintenance of records aided and supervised by the Headmaster. The Headmaster is responsible for maintaining all-round discipline aided and supervised by the Secretary. Ever since I came here I have found a sort of triangular tussle goes on unabated.

The clerk has somehow not had need over the Cash and the Sub-

sidiary Books uptill today. I am afraid to have those account books as he kept large amount of money and I want to be sure before I start my entries the balance, being uncertain of which I cannot proceed. Comming to the Correspondence Section, I find it is equally haphazard. Receiving, Drafting and Issue of letters is not smooth, so much so that Receiving the letters is so neglected that I have piles and piles of them without being Received. The other two works are similarly inefficiently executed. I know full well that I am responsible for all this. The S.D.E.O. is right when he said

I would have to flee from this post.

I know the Headmaster is directly responsible for discipline.

Ever since I came I had to face clique after clique. The last but not the least point of discipline is the one I narrated to you in my letter dated 26-8-58. This one instance alone makes me repent why I came here. In this point, the Secretary and I do not see eye to eye. I have not been able to rectify it and I admit that I would not be able to rectify it. Here again the S.D.E.O. is right in saying that I would have to flee sooner or later. I quite welcome it. The Secretary wants all grievances placed before him in writing. I refused and still refuse to record such nasty thing in writing. I have put this one in the first place towards realisation of discipline while the Secretary seems too take it to be a trifling matter. We differed in the way Shri C.Barla's resignation was accepted. We differed in the matter of the pay of Shri Barla's substitute Shri Premchand Topno and hence the gaza calamity into which we were all plunged. Had we both agreed readily, the matters would have been smooth.

To maintain and enhance the fair name of the Institution, there should be unity, co-operation and mutual help among the trio. If the Institution gets a slur, degradation, impediment or deadlock, the wiser of the trie should vacate his office to allow better hands to take the school towards better discipline, better progress and better output. And the duller of the trie should be asked to vacate his office as he is an obstacle towards improvement.

Therefore I hereby voluntarily resign the Headmastership so that the school makes all-round improvement with the fervent prayer that I be very kindly trasferred to some other school on this side of the Karo and the Koil, for which act I shall ever

remain grateful to you.

I beg to place the following grievance for your kind perusal

and sympathetic consideration.

As I am habituated to a life of following the path of least resistance, I pray you sincerely and humbly to transfer me for the undermentioned reasons to some other school on this side of the Kare and the Keil. I am prepared to work as an assistant teacher in

Kare and the Keil. I am prepared to work as an assistant teacher in a school at Ranchi on reasonable pay if there be no way out. Incidentally I may be permitted to mention that I possess the Class-Record of the Patna Training College testifying that I stood seventh in Practice and thirteenth in Theory in a class of 60 students.

Prior to the resignation of the Secretaryship by the Rev.S. Surin I found one day, to my surprise and great puzzle that Shri J. Kispotta, the Assistant Headmaster and a graduate too, with some service and experience to his credit in some school elsewhere, sat tight on my effice-chair though there were other chairs there showing not the least sign of budging an inch from it as I entered into my office the least sign of budging an inch from it as I entered into my office crossing the door-step. Following the same path of least resistance I pretended that I did not mean to sit down in the office and walked off. Since this devilry goes on with relentless hardihood I pretend in the same way. His sitting tight and my walking off from the office has happened several times. Shri C.R. Surin and Shri M. Horo, compounder are in the knew of this effronter warring. Seeing this stiff upon the are in the knew of this effrontery are ing. Seeing this stiff uncoulteeus conduct of his sitting tight, I have learnt to retrace my steps
with the same pretension, thereby refraining from an untoward summary action which is nothing but an everlasting cudgelling. The last incident in these relentless repetitions of the perverse effrontery took place in the presence of Shri M.P. Kerketta and Shri S. Horo, clerk when there was still seat for him. He sat as before with uncornedly supreme indifference though I approached my chair. On this occasion I had some unavoidable work to do, and sensing no sign of his budging an inch, and sensing that he far exceeded the limit of courtesy and discipline, and gauging that he possessed this devilry to insult me before other subordinates, I ordered him in unpolished unpolite tone to quit the chair though I became exasperated in no small degree to accomplish my long-planned deed of cudgelling. I might have flown into a rose but thenks God I checked by magning Heattenately he might into a rage. But thanks God, I checked my passion. Bortunately he quitted the chair without a word or the worse might have happened before penning these lines to you. Had he shown the least sign of unwillingness, what would have happened to him and to me. Failing to remedy it by reporting the matter to the present Secretary, I have determined to solve the matter in that way, for it is shameful for me to report this shameful act the second time. Having cudgelled him then and there I would have flown to my house to write out and submit forth-with my resignation. I have verbally reported the matter long ago with XX XXXXX to the present Secretary with no result.

But, Sir, I have yet to tell you the same tale of the class. Similar rude rustaichhas been exhibited by him several times in the class or classes, the class standing up while he sitting tight on his chair when I entered it or them. It has become a terror to me to enter his class. To be acquainted with eceptionally rude conduct and to be an eye-witness, I invited the present Secretary, of course, not in writing to follow me into his class just a few seconds after. One day in a lorry journey I mentioned these incidents to the Ilaka Secretary. Again this very gentleman one day on the 16th. May or so in 1958 was discussing with the Secretary in my office in the presence of one or two teachers that in this school there prevails a discipline somewhat like the discipline of a Dhumkuria School when I stepped in and overheard these words. Yet in Dhumkuria school, the lowest teacher with the lowest qualification does not, cannot mete out such behaviour to his headmaster. I have reason to believe that a debased and twisted discipline is being inculcated upon the students in season and out of season, inside or outside the class, himslef violating, opposing and misdirecting discipline in general. At this advanced stage I do not believe in any one able to change his conduct for the better. Neither do I believe in any one professing anxiety or eagerness in rectifying the discipline of the school without, first and foremost, wiping out such palpable breach of disci-pline. Neither am I prepared to forgive and forget such deep-seated

effrontery meted out by a teacher of his education, position and influence.

Neither do I believe he can unlearn this even if lectured upon. I have hitherto mentioned chair-incident only. I have yet to enumerate his dealings in other points which are equally disheartening.

Lastly I have to let you know that the Secretary has, true, ordered me to submit all my troubles to him in writing. I am prepared to submit all grievances in writing except this one. Giving this in writing means that this inconceivable meanness of his would be exposed to his harm of prestige. The reporter would also be instrumental in harming his prestige. This should

have been put an end to by verbal means.

Now that I submit this meanness in writing to you, the highest church dignitary, I am publishing it, which I did not mean. Circumstances force me to place the matter before you. While I submit this matter, I pray bumbly to transfer me kindly to a school noted above, for which act I shall ever remain grateful to

Dear Sir,

Please do remember Candidate's Martin Tete's prayers prayed to the President and to the Secretary of the G. E. L. Church. The following were his prayers in brief:-

(1) He requested the Church Council to kindly find a suitable place for him in Govindpur, because he is to be the teacher of the Pracharak Training School.

(2) He prayed to the Church council for leave absence from Pracharak Training School for as long as he does not get a place to stay in Govindpur.

(3) He prayed to the Church Council for service out of Govindpur when he does not have place to place his head in Govindpur.

At present he is very sorry. The Church Council does not care to listen to him. In order to get good place to stay he tried to be good Munda, and even pretended to be false Oraon. Because he knows that all foreign returned Oraons and Mundas have good German built bungalow to stay. But poor Tete has failed and he will fail in the long run if he continues to look for a German built bungalow. He should know that it is easier for him to be Christian than to be Munda or Oraon. He must also remember that he did not earn enough degrees in America to stay in the German built Bungalow.

Further he wants to offer two more prayers to the Church Council of the Gossner Church. (1) He honestly requests the Church Council for a Pracharakpan. He will be happy to stay in a Pracharakpan. It is easier for him to bear his cross for Christ in a Pracharakpan than to bear his cross in Govindpur. By giving him a Pracharakpan the Church Council will save Rs. 75.00, because he needs only Rs. 25.00, to live on in a Pracharakpan. Poor Tete can easily stay under the tree of the Pracharakpan or he can erect whut where his Pracharakpan is. (2) He requests the Church Council to withdraw her decision which was made during the appointment of poor Tete. He does not need headmastership the Pracharak Training School. The Church Council does not seem to care for the Pracharak Training School. The Church Council and the Christian in the Gossner Church are ready to build rooms for all kinds of secular schools, but they have only nominal rooms for the Training School and even for the Seminary. They do not see that the Seminary and the Pracharak Training School are important institutions in the Gossner Church. They are ready to throw money for high schools etc. etc... but not a single N. P. for Seminary building and Pracharak Training School. Where do you have the glory of Seminary and Pracharak Training School today ? The first thing has become the last and the last thing has become the first, and therefore let us all fight for poor old German built Bungalow.

Poor Tete is staying in Govindpur as a pure Gentile. He hopes that he has explained his situations frankly and honestly. Please be mereiful to him.






