Sir,

I beg to state most humbly and respectfully
behalf of the poor but dutiful teachers of this
School that they have not received their Dearness
Allowance for the periods from December 1952,
as yet. The D.A. bills have been already
submitted to the Deputy Inspector of Schools,
Jharkhand and from his records it is quite clear
that he has forwarded them to the District
Board, Ranchi duly countersigned. Petitions
also were placed to the D.B. for this purpose
but to no effect.

I do not want to draw your attention
towards the present state of payment of
salaries to teachers as you are quite aware
of it. Due to heavy shortage of church
income and non-realisation of school
subscriptions it has become a difficult
problem for the institutions in charge of
Lutheran Schools to solve. Hence heavy
dues in teachers' pay are occurring,

In spite of this the teachers are carrying on their duties entrusted to them. But everything has a limit beyond which nothing can be expected. Their present financial condition has become too pathetic. They are in such a state that they cannot think what they are to do.

I, therefore request you to kindly favour them by consulting the D.B. regarding their D.A. and make necessary arrangement for its payment so that even a gleam of ray might be helpful to them in restoring their exhausted and spiritless energies towards the performance of their duties in such abnormal circumstances.



Inspection Note of Lutheran Middle English School, Lohardaga,
by the Head Supervisor, Lutheran Schools, Ranchi.

I visited the Lutheran M.E. School, Lohardaga on 23.9.53 when the classes were on. All teachers were busy taking classes including the Head Master.

There are 6 teachers in all, among which one is a trained Matric two untrained Matrices, one C.T. failed and two M.E., E.T. passed.

Total roll of the school is 180 including girl students who are in classes VI and VII. Co-education is carried on in middle sections.

While inspecting the books of the school it appeared that the Cash Book was written up to June 1953. The Head Master explained that it could not be written onwards as the Ex-Head Master Mr. Tairkas Toppo has not cleared some of the accounts as yet. It should have been brought up to date before he was relieved. The Managing Committee should have looked to it. It was not done, however, and so cash balance could not be ascertained. I understand that Mr. Tairkas is employed in the local High School under the church. He is therefore locally available and he should, therefore, be requested to bring the book up-to-date, for the period he was in charge of the school accounts. The Managing Committee should immediately take up the matter and report to me of action taken.

Attendance Register of teachers was found to be properly maintained. Other subsidiary registers are similarly kept, but I must stress here that ~~hkkk~~ all books must be kept properly and up-to-date. Grant-in-aid to the school and enhanced salary to the teachers for the current months have not yet been paid. The school has been receiving contingency money regularly. Teachers avail of the benefit of Provident Fund. Instruments and teaching appliances should be procured more and maintained.

Managing Committee should very often meet and see how best to improve the condition of the school financially and otherwise.






