I, as a good-friend, had requested you to hand over charge of the Superintendent's Gr. I am surprised to not that instead of giving us reply to the point, you have deliberately tried to side track and avoid, not only this simple issue but also have tried to desy circumstances which completed you to leave this noble institution. The living Gr. which is now being unauthorisedly and illegally accupied by you is of as much importance as any other issue counsected with you and the press.

You have written about settlement of provident fund and the benefit of pension. I would like you to please refer to fundamental principles guiding the rules of pension and provident fund schemes. You can not blame others for non-settlement of these benefits, with which you and you alone as Superintendent of the press were primarily and absolutely responsible for the mismanegement of this institution. If the press owess owes any thing to you, adjustment of what you owe to the press.

I fully agree with you thatone should always try to avoid the circustances which would lead to wards uncertainty.

If there is any uncertainty and the so called "long outstanding complicated basic issue" of yours have remained unsettled. It is you who is fully and solely responsible. That is why dear Mr. Khess, I would advise you to please put your case to the proper authorities.

Sub: Inspection Report.

Dear Sir.

A reference is drawn to Sri.S.E.Barla, Asstt.Manager, Board of Property, inspection report of M/s.Printrite Block wherein serious \*\*\* irregularities were detected. We are not fully aware of the terms and conditions of the lease agreement, but so far item No.1,2,3,4 7 5 are concerned, it directly effects the press, as it is a cause of immense damage to the business of the press.

It is gathered that recently-the above firm has further auguemented the installation of printing materials and it is apprehended that this unconstitutional activity of the firm will further damage the business trend of the press. Therefore, in the best interest of the press, suitable action is imperative to curb the irregular activities, which is not within the perview of the terms and conditions of the agreement.

The copy of the inspection reportis attached herein for ready reference.

#### Inspection Report.

As directed by the Secretary, Board of Properties, GELC. I visited M/r. Frintrite Block on 6th September, 1978, accompanied by Mr.L. Dungdung & Mr.B. Lekra, Secretary and Superintendent of the press respectively, to check whether printrite Block was doing printing jobs, besides Block making.

These are our findings:-

- 1. That they have a Printing Machine. We understand from a reliable source that enother printing machine is on order.
- 2. That they have 36 cases of types of various sizes which can only be used for printing jobs.
- 3. That they have a separate job register for printing jobs which Ar. Presad, the Manager of Printrite Block, refused to show to us on the plea that it was their internal mather.
- 4. That they are printing and giving bills & cash memos to a number of customers and are issuing receipts elso. Since they did not show us the job register, we did not ask for copies of bills & cash memos, etc.
- 5. That they are undertaking even big printing job like House Magazine from \*\*\*\*\* M.T.I., Minoc & other such jobs of that nature.
- 6. That they are defaulter and the grear rent is Rs.3.300/- as well as this is a clear violation against our lease agreement. Burther if legal action be taken, it is suggested that rent be stopped immediately.

All these go to prove that M/s. Printrite Block are not. only engaged in printing jobs at present but are thinking of expanding their printing business further.

This is positively against the interests of our G.D.L. Church Fress and also in contravention of the lease agreement.

In the by gone years working result of the press was non too convincing and at this stage it is very difficult to dig out the causes which has attributed to this sad plight. Loans were heaped up beyond returning capacity and it is strance to note that although loans were procurred from different agencies, no concrete effort was made to stablise the capital fund, with the consequence present smooth working has been very badly affected. To spear ahead, achieve the target production and attain self sufficiency, the working system has been streamlined and sense of responsibility has been imited amonget the workers. Further 1979 has been declared by the workers and staff as a test year for our future survival. The anticipated annual turn over target is tentatively simed at Rs. 3,60,000/- and with this end in view all resources at our command have been geared up. But certain unsurmountable factors will retard our progress. Manly paucity of fund is the main factor in causing hinderence in maintaining buffer stock of paper and printing materials, which in turn is dislocating our schedule of turn over. Dear Sir.

With reference to the letter No.58/77/F-48 dated 15.3.77 from the Head office of the so called" North West Gossner Evangelical Lutheran Church" I would like to state as under:-

- 1. That the above mentioned letter is misconcepted and misleading as there is no existence of such church with its officers within the jurisdiction of the G.E.L. Church in Chotanagpur and Assam, Ranchi.
- 2. That Rev. S. Barla is the constitutional and legal head (Pramukh Adhyaksh) of the G.E.L.Church in Chotanagpur and Assam. Rev.S.Barla has been elected Pramukh Adhyaksh constitutionally vide Article XVIII in compliance with the Court's decree on Title Suit No. 232/85 of 1973, after due notification and is in line with provisions envisaged and made by the Continuation Committee in its meeting dt.Sept.4-8,1960.
- 3. That the KSS with its officers, Boards and Standing Committees has been constituted under the chairmanship of Pramukh Adhyaksh Rev.S.Barla, therefore, these are legal, constitutional and valid for the whole Gossner Church, and have every right and control whatsoever as provided in the Constitution 1960 of Gossner Church.
- 4. That the door is kept open for all the members of North West Anchal who are willing to join the KSS of the Gossner Church vide KSS resolution in its meeting dated 13-14th Jahuary, 1977 item 16(A)(1) which reads as The doors of the KSS.is kept open for N.W. Anchal to join the present KSS." because peace& progress is not in division but in unity.
- 5. The G.E.L. Church in Chotanagpur and Assamis one. The declaration of the N.W. Anchal as an independent "North West G.E.L. Church, Ranchi" cannot be recognised as a separate independent church. And hence all actions taken by and involvements as so called "North West G.E.L.Church, Ranchi" are unconstitutional, illegal and invalid. It has no identity of its own. The G.E.L. Church is inseparable.
- 6. The Ranchi Head Quarters Congregation is directly under control of the Pramukh Adhyaksh vide Constitution -Appendix-I(b). No Anchal has any right to interfere in the administration and management over Head Qrs. Congregation, Ranchi, because of its unique and symbolic feature.

All this happended due presumably to the fact that the Press Supdt made two strong conditions for printing and delivery of Panjikas to the Book-shep. The conditions were -

- (a) 50% advance was required by him while placting order
- (b) Delivery was to be made to us only after full payment.

Condition at (a) above has been fulfilled. Second condition will be fulfilled on receipt of 20,000 copies of Panjikas. So far we have received 12,940 copies.

Bille for Re 6,741.55 has been received and part payments made as under:

- (a) Rs 3,000.00 on 16 Dec 72 amount received from KSS
- (b) Rs 230.00 on 12 Jan 73 from COPH resources.

It is requested that Press Supdt may kindly be directed to supply the balance i.e. 7,060 copies at an early date so that we may meet the pressing demand of the customers.





8 FINANCIAL ARRANGEMENT WITH THE PRESS: The Press Superintendent informs the committee of the difficult situation in which Press finds itself, due to heavy expenditure in 1966 on publications which are now (for the greater part still) in the possession of the Publishing House. By those expenditures the working capital of the Press was seriously reduced yet no recompence was received from the P.H. A grant from the Gessner Missian bridges the gap only in part. In the Superintendent's opinion the P.H. still owes about 18.000 Rs to the Press.

The Chairman voices the views of the committee like this;

- (1) In the separation of the Press and P.H. the financial arrangement was clearly stated to be that the P.H. will owe nothing to the Press for the books published previously;
- (ii) the committee cannot and will not neglect the difficult situation of the Press but it is not able to remedy it.
- (111) through the chairman, the committee will recommend a request to the Gossner Missi
  -on that further grant be made to bridge the gap (this request should come
  from the Press Managing Committee).

## POINTS FOR MANAGING COMMITTEE MEETING - C C PH. 26 NOV 1971

- 1. Commissions allowed to Book Agents as under appears to be high -
  - (a) On COPH Publications 25%
  - (b) On outside publications 12%

    In view of the present financial position of the House, suggest that this should be reduced to :-
  - (a) On CCPH Publications 15% )
    (b) On Otherpublications 10% )
    from 1 Jan 1972.
- 2. T.A. and connected allowances to agents (fooding, Rickshaw fare, Rail reservation) should be regulated. Suggested that only one side rail/bus fare be given and all extra allowances discontinued from Jan 1972.
- 3. GCPH should be allowed to stock some of the stationary items (e.g. Exercise books, pens, pencils, rabbers, chalks and so on) for all High Schools and the schools should give their bulk (estimated) demand for one year so that provision could be made to stock their requirements.
