My Dear Sanad,

You know under what financial difficulties our church schools are helplessly fighting for survival. This is a matter which should be everybody's concern, since schools play a vital role in the life and mission of the church and also in the life of the community among which it lives. It has been my constant concern over the years and as such, I have tried to impress upon our people its significance and to remind them of our responsibilities. But to-day it seems to me that all my labours have been vain.

It is good that you head the education department of the SE Anchal. Therefore, I want you to share my concern that unless we mobilise the entire congregations causing them to realise that the maintenance of the schools is their responsibility, we are going to lose them for ever. Nothing would be more disastrous than to succumb to the temptation of handing over them to the Govt. To me, there should be no second thought, no alternative but to rehabilitate the schools and bring back that splendid tradition of initiative, self-support and robust faith on God for every little thing, which our forefathers courageously exhibited in such circumstances.


I would therefore beg you most earnestly to consider the following suggestions which may be of some help to you :-

1. The members of the congregation, all of them individually and collectively, re-dedicate themselves for the noble cause of education (also for other aims and activities of the church) which has changed the economic, social, cultural and spiritual pattern of their lives. This change has been for the better. This should be carried on for the further generation, and vigorously.
 2. Regular seminars for pastors and Catechists should be organised in order to re-orient them on the educational policy of the church. They should know how to mobilise the people for supporting the school.
 3. Regular seminar for school teachers (For Headmasters separate seminars can be held) They should be taught method of teaching, management and teacher-guardian co-operation.
 4. Expenditure on individual schools (salary, building, furniture) P. Fund) should invariably find place in the budgets of the Ilakas or synods, as case may be. (Minimal and inadequate Ilaka grants have no meaning) congregations should be relieved of directly supporting the schools. They should be taught to pay their contributions, subscriptions, donations etc to the Ilaka or Synod.
 5. Building of an Education fund or Trust at the Anchal level to be operated by a strong committee to be headed by an able man having wide powers.
 6. Payment of educational expenses on schools should be the joint responsibility of the Anchal through the Education Fund/Trust and the Synods.
 7. Regular inspection of schools through a system to be evolved.
- These are but a few suggestions which may be considered. It seems to me that a scheme cannot be successful unless it becomes the concern of the entire population. Therefore there should be mass participation in our undertaking like this.

I would be grateful to you and your Anchal if you find it possible and practicable to consider some of the points at least. I would be glad to have your reactions on it.
