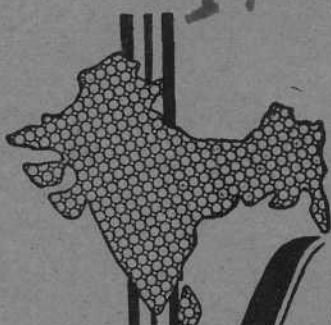

Many greetings to you and your family members.

I hope you are aware with the situations and developments of G.E.L.Church members of Delhi. There are about 60 G.E.L. Church members in Delhi. Besides that many of our Church members are scattered in surrounding area of Delhi. A centre of meeting for these members is the must for their spiritual and social needs. Presently they are going to Protestant Churches according to their convenience for their pastoral needs.

When Dr. M. Bage was the Pramukh of our Church there was an arrangement for the church members of Delhi, according to that they would be associate members of Free Church Parliament Street, and the Pastor of Free Church would do their shepherding. This was one of a best arrangement for our members. Later Dr. Nirmal Minz encouraged some of our members to worship separately and to keep an identity. Many members were convinced and started service in the Community Hall of R.K.Puram Sector II, New Delhi, while many remained attached with Free Church of Parliament Street and Free Church of Green Park, New Delhi. After sometime some members who were worshipping in the Community Hall of R.K.Puram mostly non-orsons started feeling that some hush hush is going on among some Oraon members of the Congregation and decisions are taking place in the closed door meetings. This Oraon group had the blessing of Dr. N.Minz. Now-Oraon members of that Congregation later separated themselves from the Dr. Minz group. Later this separated group and the members who were worshipping in Free CHURCH-ES decided to worship together in the Free Church Parliament street. In the meantime we had the detailed talk with the Pastor of Free Church P.St. Rev.Salim Sharif. He told us that all of us are welcomed to remain in the Free Church as associate members. He will give us all possible help, ^{and} give us pastoral services. He also allowed us to conduct the Hindi Service of Free Church in our own Church Service procedure, sing songs from Shakhshivani e.t.c. He also told us to give Sermon in Hindi by our senior church members, besides that whenever our Church leaders and Pastors from Ranchi would come to Delhi are welcomed to preach in our Church Service. We became much happy to this agreement and accordingly we started Church Service in our Church Procedure in Free Church P.Street from 26.10.80. And now our Sunday average

gathering has gone up to 50. During X'mas our gathering was around 100. There was an X'mas gathering on 28.12.80 of our Church members and our children were given X'mas presents. These Services are also attended by some local Christians of Delhi but everything is conducted and managed by the G.E.L. Church members. The followers of Dr. Minz are still worshipping in the Community Hall of R.K. Puram but so far I know their number has dwindled .

During his visit to New Delhi on 31.10.80 we had submitted a memorandum to Dr. Grothaus where we had requested to give a consideration to have a house or a plot at New Delhi which would serve as a centre for the G.E.L. Church members of Delhi. We are enclosing the copy of memorandum. Besides this Delhi being the Capital and centre of so many national and international activities, our centre would serve various purposes including giving shelter to the visiting Pastors and members. I feel this thought has been given an active consideration by Pastor Kriebel and Dr. Grothaus. So I request that when they visit Ranchi in next March they may kindly be given a suitable impression so that our move becomes materialised.

There is also a need to post a Pastor in New Delhi , he can function as resident Pastor who could fulfill the Pastoral needs of our people of Delhi and the surrounding area. This Church congregation may not be attached with North West Anchal of our Church but should be looked after by the Headquarter of our Church.

May the Lord help you and our Church in all respect.

We the children of Gossner Evangelical Lutheran Church in Chotanagpur and Assam, Ranchi, forming as an essembly of the said Church in Delhi have the priviledge to see the Chairman, his family and team belonging to our beloved Mission in Berlin and to offer our gratitude and thanks on this very auspicious occasion in Delhi today the 31st October 1980. We welcome you in our midst in precious name of our Lord Jesus the Saviour of the world.

By courtsey of this appraisal, we beg to lay down a few lines of appeal to the honourable Chairman as hereunder :-

that our city Delhi, the Capital of India and an International place famous for world politics and religion as well, acknowledge the dominion of the following churches over its vast christian population:-

1. Roman Catholic Church
2. Methodist Church
3. Wesleyan Church
4. Baptist Church
5. Seventh Day Adventists Church
6. Yehowah Witnesses
7. Church of England
8. Pentecostal Church
9. Mar Thoma Syrian Church
10. Delhi Evangelical Lutheran Church (one of the Churches of United Evangelical Lutheran Church in India).

say why the Gossner Mission has limited herself for long within Hindi speaking population of "GELC in Chotanagpur and Assam, Ranchi"(India) only.

Further to say that the Gossner Church in India has been facing a great hardship for years due to divisions among the Church, organisers, leaders, elders, pastors, evangelists and even the common men who have been led to involvement in many court cases and local differences. Among other reasons vast majority of our people live on utmost poor economic conditions. As for the above reasons and while our pastors and evangelists live on charity, there is a shortage in pastoral and evangelistic arrangements for us and for many in the country sides as well as in far cities in India.

At this juncture, our families nearing about 60 in numbers and the defence personels around hundreds in Delhi who originally belong to our mother church have no alternative but to form an assembly only and have to associate ourselves with different local protestant churches for our spiritual needs.

In view of the above circumstances, we, therefore, have the privilege to highlight our sordid demand before the Chairman of our Gossner Mission as hereunder:-

"Because we have no adequate financial accumulation and so is the case in this respect with our mother church in Ranchi, we request you kindly to arrange a means which will enable us to acquire a piece of land or ^a building in this capital city Delhi. This will besides our worship place, be a place for our occasional get to gether place of culture, a visiting place of Lutherans on world travels, an office of international link and above all, a place of learning for children of the age and the generation to come."

With this great hope and aspiration, our foldedhand request as above may very kindly be acceded to and a line of expeditious reply to this will be highly appreciated,

Extract from the Minutes of the Anchal Samiti meeting held at Khorhatoly, Old Hazaribagh Road, Ranchi on the 28th. September, 1977.

" Item XI Financial Matters : The following decisions were made regarding collection of funds .

1. All the Sirnis which are collected and used by the Ilakas should remain with the Ilakas as before.

2. The following Sirnis and Chandas should be collected by the Ilakas and sent as directed below under each item :

i. Mandli Paisa : The Mandli Paisa should be collected at the rate of one rupee per confirmed member. The whole amount of collection should be sent to the Anchal Treasurer, preferably quarterly, in the months of January, April, July and October. 25% of the collection of Mandli Paisa will be sent by the Anchal Treasurer to the Treasurer of the K.S.S. and will keep 75% of it in the Anchal Treasury.

ii. Prabhuprit Offering : Prabhuprit Dan (Offering) is a freewill offering according one's free wish. It is to be collected from each family once a year, preferably during the harvest season for the farmers, and in the month of April for others. The whole amount of collection of the Prabhuprit Chanda should be sent to the Treasurer of the Anchal Sabha for the expenses of the Anchal.

iii. Atam-palan Chanda should be collected and the whole amount should be sent to the Anchal Treasurer who will send the entire amount to the Treasurer of the K.S.S. for the Central Funds of the Church.

v. Christmas Collection : All the collection raised in the Christmas Service of the 25th. December should be sent to the Anchal Treasurer. This will be used by the Anchal Treasurer for Anchal expenses. If Christmas (25th. December) will happen to be a Sunday then all the collection of Sirni and other offerings of that Sunday will be sent to the Anchal Treasurer for the Anchal.

vi. Mission Parb : This is to celebrate the coming of the first missionaries to Ranchi. The whole amount of the collection of this festival should be sent to the Anchal Treasurer who will send it to the K.S.S. Treasurer. The whole amount will be for the expenses of the K.S.S.

vii. Bank Account : Resolved that a Savings Bank Account be opened in the name of the North Western Anchal of the G.E.L. Church in Chotanagpur and Assam with the Central Bank of India, Lalpur, Ranchi.

It was further Resolved that the account be operated jointly by the Treasurer Shree Paulus Topno and the Adhyaksh Rev. Dr. J.J.P. Tiga. "

Dear Rev. Toppo,

It was not good, that you received the Evg. Grant for the month of Feb. 1975 and went back without meeting me, and thus the grant could not be entered in Anchal Cash Book. Last month also you did the same. Thus you are following wrong practice. Therefore please note that the Bill for the month of March will not be forwarded to the Director, if you fail to bring the Chalang for entry in the Anchal Cash Book. In future, please do not draw the grant from KSS Treasury without my permission. Proper procedure must be followed for good account keeping.

I had to give you envelopes for distribution to every family to collect Atam Palan Pratigyat Dan on Palmarum Sunday, but that also could not be done for you went back without meeting me. However, I shall arrange to send it by post, but it will not be possible to use on the Palmarum Sunday. You will please fix any suitable Sunday for the same for Surguja Mission Field, preferably of Pentecost Sunday.

You are the convenor of the sub-committee on Khuria Mission Field, but till now you have not taken any action to convene the meeting of the said committee.
