- 5. The Cash receipt have not been issued on the actual date of transaction as it reveals from the receipt book that receipt for June '73 has been issued after the receipts of July '73.
- 6. You have made refund of Rs.10,000/- to Shri V.P.Bhatia Punjab Sweet as a refund of advance made to shop No.1,2 and 5 vide Cash receipt No.4402, 4404 and 4407 of Rs.1000/- each. The excess of refund of Rs.7000/- bas not yet been clarified.

Church Printing Press which is not the recognised office of RCP. This will be confirmed by the RCP Office staff.

For good works relevant papers should be always available for correct answer.

A copy of the suspension order is missing perhaps to be made ready later on.

I hope my reply will fully satisfy you.


