Dear Brothers and Sisters of West Germany,
We the Christians of Harser, Dhurwa Heavy Engineering Corporation
colony let extend our greetings to you all, in the name of our
Lord Jesus Christ.

Today we are very happy and lucky to find you all in our midst
under this tent, after your long journey. We thank our Lord that
He has brought you all with sound health in our midst by His lov-
ing and gracious hands.

Therefore we welcome you all and want let you know the situation
of this congregation. The Harser Dhurwa congregation is under the
North Western Anchal of G.E.L. church. This congregation is situat-
ted in the Industrial belt of Heavy Engineering Corporation.
About 13 kilometers west a village named 'Hetha Kotha' where four
brothers accepted Christ from Oraon community in 1850 and about
5 kilometers west a village named 'Balalong and Bantya' two bro-
thers accepted Christ as Saviors from Munda Community in 1851 .

This happened by our first Missionaries and both places became the
historical place in our G.E.L. Church-History. Now in the H.E.C.
colony we are sixty one families and all together three hundred
and sixteen bonafide, G.E.L.C. members are living in this congrega-
tion under the pastoral care of Rev. S. Mohan M.G. One church buil-
ding was constructed by us in the village Harser in 1970, by the
help of our Gessner Mission of West Germany. There we were using
our church services very nicely up to 1977, but in the same year
some of our church leaders created a division as styled of N.W.G.
L. church and hence we are forced to stop our church services in
the said church building. From that time onwards we are doing our
church service at the residence of Dr. Mrs. Marandi at Dhurwa, and
at the residence of Dr. S. Minz of sector side.

Nowa days we are facing difficulties for church building and our
congregation is waiting for the peaceful settlement to maintain
unity and peace in our church.

In your letter of 11.8.1972 you did inform us that in your estimation additional expenditures for linguistic studies of the couple Rev. and Mrs. Hecker would no more occur. Therefore we actually had not expected a request to meet additional expenditures.

The rate of exchange according to the figures which to us were quoted by the Bank here was 38 Pfg. for 1 Rupie. In May we had transferred to your account for 5.610 Rupies the amount of 2.805,-- DM. According to your letter of 11.8.72 you received through this transaction the amount of 6.668,63 Rupies.

Dear Mr. Bhengra!

As it was agreed with our church in Germany, I finished now the Second year course at the Missionary Language School at Mussoorie with the Second year examination; the oral part had to be taken in Mussoorie itself at August 14th 1973 and the written part has been sent to me to Ranchi, where I wrote five papers from August 28th - 30th. My wife did not take part in the examination. I am giving a list of the costs, which I would like you to forward again to Rev. Beck in Karlsruhe. The costs were slightly more than I expected, because of the railway loco-staff strike, so that I had to fly from Ranchi to Delhi and on the way back I had to go via Calcutta, because the trains between Patna and Ranchi were not yet running again. In Bareilly I had a stop on the way to see the Library of the Theological College, in order to be able to reorganise ours along the same lines.

Dear Mr. Bhengra!

You can see from this letter, that we are back safely again to Ranchi. I have submitted herewith the costs we had this time with the language studies. The Travel expenses have become quite high. We wanted to return by train, but there was absolutely no reservation to get from Mussoorie, so we had to fly, which brought the costs up considerably. Anyhow, our costs were actually much higher, for we had to pay Rs. 55/- daily for our family at the guest house, which is definitely higher than our living here in Ranchi and after all, in Germany the travel costs for an ordinary railway journey of this distance would have been at least as expensive as a flight here. So it will be not so extraordinary for German people as if really is here in India.

I have enclosed the receipts for Language School and room rent in Mussoorie. The travel costs will be known to you. Partly we had to submit the tickets at the railway stations. If you should require any more bills or receipts for the travel, please let me know. We would be grateful, if you could forward this soon to our church, for we actually have had these costs already.

3. If payment is not made in full on or before the due date including arrears, if any, a surcharge according to current Tariff will be claimed on all categories of service.
4. If the bill is not paid by the due date, the service is liable to be disconnected, on the expiry of 7 days after a notice of disconnection has been mailed to the consumer under certificate of posting.
5. Inclusion of past arrears in the bill does not extend the time of payment of the arrear or for disconnection or in any other way invalidate a prior notice for disconnection.
6. Non receipt of bill shall not be taken as a ground for delay in payment, or exemption from payment of surcharge.
7. In case of any objection, payment should be made in full & the complaint lodged thereafter within a week.
8. If a cheque is returned uncashed due to Bank objection the bill has to be paid in cash along with surcharge within a week failing which the service is liable to penalties as provided in Rules and Acts.
9. If and when a meter is reported/ found defective a bill on the basis of last three months average consumption will be raised. Security deposit in respect of meter is *Non-Transferable*.
10. Collection of bill amount will be received on working days in Upper Bazar, Doranda and Lalpur Branch Offices from 8 A. M to 1 P. M. and in Main Office (at) Main Road from 10 A. M. to 3 P. M. except on Saturdays. Saturdays the Branch Offices are closed at 12 noon and Main Office at 1 P. M.




