

To The Headmaster Khutitoli U.P. School

Dear Headmaster,

I, two days ago I sent the D.B. Grant for June and the C.C. Grant for the same month to you by M.O. From the D.B. Grant I cut Rs, 10/12/- Miss Sujan Toppo's June Salary and sent it to her. By a mistake I cut only 10% instead of 15%. Please enter her June salary into the Staff's pay book.

2. Mrs. Bakhla is allowed to further go on with teaching for a temporary time in the School for an allowance of Rs. 6/-/- a month without cut. But she is expected to do a full teachers duty and ^{I expect} that the School will not suffer by the fact that she is a mother with a large family and the Headteacher's wife.

3. If you draw your attention to the income of Forms IV you find that in January it was only Rs. 6/-/-

in February	"	7/-/-
in March	"	3/4/-
in April	"	14/-/-
in May	"	1/-/-
in June	"	15/-/-

that is so extremely less that I do not understand how you are collecting the fees and how managing the Boarding. In January and February when others have a boarding fee income of Rs. 50 upward that of yours is Rs. 6 and 7. How is that possible if the management is regular and right? If you add the sums and search for the average income you find that every Boarder has not yet paid even Rs. 2/-/- You should care for the income of Boarding fee in the beginning and during the whole year and not only on its end.

In the next monthses i hope you can show ~~other~~ quite different sums in the income side.


Dear Shantiprakash Babu,

With reference to your letter No. 83Kh dated the 27th instant I beg to inform you that the general rule of the Council is that school teachers be paid by the following sources :-

- 1, School fees or subscriptions,
- 2, Govt grant,
- 3, Teachers' house rent which is at 10 %
- 4, Ilaka contribution which is composed of teachers' 5 % contribution plus the equivalent amount of the Ilaka

The balance will be paid by the Church Council. Please then collect the school subscriptions from your pupils and pay your contribution and house rent. If it is done regularly then all the deficit is paid by the Church Council.

members I have not attended any meeting
since a long time. This school is improving
itself day by day. The pastor owing to the
personal grudge reported you falsely.

He is apt to do this. He is himself against me. The matter goes in this way. In January when I met you in Ranchi you told me about this report. In February he prepared one petition addressing to the Ilaka. He made some or all the pracharakas to sign in the petition. He threatened one of the pracharakas saying if you do not give your signature here then you will be dismissed or suspended. He was afraid. He gave his signature against his will in that petition which was against me. This sort of Bible teaching goes on by the pastor and the pracharakas. This sort of work goes on every now and then. He always presses people to do against me. This is only done to disqualify me. You may have written me in what things I have disobeyed the Ilaka authorities. Anyone person is not the Ilaka. It is only to win your kind personal favour. I do not want to say much about this or the Rev. D. Lorenz. You will know things afterwards. I am working here for the improvement of this school according to the instructions given by you and the government officers. There should be a special and direct supervision of the headmaster for the improvement of this school not the pastors. If there is no direct supervision of the headmaster in the school and boarding, then there is no improvement. This pastor wants to take the direct and complete responsibilities of the school and boarding to spoil it.

1. Regarding the salary for June of Miss Pagan Joppo. That there is the total collection of Rs 55/61—only for June. So the salary disbursed proportionately will fall Rs 9/- only for her. i.e. you have sent Rs 11/12/- extra for her. But note that this school had to pay her some more money. In this way the matter is clear now. She got less money from me. Please don't bother in this matter.
2. Regarding the appointment of my wife as a teacher I never want that my wife should work here under me. This is done only that the work may not suffer by such coming and going of Lady teachers as is the case here. She is doing her duties as others would have done or more than they did because she is an experienced hand. So please never think otherwise in this matter. There were some mistresses here who left this school early or late were rather careless and unfaithful so I am crying for outside workers.
3. Regarding the collection of B.F. + S.F. which are not irregular and are the cause of less salary. It is so but I am afraid to write you that the people of this side never care to pay fees regularly. If they are strictly treated they then need there leave the school for good. Parents and guardians as well as the pupils are not eager to get education. They are not willing to give any price for the education. Further they make excuses we will pay the dues at the end of the year but not now. Some pay but some never pay.

I beg to say that there has not been allotted one day's holiday on the occasion of the Aseeh day. It will be observed by cutting one day from the local holidays.

The collection of the subscriptions is not regular.

Further I beg to say as it is in vogue in the other schools that the holidays if left unenjoyed during the last year 1939, may be included in the summer vacation especially the holidays on occasion of the visit of officers or local holidays.

This much is the sum and substance of this school matter, hope you will be quite known by these things.
