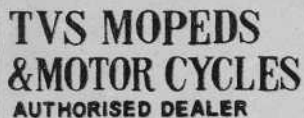



Your letter referred to above has been received in our office.

In reply to the same I hereby state as follows :—

You have raised certain matters as regards the provisions of our constitution. The well known principle is that before a person makes criticism of others, he should see whether he is above any criticism. You have accused me of acting against the provisions of the constitution, but you have yourself failed to abide by the provisions of the same. The letter and the allegations made therein themselves are unconstitutional. The letter is not signed by yourself, Up-Adhyaksh and the Treasurer. The same is only signed by the Secretary. The letter does not indicate that the Secretary sent the letter at your instance or by the approval of the Anchal Samiti. Whether the entire matters raised in the letter were placed in the Anchal Samiti for approval, if not, then you have acted against the constitution. It may be presumed that the decision of putting allegations against me is in the individual capacity of the secretary and not of the Anchal Sabha or Samiti.

In this regard I want to draw your attention to Art. 15 (3) of the constitution. In the letter as it appears some decisions have been taken, but it is not clear that the same were taken by the Anchal Samiti and reported to the Anchal Sabha for confir-

mation within a fortnight. Now you yourself think whether the Secretary or the office bearers moved constitutionally, what would be the legal effect of such decisions and how far the same would be binding upon us. As a matter of fact such unconstitutional methods of putting allegations and throwing mud sliggings should under the circumstances be totally ignored. The letter, and the contents therefore are unconstitutional. You are a responsible office bearer of the church and being Head of an important Anchal of the church and are fully conversant with the provisions of the constitution, We never expect of you to move unconstitutionally. May we request that such thing may not be repeated in future.

You fully know the provisions of Art. 19, At first the up Pramukh has to be elected from among the Anchal Adhyaksh then the election or appointments of Secretary and Treasurer is to be held or made. After the election in the Anchals a meeting was called on 1-11-87 (at that time the Election Tribunal has not decided the dispute of Orrissa Anchal) for formation of K.S.S. and election of Up-Pramukh and appointment of Secretary and Treasurer. But unfortunately except Rev. S. K. Jojo, Adhyaksh Orrissa Anchal, all Anchal Adhyakshs including yourself were absent. Had all the members including the Anchal Adhyakshs been present on that date the K.S.S. with the office bearers would have been duly constituted. It is for you to judge at whose fault the K. S. S. could not be formed on 1-11-'87. The church has been Put into litigation by Rev. N. Ekka only on the ground that in absence of the Adhyaksh of N. W. Anchal, the entire formation of the then K. S. S. and the election of the then office bearers were null and void. Though we have won the case in the lower and appellate courts, the same is pending in the High Court. The other example of the litigation on this point was initiated at the instance of Phulchand Panna. You are aware of all these facts.

The church has tasted the brunts. Do you want that the church would again be put in litigation for the formation of K.S.S. and election of office bearers in absence of Anchal Adhyakshs. For the latches on the part of some Anchal Adhyakshs, including yourself neither the K. S. S. could be formed nor the election of office bearers could be held. In the mean time the Election Tribunal declared the election of Orissa Anchal as illegal and void. In absence of the representation of Orissa Anchal and N. W. Anchal, the provisions of Art. 19, cannot be implemented. As per provisions of the said Article, I am the legal and constitutional Head of the Church and also the Chairman of K. S. S. by virtue of office and also the Spiritual Head of the Church (Art. 4-Part II (6-c) + 6 (b) ). There is no provision as to how the administration of the church would function in absence of K. S. S. As such being the chairman, Spiritual



Head and Pramukh Adhyaksh of the church all the powers are vested in me and I am the only person at present to look after the church affairs and its administration. I am not doing anything illegally, but all my actions are for the best interest of the institution. The use of the word "US" everywhere means the institution and is used in plural sense. The actions are taken by the institution. The use of the word "US" is correct and not used in individual capacity. Every action and decision is on behalf of the institution. There is nothing wrong in using the word "US".

As regards the allegations made in your letter they are baseless and unfounded. The Election Tribunal held the election of Orissa Anchal illegal and void. The fact is known to you also. As per election rules appendix I, Election rule 7, an elected person can act till his election is not set aside. The election of Orissa Anchal was declared null and void on 12.11.87 and since then Rev. S. K. Jojo ceased to be the legally elected Adhyaksh of Orissa Anchal. On behalf of the church, Orissa Anchal, was directed to hold fresh election as per direction of Election Tribunal within two months and in the mean time the office bearers were permitted to do the normal and ordinary duties as care taker office bearers till "Fresh election". The date for fresh election was fixed on 14-15 December 1987. The treasurer of Orissa Anchal requested to extend the date, which was however extended to 14-15 January, 1988, but unfortunately the Orissa Anchal deliberately and intentionally failed to hold the election. These facts are within your knowledge. Thus all the constitutional actions have been taken and direction of Election Tribunal has been implemented. The care taker power was given to office bearers of Orissa Anchal not in my individual capacity and by the decision of any meeting, but as chairman of the K. S. S. (having all the power of K. S. S. vested in me in its absence) and hence as chairman I with-drew the said power. In such action no illegality has been committed, the office bearers had no legal right of office after the decision of the Election Tribunal. In spite of the knowledge of every fact your allegations are regrettable and painful. As regards the use of the word 'US' the same has been explained above. As chairman of K. S. S. I had or have no intention to Blackmail the office bearers of Orissa Anchal in any manner. This allegation is purely imaginary. On the other hand it seems and is apparent that the letter has been circulated largely with malafide designs and ill motives to defame me and to lower me down in the eye of the followers of the church and public at large.

I am not acting as a Dictator, but according to the provisions of the constitution of the church. In absence of the formation of the K. S. S. for the reasons stated above, who will do the administrative works? Is there any provision in the constitution?

Naturally in the eye of general law and equity the chairman of the K. S. S. (Art. 4 - Part II 6 (c) ) is solely responsible and has legal powers and authority of administration in absence of formation of K. S. S. Every decision and action shall be legally deemed and meant as decision of the K. S. S. Moreover, the chairman has also the power of superseding any Anchal and take over its administration under certain circumstances (Art. 21-II functions b (iii) ) I as chairman of K. S. S. have not set aside any or all provisions of constitution, on the other hand it is being fully abided by me in my official capacity.

The facts stated in para 11 of your letter is nothing but a blasphemy against me. I have no selfish motives at all. I am Pramukh Adhyaksh for a limited period only. I have to look after the institution with its best interest in view and mind.

(a) Why K. S. S. has not been formed is well known to you. On 1. 11. '87 the Anchal representatives were not present. Except Rev. S K. Jojo all Adhyakshs including yourself were absent, hence the K. S. S. could not be formed. Who are to be blamed for the same? After the decision of election of Orissa Anchal was declared null and void there was none to represent it. The election of N. W. Anchal is also in dispute. The Orissa Anchal inspite of directions did not hold fresh election. Rather the matter has been taken to court of law. In absence of representatives from two Anchals, you yourself can imagine, how the K. S. S. would be formed. On this point we have been put in litigation by Rev. N. Ekka and Phulchand Panna previously. Do you mean that similar situation may again arise if any Anchal or any member of the church takes the matter to the court of law challenging the election of K. S. S' and office bearers?

(b)+c) The stand taken by you cuts and turnover all your grievances, you admit there by that in absence of K. S. S., the work would be done; with the consultations of the Adhyaksha. Is there any such provision in the constitution? According to you I as chairman can work with the consultation of council of Adhyaksha. That means that till the formation K. S. S. I can work under certain conditions. This admission of yours brush aside all the pleas of K. S. S. taken in your letter.

(d) Yes, like Korah, Dathan and Abiram of Number 16, you had opted for an unconstitutional K. S. S. of three Anchals, and of course, a committee was formed in an informal meeting, but unfortunately uptill now no reports has yet been submitted by it as regards the possible ways and means to form the K. S. S., but still

you are throwing mud slinging against me. There is no provision in election rules to review or reexamine the decision of Orissa Anchal. This decision is final and conclusive. Knowing the provisions fully, you want me and other members to act against the constitution and bye-laws giving grounds for future litigation. You yourself as such want to act against the constitution. Thus you can imagine yourself how far you abide by the constitution to suit your purposes. As regards issue of letter dated, 2.8.88 to Orissa Anchal the matter has been explained above. I never wanted to avoid formation of K. S. S., I as chairman wanted the election of Orissa Anchal to take place for the same, but it was not held. Who is responsible for the same? Duly constituted Committee in an informal meeting uptill now has not submitted any report nor sent any advice, they should be held responsible for the same and should be blamed for it and not myself. I am neither a king nor a Dictator nor for God sake I want to be the same. For the fault of others such as persons should not be made against me. The same are not only highly objectionable, but also regrettable. I take exception to those as they are for the sole purpose of blackmailing me.

12. (a) The purpose of Election Tribunal is limited. The disputes of Orissa Anchal and N. W. Anchal were before it. The decisions have already been passed. Nothing was pending before it, hence its dissolution was legal and according to election rules. If there be any election dispute in future, election tribunal can be again constituted.

(b) The term of Board of Property is for three years (Art. 22 (2) composition). The term of Secretary of the Board expired on the completion of 3 years. The boards are to be constituted afresh by the K. S. S., but as the K. S. S. has not been formed, the Board of property could not be constituted. The term of P. Topno expired. The power of attorney was given by Ex. Parmukh Adhyaksh on the advice of K. S. S. The old K. S. S. has been dissolved. The new Pramukh Adhyaksh has taken charge of office. The body which had given, power of attorney, being no longer in office and having no authority at all, the power of attorney to Sri P. Topno, is automatically revoked under law. The attorney ceased to have any power. There was no necessity of registered revocation of the power of attorney, but for the sake of precaution the power of attorney was revoked by registered deed. No illegality has been committed. After the dissolution of the old K. S. S. and the expiration of the term of Sr. P. Topno, he was and could not be an attorney at all and act as such.

(c) The aspersions against me are baseless. It has already been stated above that I am not working in my individual capacity but as chairman of K. S. S. Every



lease is signed by the Pramukh Adhyaksh or the Secretary of Board of Property, if power is given to him. In absence of K. S. S. I as chairman is responsible for the managements of the properties. As there is no K. S. S. I as chairman has to do all legal acts. This matter has been explained above elaborately. You can come and see how the property of the church has been expanded and added with new constructions income has been augmented. All persons are appreciating the same. I have done everything honestly and keeping in view the best interest of the institution. Our followers and you should be proud of improvements instead of making unnecessary criticisms and mud sling.

13. (a) Rev. S. K. Jojo instead of holding election should not have knocked the doors of court of law. Chances were given to him for the same, but having no right of his office, he rushed to court at his own peril. He should not have done so. This is another example of a case in court of law. Experiencing all the above facts you want me to act against the constitution and opening doors for various litigations, which I am unable to do.

14. You should not blame our advocate. He has given his advice according to the provisions of constitution. I request you not to drag him in our matters. Except legal works entrusted to him he has no interest in our internal matters, the advocate cannot be my saviour and Lord. I know and believe in one Lord. You also went to your advocate in this matter. Is he your saviour?

15. You have misquoted Ezekiel 34. If not you are one of the sheep in the Gossner church under me. Then why do you dare revolt against your shepherd by circulating an unconstitutional letter in and out of Gossner church? How could you referred to Ezekiel 34 : 1 + 2 when you have stopped all your contributions to the central office of the Gossner church? Did the Holy Spirit guide you to write to me? How many hours did you spend in prayers before deciding to defame me?

You are also a shepherd of the biggest. Anchal of the Gossner Church, please do not misguide and mislead the innocent sheep of the church. Why do you look at the speck of sawdust in your brother's eye and pay no attentions to your own eye? How can you say to your brother, 'let me take, the speck out of your eye, 'when all the time there is a plank in your own eye'? (M. 7 : 3 + 4)

As regards your advice, please think over the matter many times and if accepted complications and consequences for the reasons stated above would arise.



(i) Would it be constitutional to allow Rev. S. K. Jojo whose election has been set aside ? He is not now legally elected Adhyaksh. He has no constitutional right to hold office of Adhyaksh. Did he not flouted the directions for fresh election ? He was allowed only to work as care taker Adhyaksh till fresh election was held. Is there any provisions, for nominated Adhyaksh ? Will it not creates a precedent in future ? Can other Adhyaksh if their election is set aside not claim such nominations on this example or ground or precedent. Will you please advice Rev. S. K. Jojo to hold fresh election and got elected if members so like ?

(ii) Is there any K. S. S. at all when two Anchals are unrepresented ? Would it be advisable to form K. S. S. with representatives of 3 Anchals and H. C. Congregation ? Can such formation of K. S. S. would be legal and within the four corner of constitution ? Can the unrepresented Anchals not challenge the formation of K. S. S. against constitution ? As Rev. S. K. Jojo filed the suit, similary any member of church can challenge the K. S. S. in court of law. Who can take the guarantee in this matter.

(iii) By General law of the country Election Tribunals are formed before election or soon after the election. It is not a permant body. As soon as the election matters and election cases are disposed of the election Tribunal is dissolved. We have followed the same principle in our election rules. Before the dates of election of K. S. S. and executive committee the Election Tribunal can be again constituted. There is no such bar in this regard.

(iv) The power of attorney given by ex-body has already been dissolved, naturally the power of attorney is revoked under the provisions of Power of Attorney Act. If a giver of power of attorney is dead the power of attorney itself ceases and the actions of Attorney on the basis of such power of attorney would be illegal, unlawfull, null void and not binding upon any body. The same principle is also applicable with Sr. P. Topno. Moreever, Sri Topno was secretary for 3 years, and that period has also expired. After that new Board has to be constituted. The old Board is defunct. Under the circumstances would it not be against the constitution and general law to allow Sri P. Topno as holder of power of attorney ?

In the last may I say that all your advice are themselves unconstitutional. Please with cool mind think over the matter again and again inconsonnance with the provisions of constitution.

You have blamed me with malafide designs and ill motives and with the intention to defame me by putting all baseless and unfounded allegations of acting against constitution, but you yourself without following the constitution ask me to act in such manners which are strange and foreign to our constitution.

Now it is for you to judge whether we should proceed constitutionally or according to the advice not contained in the constitution. Please also note the election disputes of Assam Anchal already given to you.

I would request you that we all should proceed in such manner so that the prestige, image and high qualities of our church affairs may become an example to others and whole world at large.

# गोस्सनर एवंजेलिकल लूथरन कलीसिया के भाइयों एवं बहनों के नाम में पत्रिका

प्रिय भाइयों/बहनों ।

यीशुसहाय ।

उड़ीसा अंचल सम्बन्धित चुनाव एवं अन्य विषयों पर कुछ गलत फहमियाँ उठायी गयी हैं एवं फैलायी जा रही हैं। अतः कलीसिया के सभी सदस्यों की वस्तुस्थिति की जानकारी करा देना तथा सभी बिन्दुओं पर प्रकाश डालना जरूरी हो गया ।

यह सर्वविदित है कि नया चुनाव उड़ीसा एवं अन्य अंचलों का लगभग १३-१०-८७ को हुआ । पाद्री जोजो ने बिना अंचल सभा या समिति द्वारा पुष्टिकरण या अनुमति या सहमति से विरमित्रापुर पेरिश के हजारों सदस्यों को बहिष्कार कर दिये ( excommunication ) एवं चुनाव में भाग लेने से भी वंचित कर दिये । चुनाव के पहले एवं समय विरमित्रापुर के सदस्यों द्वारा उठाये गये आपत्तियों, दोषारोपणों एवं योग्यता सम्बन्धित आरोपों को भी चुनाव अधिकारी अनदेखी करके और बिना छान बिन किये चुनाव करवा दिये ।

श्री इलियास लकड़ा ने अवैधानिक चुनाव के विरुद्ध १६-१०-८७ को चुनाव आयोग के समक्ष चुनाव अवैध घोषित करने के लिये चुनाव याचिका दाखिल किये । चुनाव आयोग के निर्देशानुसार दिनांक २६-१०-८७ को डाक एवं तार द्वारा भूतपूर्व प्रमुख अध्यक्ष पाद्री जोजो को चुनाव सम्बन्धित कागजातों एवं कार्यवाही बहिषों को लेकर आयोग के समक्ष उपस्थित होने की सूचना दी । परन्तु वे उपस्थित नहीं हुए । चुनाव आयोग ने दिनांक १२-११-८७ को उड़ीसा अंचल के चुनाव को अवैध घोषित कर दिया तथा नया चुनाव कराने का आदेश दिया ।

इसकी सूचना पाद्री जोजो को दी गई । उससे १४-१२ दिसम्बर १९८७ को चुनाव कराने का आग्रह किया गया । उड़ीसा अंचल के कुछ अधिकारियों ने चुनाव तिथि बढ़ाने का आग्रह किया । अतः उन्हें आदेश दिया गया कि १५-२५ जनवरी १९८८ तक अवश्य अंचल का चुनाव सम्पन्न करा लें । प्रमुख अध्यक्ष जो पूर्णरूपेण केन्द्रीय सलाहकारी सभा/समिति के अधिकारों का संचालन कर रहे हैं, उड़ीसा अंचल के पदाधिकारियों का नया चुनाव होने तक सामान्य कार्य ( Routine Work ) करने का इजाजत दी । इसके बावजूद भी पाद्री जोजो चुनाव नहीं कराये । इस बीच उनकी गतिविधियाँ अवैधानिक, कलीसिया के कार्यकलापों एवं हितों के विरुद्ध रहा । अतः सभी पदाधिकारियों को दिये गये कार्यभार अधिकारों को दिनांक २-८-८८ के पत्र द्वारा वापस लेलिया गया । इस प्रकार पाद्री जोजो न तो निर्वाचित और न तो कार्यवाहक अंचल अध्यक्ष २-८-८८ से रहें । २-८-८८ से यथास्थिति उस अंचल का यही है ।

पाद्री जोजो को नियमावली के नियमों एवं चुनाव आयोग के आदेशों को पालन अवश्य करना था एवं कलीसिया के सिद्धान्तों को मानना था, परन्तु वे ऐसा नहीं कर के मुकदमा का सहारा लिया । उन्होंने सुन्दरगढ़ दिवानी अदालत में टाईटल सूट न० २१ सन् १९८८ द्वारा अपने को अंचल अध्यक्ष पद पर बने रहने का और चुनाव आयोग के फैसला को रद्द करने का



दिनांक १६-८-८८ को मुकदमा दायर कर दिये और प्रमुख अध्यक्ष एवं चुनाव आयोग के सदस्य, और इलियस लकड़ा को पार्टी बनाये। साथ-साथ मिसलेनियस (विविध) केश न० ७ सन् १६८८ भी दायर किये। उसमें उन्होंने टाईटल सूट २१ सन् १६८८ के अन्तिम फैसला तक अंचल अध्यक्ष पद पर रहनेका तथा प्रमुख अध्यक्ष एवं चुनाव आयोग को किसी प्रकार से हस्तक्षेप न करने के लिए टेम्पोररी इन्जक्शन की प्रार्थना की। इस मुद्दे पर २३-६-८८, १२-१०-८८ और ७-११-८८ को सुन्दरगढ़ अदालत में दोनों पक्ष द्वारा बहस हुआ। अदालत ने अपना फैसला दिनांक ७-११-८८ के द्वारा पाद्री जोजो के टेम्पोररी इन्जक्शन की प्रार्थना को अस्वीकार (खारिज) कर दिया एवं १६-८-८८ (मुकदमा) दायर करने की तिथि के दिन की यथास्थिति कायम रखने का आदेश दिया।

जैसा उपर कहा जा चुका है कि २-८-८८ से पाद्री जोजो किसी भी प्रकार से अंचल अध्यक्ष नहीं हैं अतः वे १६-८-८८ को अंचल अध्यक्ष के पद पर नहीं थे। यह बात अदालत के फैसला के अनुसार यथास्थिति १६-८-८८ का भी है।

सभी कलीसिया बहुवों को सूचित किया जाता है कि अब उड़ीसा अंचल का देख-रेख, व्यवस्था एवं शासन अधिकार कलीसिया के नियमावली के अनुसार ही होगा।


