



Dear Council Member:

Happy New Year.

The new year however does not promise to be a happy one for the staff of CMC and Hospital unless you respected Councillors take your responsibility of guarding and guiding the spirit of CMC seriously.

We in CMC are going through a difficult sort of governance -autocracy, dictatorship and vindictiveness. Never has the institution been run by such a scheming, wheeling dealing dictator - sorry Director.

Please do not be carried away by his smooth and impressive talk 'supported by facts and figures'. Many ideas he is carrying out as the vision of the institution are really only his own ideas forced down people's throats. How else does one explain his way of coercing all the Director's office staff to part with their one month's salary towards the centenary project. Incidentally this centenary project concept is not popular with many categories of staff.

His new concept of administration, i.e. decentralisation of power, means to strip everyone else of whatever authority they may have in their positions and accumulate all power in his own office. Once he wove his way to the Director's post, he made sure to keep the previous Principal out of any administrative position and got himself a submissive and less knowledgeable person as Principal. The new Additional Vice Principal is his nominee also.

It is common knowledge that the office of the General Superintendent is a purely decorative post and is controlled wholly by the Director. The General Superintendent owes his very existence in Welcome Unit and Microbiology to him, and hence is totally unable to have a mind of his own. The officers in the General Administrative Service who were not agreeable to his ideas as Medical Superintendent have been exiled to posts of no responsibility or importance.

Deputy General Superintendents are appointed and dispensed with at will. It is rumoured that a newly appointed Wing Commander is to be made a Deputy General Superintendent, totally ignoring other senior staff members who are more eligible and suitable for such a post.

It seems an attempt is being made to systematically destroy the policy of promotion and appointment with respect to seniority and duration of service. Conniving staff will supercede others in promotion and position. The General Administrative Service changes are made partly with the help of his newly appointed Additional General Superintendent who till some time ago was just a contractor of dubious repute. Additionally, this contractor's feeble wife has been appointed as a guide in the private patient special facility as Receptionist/Patient Guide in preference to a young staff member's energetic wife. It is further rumoured that the Additional General



It was in October 1894 that the first School of Nursing was started for young Indian girls in Ludhiana and in Punjab State, and a few months later, in January 1895, the School of Medicine was started, again for young Christian girls in this part of Punjab State.

This letter is specifically to invite your institution to share in the joy of a unique event in the history of this Institution, the celebration of 100 years of service in medical, nursing and para-medical education.

To make arrangements for your local transportation, accommodation and return travel, a proforma is enclosed. Please fill this proforma and return it to this office by 23rd May, 1994.


