- Rt.Rev.S.Mohan M.G. pointed out that Rev.R.Toon was on medical leave and was asked not to participate in the Central Council Meeting. Rev.R.Toon also clarified his position. In view of the stand taken by the Bishop NED and Rev Toon in the Moderator decided to counsel both the honourable members. The crisis was resolved and both c tinued the meeting.
- over by the General Secretary and discussion began keeping in view of minute and the follow up reports presented earlied by the General Secretary.
- Decision was taken that bio-data from all concerned should reach the central council office on or before February 1999 and it be secrutinised by the office so that necessary steps can be taken in preparation of the Service Book records for permanent church workers. Progress on this matter be reported in next council meeting.
- The pension/P.F.Committee be requested to submitted the completed report by Dec 15, 1998 to the council for discussion.
- The house was informed about the failure of Unity and understanding joint church service scheduled to be held on August 16, 1998 in Rajgangpur. Both, so-called Sudhar Sangh and the South West Diocese met at Rajgangpur on August 3, 1998 but instead of talking on Unity and understanding, old issued were dug out thus due to failure of fruitful result, the unity and understanding joint service was cancelled.
- South West Diocese was placed before the house and accordingly it was resolved that the name of suspended Pastors belonging to so-called Sudhar Sangh will not be published in Panjika from 1999 and onwards. The house also authorised the South West Diocese to take futher appropriate action against the members/Pastors as it deemed fit. Aforesaid information may be circulated in all dioceses/CRC.

 College were placed. Matter was reviewed and discussed and
 the house resolved that Shri.Subodh Lakra be relieved with
 immediate effect and simultaneously Shri.S.K.I.Minz who is
 already a member of Governing Body was nominated as Secretary,
 Governing Body of Gossner College with immediate effect.
- O6.6 Acceptance of amended constitution of G.E.L.Church by I.G. of Registration, Bihar Patna remained pending as the office could not locate the documents pertaining to registration papers of 1921 of G.E.L.Church. The house felt that this work is to be done at any cost and with all seriousness. Nothing should come on the way. It must be accepted/approved. This should be taken up on priority basis.
- 06.7 The committee on Modification of Liturgy was requisted to finalise and place it before the next Central Council Meeting.
 - 06.8 While discussing the cereation of membership of so called NWGELC from UELCI, the letter of UELCI was also placed before the house. The members were critical on spirit of the letter written by Rev. Tikkey Bishop of so called NW GELC which was misleading and the letter of UELCI was quite : surprising although the UELCI was meditating the negotiation and each development and the stand and attitude of so-called NWGELC was known to the UELCI negotiators. Suggestions, opinions, displeasure were expressed by the members blaming the so called NWGELC and the spirit of UELCI letter. After a well meaning discussion the delegates participating in the triennial conference may sit together and all points be discussed and share the decisions/stands taken for the conference and no one should deviate from our stand/decision. It may be clearly stated that communal church has no place in the UELCI. We must not further allow that the sentiments of G.E.L.Church was must. Lobbying should be done effectively. Keeping in view of the UELCI's remarks in the prevous negotiation meetings and basing the constitution of the UELCI, presence and move of the so-called NWGELC should be strongly opposed. Pressure may be built and NWGELC is not allowed to sit. The members also did not appreciate naming of NELC as recommending neighouring church. It was urged that delegates to Triennial Conference should take this matter with all seriousness.

- O6.9 Atampalan Damn: With a view to monitoring the despatch and receipt of Atampalan daan in the centre, quarterly report to Bishops may be sent about the receipt of atampalan daan in the centre.
- Bethesda Primary Teachers' Education College has submitted the drawing for construction of two rooms as per the specification of NCTE. It was suggested that ex-students may be approached for financial support.
- As discussed in the past Board of Properties may initiate the discussion on sharing of the income of B.O.P (25%) by C.R.C. The finance committee may also attend in the negotiation/discussional meeting. Discussional meeting is scheduled to be held on Nov 21, 1998. It will be initiated by the Secretary Board of Properties.
 - As for as publishing and printing of the small catechism in Oriya and Assamese, expert may be requisitioned it necessary and the diocese board of worship was authorised to bo the needful. Bangla small catechism was published by Purulia pastorate earlier.

Similarly resolution regarding issue of power of attorney to general secretary, G.E.L.Church was considered and accepted by the house. It was resolved that general power of attorney be given to the general secretary.

These resolutions will go in amendment procedures.

In view of the difficulties experienced due to the use of words "Sub-Committee "in Article 15 sub clarase 4 the workds "Sub-committee "be replaced by "Diocesan Property Board ". This too will go in amendment procedure.

N.E.Diocese: M/F workers have been shifted to its Hqrs at Dering near Kaziranga National Park as M/F in

Karbi-Anglong has been declared established congregations. It has one congregation at Iara Juli, Arunachal Pradesh where a Dalfa catechist is required. The financial position of the diocese is not sound. Due to flood and ethnic violence the church activities are adversely affected. Diocese wanted that on Atampalan Daan progress on financial assistance to Theological College quarterly report be sent to Diocese by Cent: ral Council.

N.W.Diocese: Split in the church (presence of so called NWGELC) continues to adversely effect the spiritual (church) life as well as the financial aspect of the Diocese. Due to this pension and P.F. could not be centralise timely. In almost places the diocese has problems with so-called NW GELC as the latter has disputed on buildings and properties. The Bishop of are Diocese was sent by the Central Council to Germany from July 17 to August 12, 1998 to attend the Summer School. Surguja and Udaipur M/F have been declared established congregation: congregation but the diocese is finding problems to provide pastors for the self supported congregations.

S.E.Diocese: M/F activities from Nakti and Ranga-Mati a have been shifted to Bankura (WB), 'Goikera and Chandil (Singhbhum West), Due to retirement/volentary retirement at some problem they retire evangehits are trying to enforce their ministry. In Adamam evangehistic programme is carried out. Revival programmes are to be initiated to strengthen the spiritual life of congregations. The diocese is going through financial crisis. Church run schools continue to bace financial haddship as the government is irregular in paying the salary/subsidy. The management of properties is yet to be streamlined.

Diankel Project is supported by CASA.

S.W.Diocese: It continues to suffer due to split in the Diocese. Problem of marriage license is to be solved urgently. Small catechism is likely to be printed/publish shortly in Oriya Language. Various boards are yet to function effectively Development works have been initiated in Jadakudar and Jodabandh.

Madhya Diocese: Administration has been lined up with the diocesan elections held on Sept 7-8, 1998 and insa famous tallation of Bishop in the Madhya Diocese Rt. Bev. S. Kerketta was instulled as first Bishop of the Diocese. Now administration is to be strem lined. A number of schemes/programmes

It was suggested that Rev.Lucas Tete (retired/Ranchi) be requested to visit Khuntitoli for sacramential service. On geographical boundary process may be initiated by discussing with the concerned diocese.

CRC: There is need for spiritual revival More resources to be found out for developmental works. Boundary wall of grave yard has been emmpleted. From time to time members are returning from NWGELC to mother church.

Evangelistic and developmental work. Seminars trining, refresher course ete conducted from time to time. Five point programmes continued but follow up is required from Diocese/CRC. In HRDC complex women's Training workshop centre (WTWC) was inaugumated on Jan 26, 1998. Specific programmes for women are launched from time to time. Stress was given on publication, Literacy, Finandial support, proper function of board of evangelism and development. Supervisor of Evangelistic work fields to be encouraged.

Rev(Dr)R.Dang, Principal Gossner Theological College presented his report. It was accepted with thanks. Financial crisis remained the focal point payment is to be stream lined. College needed for 1) History of Christianity and 2) Christian Ministry and Communication, Rs.20000/- is to be paid to Registrar, Serampore College. It proposed i) For college's separate registration and ii) The students to be sponsored and financially supported by the concerned diocese.

Problems of G.T.C. and G.B.B.P.K, Govindpur were discussed eleborately. Every member was concerned about Theological Education. It was resolved that each pastor will annually donate Rs.100/- towards Theological Education Fund and encourage the laypersons to come forward to donate liberally to-ward the Theological Education Fund. All the members of the august house will annually contribute donate Rs.300/- towards the fund.

It was also resolved that besides submitting annual financial report/bugdet of the Gosmner Theological College, it will regularly submit its quarterly financial report to the central council. It will reflect amounts received through all the sources and the expenditure enabling. The cash

section of the Central Council to adjust the amounts to avoid dual payment.

It was clarified that when we speak about Theological Education or fund it imphies to both Gossner Theological College as well as the Gossner Bible and Buniyadi Prasikshan Kendra, Govindpur and the collection under Theological Education Fund will to both these institution.

The house was positive an the separate registration of Gossner Theological College. However about sponsoring of students from Diocese needs to be reconsidered as we have been requesting the congregational people to contribute towards

Theological Education Fund.

- Mahila Samity continued to work for the over all development of the church and its spiritual life. It has been participating by sending delegates to seminars/training programme. It had organised HIV/AIDS workshop on Oct 14 15, 1998. It organised annual meeting at Dibadih from Sept 29 to Oct 1, 1998. Women's Centre cum Adivasi Girls Hostel, Ranchi will be anaugurated on Nov 2, 1998. Stress was given for women ordination.
 - og.1 Central Youth Organisation has been trying to streamling its organisation activities. It had organised meeting-cum-seminar on Sept 29 Oct 1, 1998 but due to:various reasons response femained poor. Youths units of Diocese/CRC should respond positively to Central Youth Organisation.
 - 09.2 Mahila Sangh was requested to encourage the participants of HIV/AIDS to organise mini seminars in different place/occasion on the prevention of HIV/AIDS.
 - Donor agencies through H.C.D.I. sanction has been made for constanction of H.C.D.I. Hostel Building at Govindpur.

 Memorandum of agreement will be signed between the church and the donor agency H.C.D.I.

 - 10.2 Rt.Rev.C.S.R.Topno, Moderator and Rev.(Dr) C.K.P. Singh, Director HRDC during their visit, also visited LWF and discussed aspects pertaining to projects.

It was felt that projects should be precise and self explanatory to impress the donor agencies. The Diocese/CRC

were authorised to prepare projects independently and submit to us ULLCI and ULLCI will forward it to LWF.

- Rt.Rev.C.S.R.Topno, Moderator and Rev.Dr.C.K. 10.4 Paul Singh also enteracted with the Gossner Mission, Germany during their visit abread. Special reference was made about Rev.H.Borutta the last missionary to Chotanagpur. He died on 7-8-98 and was bur on Sept 29, 1998. Both Moderator and Rev.Singh and Mr.Hora Senan Horo, Rev.B.Krause also Mrs and Rev.N.Gagrai had attended the burial. Condolence prayer and condolence letter to be sent to Mr. Borutta and their doughtor and grand children was suggested and accepted.

Rev.D.Hecker expressed his willingness to offer his services for G.E.L.Church. It depended on the willingness to accept him by G.E.L. Church and the government's attitude to grant VISA to Rev. Hecker. If things were cleared he may join us by 2001. The house accepted and expressed its willingness; to accept Rev. Hecker and his wife. They will be accommodated in Gossner Theological College.
