
Dear Mr. Lakra,

I beg to lay the following facts before you all for your kind and favourable consideration
that I have a burning desire to take up the L. Th. Continuation Course of the Serampore University, the goal of which ends in obtaining the degree of Bachelor of Divinity.

There has been passed a rule in the University that henceforward i.e. from 1931, no candidate passing even L. Th. Course in the 2nd or 1st division will be allowed to take up the Continuation Course leading to the B.D. degree. I interpret this that it is the mercy of God for me that I am eligible for the above-mentioned Course.

May I be allowed Sirs, to interpret the same, also in this way that it is a mercy for my Church too? I believe, it will be a blessing if God wills.

I, therefore, humbly and earnestly request the Council that you would kindly permit me to take up the Course. I had forwarded an application to the Principal of the College. In its reply, he writes that they ~~need~~ a request of the President or of the Secretary of our Church by way of the approval of the Council. He advises me to prepare myself for the examination to appear privately, which I find very difficult because of some new and difficult subjects. And it is an obvious thing as how heavy a burden it is for a man having taken charge of a congregation. And I think, the sooner I finish up the Course the better for me.

Would you Sirs, therefore, permit me and grant me a scholarship of Rs 30/- p. m.? This act of your kindness I shall ever remember with sincere gratitude.

MARINE ENGINEERING.

New Delhi, the 24th January 1931.

No. 201-M.-II (12)/30.—The following Press Communiqué regarding the grant of three scholarships in 1931 tenable in England for the training of Indians in Marine Engineering and also the rules and conditions for the grant of these scholarships are published for general information:—

Press Communiqué.

Three State technical scholarships of the value of £240 per annum each (inclusive of a bonus of £40) tenable in England for the training of Indians in Marine Engineering will be awarded during the year 1931. The training in Marine Engineering consists of (i) workshop service (*i.e.*, practical training in the construction and erection of marine engines), and (ii) sea service. The total period of training will extend from six to seven years. Of this four to five years will be required to complete the training at such private firms of marine engineers as may be arranged by the High Commissioner for India. This period of workshop apprenticeship will be followed by training for 18 months at sea in a foreign-going ship, arrangements for which will also be made by the High Commissioner.

2. The scholarships will be awarded after a competitive examination which will be held at different centres in India on the 20th April 1931 and the following days. Rules and conditions for the grant of these scholarships and the rules for the competitive examination for the selection of candidates for the scholarships are being published in Part I of the *Gazette of India*, dated the 24th January 1931. Applications for entry to the examination must be made on the prescribed form copies of which can be obtained from the Secretary to the Government of India, Department of Commerce, and they must reach that Department on or before the 20th March 1931.

Rules and conditions for the grant of three scholarships in 1931 tenable in England for the training of Marine Engineers.

I. Candidates will be required to appear at an examination. The regulations prescribing the qualifications of candidates, the rules for the examination and the method of selection are detailed in Appendix II to these rules.

II. The selected candidates will be apprenticed for training at such private firm or firms of marine engineers as may be arranged by the High Commissioner for India. This apprenticeship will extend over a period of 4 to 5 years.

III. The period of apprenticeship will be followed by training for 18 months at sea in a foreign-going ship in order to enable the candidates to sit for the Second Class Engineers' Examination of the Board of Trade.

IV. The selected candidates will be required to observe the rules laid down by the Government of India or the High Commissioner (*vide* below).

Rules required to be observed by the scholar.

1. All Government scholars are required to avail themselves of the information and advice which the High Commissioner for India is in a position to give them, and to apply to the Education Department of the High Commissioner's Office for instructions as regards their studies and in any circumstances of difficulty, and in regard to any matter requiring the sanction of the High Commissioner or the Government of India.

2. Every scholar should, on reaching England, at once report himself to the Education Department of the Office of the High Commissioner for India in London, India House, Aldwych, W. C. 2. Accommodation for new arrivals is provided at 21 Cromwell Road, South Kensington, S. W. 7.

3. Every scholar must obey all instructions which he may receive from the Office of the High Commissioner.

4. Every scholar must from time to time, whenever the High Commissioner for India requires it, submit a certificate from the authority under whom he is working, showing that his conduct and progress have been satisfactory.

5. Every scholar must give a written undertaking that he will at once and without discussion of possible alternatives devote himself exclusively to the course of training laid down for him, comply with whatever instructions are given and do whatever work they may involve. Any scholar who neglects his studies, or tries to work for any other profession concurrently, will render himself liable to forfeiture of his scholarship.

6. Every scholar will be required to keep a concise diary of his work to be submitted to the High Commissioner for India at the dates laid down in the rules for the keeping of such diaries.

7. Subject to a due compliance with the above conditions, the scholar's allowance will be paid quarterly in advance by the Office of the High Commissioner. It will begin from the date of the scholar's reporting his arrival in England, and the High Commissioner will disburse it to the scholar in such instalments as convenience may dictate. Three months after the date of reporting arrival the amount to the ensuing official Quarter Day* will be paid and subsequent payments will be made in advance on or after each official Quarter Day.

* Note.—The official quarter days are the 1st January, the 1st April, the 1st July and the 1st October.

8. Every scholar is required to lodge with the High Commissioner in London, before his arrival in England, the sum of £40 for initial expenses. He will have no claim to payment of any instalment of his scholarship until this deposit has been made.

9. The necessary travelling expenses of scholars by second class or by third class if no second be available, will, if sanctioned, be defrayed by the High Commissioner. Applications for payment of these charges should be made to the High Commissioner. But charges for private tuition, unless specially sanctioned, for books, instruments, hotel bills and medical attendance must be paid by the scholar himself.

10. No claim can be admitted for the payment of any expenditure unless the scholar has obtained *previous* sanction from the High Commissioner.

11. The allowance will be at the rate of £200 a year *plus* a bonus of £40 a year and will be reduced or withdrawn while the scholar is being trained at sea on a foreign-going ship. Every scholar who, not being disabled by illness or prevented by any other cause which the High Commissioner may consider sufficient, fails to comply with the rules here set forth will forfeit his scholarship. It may be terminated at any time by the High Commissioner, if a scholar fails in health or conduct, in which case he will be provided at the discretion of the High Commissioner with a second class passage to India.

12. He must also execute a bond in the form appended (Appendix I) undertaking to pay a sum up to Rs. 20,000 if he fails to return to India when instructed to do so or if he settles in some other country within five years of the termination of his scholarship.

13. A free second class passage from the port of embarkation in India to England will be provided and the cost of the overland journey from Marseilles will in no circumstances be refunded to a scholar, unless he is expressly instructed by Government to travel overland and is provided with a steamer ticket to Marseilles only. In the latter event the High Commissioner for India will refund the rail and baggage expenses on the direct instructions of the Government of India.

14. The scholar should clearly understand that the grant of the scholarship does not entitle him on completion of his course to an appointment in Government service, but he should immediately on his return to India report his arrival to the Government of India.

1. An examination will be held on the 20th April 1931 and the following days simultaneously at the following places:—

2. *Qualifications.—A candidate*

- (a) must be not less than 15 or more than 17 years of age on the 1st of April 1931,
- (b) must be a British subject or a subject of a Ruling Prince in India, and born of parents domiciled in India;
- (c) must have passed one of the following examinations:—
 - (1) Matriculation of an Indian University;
 - (2) Cambridge School Certificate;
 - (3) School leaving certificate, including the Final Passing Out certificate of the I. M. M. Training Ship "Dufferin" recognised as equivalent to the Matriculation examination of an Indian University.

3. *Applications.—Applications for entry must be made on the prescribed form attached to these rules accompanied by the following certificates:—*

- (1) Birth certificate or other satisfactory evidence of age (a).
- (2) Certificate of good character from two respectable persons (other than relatives of the applicant).
- (3) Certificate of nationality.
- (4) A certificate to show that the candidate has passed one of the examinations specified in Regulation 2 above (a).

(a) Copies of these certificates and not the originals should be sent with the application. In the event of the applicant's selection he will be required to furnish at once the original certificates.

(5) Medical certificate of physical fitness to undergo the proposed course of study in England by a Government medical officer of the rank of a Civil Surgeon.

(6) Certificate from father or guardian that he is willing to send the candidate to the United Kingdom, if selected

Applications should reach the Commerce Department of the Government of India on or before the 20th March 1931 together with a treasury chalan for Rs. 20 representing the examination fee, which will not be refunded.

Candidates will be informed of the place and time of the examination and will be sent a pass which must be shown to the officer conducting the examination.

4. *Subjects of Educational Examination.—The subjects of the Examination, and the maximum number of marks obtainable in each subject, are as follows:—*

(1) Arithmetic	250
(2) Mathematics	300
(3) English	300
(4) History and Geography	250
(5) Science	300
(6) Drawing	100
Total	1,500

The *Syllabus* of the Examination is as follows:—

Mathematics.—Properties of angles, triangles, quadrilaterals, circles, loci, that is, the substance of Euclid's first three books treated in the manner of recent books on Geometry. The calculation of the areas of simple surfaces, and the volumes of simple solids, such as the cylinder, sphere, wedge, and cone. The use of instruments drawing to scale, and drawing of loci from simple data. Stress will be laid on skill and accuracy in the use of instruments. Solution of right-angled triangles by drawing and by the use of trigonometrical sines and tangents. Algebra up to and including graphs and quadratic equations with one unknown quantity.

The use of logarithms is allowed.

English includes Handwriting, Spelling, Composition and Literature. The test in Literature will consist of questions upon a book or books prescribed from time to time (b). The questions will require merely intelligent reading and not detailed study of the book. Handwriting and Spelling will be taken into account in the assignment of marks in English and other subjects, but for Handwriting a separate test will also be set.

For adequate proficiency in Handwriting full marks will be awarded, and greater proficiency will receive no further reward.

History.—Outlines of Indian History with special reference to India's place in the History of the British Empire.

(b) The book prescribed for 1931 is "Tanglewood Tales" by Nathaniel Hawthorne (Longmans, Green & Co.).

Geography.—With special reference to the British Empire. A knowledge of minute detail will not be looked for. Particular questions may involve both History and Geography.

Science.—The test will consist of elementary questions upon:—Practical methods of measuring length, area and volume. Quantity of matter in a body. Comparison of bodies by weighing. The use of the common balance and spring balance. Idea of Time, Experiments with pendulums. Measuring time: the clock. Ideas of force from common experience. Composition and resolution of forces in one plane. Ideas of work and energy. Principle of work as applied to simple machines: levers, blocks and tackle, etc. Mechanical advantage. Determination of density. Pressure of the air: the barometer. Effect of heat: the thermometer. Simple chemical and physical properties of com-

mon substances, such as air, water, chalk, lime, coal, salt, oxygen, nitrogen, hydrogen.

Drawing.—The examination will test one or more of the following:—Drawing of a simple object, memory drawing, elementary design in black and white.

5. Candidates must obtain such an aggregate of marks in the Examination as a whole as may indicate a competent amount of general proficiency.

6. *Result of Examination.*—Candidates will be informed by letter of the result of their examination, and a limited number of the most successful candidates will be called for interview by a Selection Committee which will make the final award of scholarships.

7. Selected candidates will be required to proceed to England in the month of June 1931,






Dear Sir,

In reply to your No. 288 of even date on the subject of deduction of salaries from the teachers of your school who were beneficiaries of the Church Council Scholarship Fund, I am to say that I do not know of any "authorisation from the teachers concerned." As to the Agreement "as agreed by the Council and the teacher", referred to in your letter, I can only say and refer you to the A.B. Minutes, Item 14 of October, 1924, which has materially changed or affected the terms of the original Contract and has never been opposed by these people all these years.





Sir,

In reply to your Nos: 1085 and 1086 received this morning I wish just to say that in the beginning the Advisory Board or the Church Council never went from door to door to invite applications for scholarship. It was simply an announcement and applications pured in. No body ever said that he would not apply because he did not get any notice of an offer. It was a public announcement and it had its effect.

Ignoration legis neminem excusat - ignorance of the law excuses nobody. It was not necessary to have fresh signatures in the Bond or Contract because the terms of the Original Contract were superceded by those of the subsequent Rulings and their signatures to the Old Contract or Agreement is an automatic endorsement to the revised Ruling, which was also a public announcement or Notification issued in the minutes and circulated.

It is very easy for any one to say that had he known that he would be required to repay he would not have taken the Scholarship. The Church Council or Advisory Board did not guarantee that every one would get employment in the Church or they did not know who was to work in the Church and inspite of this there had been so many students who came forward to accept the Scholarship loan. This shows that the students were eager to avail themselves of the offer whether they had to repay or

or not. Even to-day students would, if given loan, come forward to take it, but there is none to give.

If there be such a thing that some will have to repay and other would get money as gratis it would be an injustice on the part of a public body like our Church. An individual can give his own money away gratis but public money should not be spent iniquitously to show favour to some and disfavour to others. There must be fairness to all, and it is in this fairness that the Advisory Board in consultation with the Church Council revised the terms of the Agreement. Those who work in the Church are, as I have already pointed out, doubly benefitted. They got a loan without interest and also Church employment on good salary which an equally qualified man would get in other departments. For those who work in the Church there is not the slightest ground for murmuring or complain.

Please refer to the Advisory Board Minutes of Oct. 1924 Page 12 Item 14 (d) and you will find it says - "These rules are to take effect in June 1925". So we must realise that it has already gone into effect. Now it is over 5 years and nobody ever raised any objection or voice of protest against this Ruling. The protests come now when we begin to collect the money but it is too late, it is time barred.

I may point out that this subject was given a very thorough and careful consideration in 1924 and in recent years i.e. last year and this year too and the Church Council do not find any just ground to go back on what has been decided already and this for the sole benefit of the students.

A copy given to the past beneficiaries of the Notice which outlines also the object of organising a permanent Loan Fund is enclosed for reference in your Office.

In concluding, I wish again to say that under orders of the Church Council we can not stop collecting money until fresh orders cancelling the former one is issued. Please therefore collect the dues and inform the objectors accordingly.

With reference to the representation made by Mr. P. Dungdung, Headmaster of the Kinkel M.E. School, I wish to make it clear for him and for all concerned that the terms of the Original Contract or Agreement signed by many students was materially revised and changed by the A.B. in 1924. The aims and objects which prompted the Board to bring about this change have very clearly been set forth in the printed Notice of Realisation which has been sent to each former Scholarship holder.

It should be borne in mind by all former scholarship holders now in the service of the Church that the Advisory Board in revising the scheme has done a very good thing as it suggested the founding of an Endowment to which all should readily agree. Surely it would be an act of injustice on the part of the Church Council or the Advisory Board, if only those who work outside the Church were made to pay. In that case those who work in the Church are the most favoured and are doubly benefitted in that they received the Church aid gratis and also Church employment without having in mind the prospect and welfare of the future students.

I don't think the scholarship holders are wronged or unfairly treated and they should have no ground for complaint morally or legally. Their complaints, if any are now time barred, the new

new Rules taking effect from June, 1925 (vide A.B. Minutes of Oct. 1924). I am therefore not prepared to entertain any more representations on this subject. Please therefore deduct the amounts due from each person and send them clear receipts obtaining the same from the Treasurer.

16th May 1930, I have the honour to place before you
the following facts for your further consideration.

1. That as far as I can remember the bond I have signed do not conform to this notice.
2. That the money I took from the A. B. from the year 1923 was thought to be a scholarship rather than a loan.
3. That the last part of the para. 2, which says "With interest at 3 $\frac{1}{2}$ %" seems to be quite dangerous with that of the original bond signed by me. For, it was understood that I shall repay the full amount (even in instalments), if I am working outside the Mission field, and at the expiry of my College career when I have begun service anywhere, but without paying interest of the same.
4. That the phrase "are working in some capacity" in the third para. is not at all applicable in my case as I have not yet taken up service anywhere.
In such circumstances neither can I understand the notice, nor can I begin from June 1930, to repay the money I have taken from the A. B. as scholarship, even though I shall not have to pay the interest.

It is very sad that your letter regarding refund of the Scholarship money shows your unwillingness to pay it back. I should like to remind you that in the very beginning when the Scholarships were offered the A.B. or the Church Council did not advertise the offers at every door. Those who desired to avail themselves of the benefit applied for the Scholarships and stated to abide by the terms given in the Agreement.

Later on the A.B. and the Church Council revised the terms of offers, because they wanted that out of the money thus paid other students in the after generations may similarly be benefitted. If those who are employed in the Church ~~now~~ have not to return and repay the money, one should think they are the most favoured of fortune from the rest. In such case it should be the claim of every one to get employment in the Church to escape repayment.

The A.B. and the Council therefore revised their previous conditions or term of offer which they published in the A.B. minutes of October 29-30, 1924 Item 14 and later adopted them. Years have gone by since then and not a single person likely to be effected by these new Conditions ever made any protestation until now. The first and original terms of the Agreement now stand superseded by the revised ones and remain unchallenged.

It is a pity that you have even failed to see the way by which you can help your fellow brothers - a moral obligation on your part.

I should like to point out that if you fail to consent to the ordinary

RULES GOVERNING THE AWARD OF SCHOLARSHIPS, ETC.,
APPROVED BY THE CHURCH COUNCIL AND THE ADVISORY BOARD.

1. All candidates for scholarships shall be recommended to the Advisory Board by the Church Council.
2. Scholarships shall, as a rule, be awarded for twelve months in each collegiate year, usually beginning with the month of June.
3. As a rule scholarships will not be awarded to "plucked" students.
4. All holders of scholarships shall be required to execute in favour of the Advisory Board bonds promising to refund to the Board the amount of the scholarships enjoyed, provided they do not enter the service of the Gossner Lutheran Church.
5. It shall be the duty of the Secretary to the Church Council to have these bonds executed.
6. Scholarships shall ordinarily be paid one month in advance, but in case of necessity they may be paid up to four months in advance, on request from the Principals of the institutions in which the holders are reading.
7. Scholarships will not be awarded as a rule to those who already are enjoying scholarships from another source, but in case of real need small supplementary scholarships may be awarded to those who enjoy scholarships from other sources.
8. When scholarships are paid in advance the amount thus paid shall be deducted from the total amount due and the remainder shall be paid in the most convenient way.
9. All correspondence concerning scholarships should come to the Advisory Board through the Secretary to the Church Council.





making an inquiry into their parents' financial positions I have come to know that it will not be possible for the parents


