Bank operation of our S.B.A/c No.604, G.E.L. Church Fund;
with Central Bank of India, Ranchi Branch.

1. The KSS (Central body) of the G.E.L.Church in Chotanagpur & Assam, in its meeting held on 27-30th Oct.1973 has appointed Dr.C.K.Paul Singh as the Acting Pramukh Adhyaksh with the assignment of the total administration of the G.E.L.Church and resolved that all the Bank accounts including S.B.A/c No.604 with the Central Bank of India, Ranchi branch, will be operated jointly by Dr.C.K.Paul Singh Acting Pramukh Adhyaksh and Sri. Salan Bhengra, Head Accountant.
2. Unfortunately after some days in the month of Nov.1973 some persons have filed injunction suit (No.232/73) against the above decision. The result, the banks stopped payment since then.
3. On 2nd April 1974, the Court gave permission ^{to} Rev.Dr.Christ Kumar Paul Singh (defendent No.1) acting Pramukh Adhyaksh to operate the Bank accounts of the Gossner Church in Chotanagpur & Assam.
