CONSTRUCTION OF GOSSNER THEOLOGICAL COLLEGE NEW BUILDING IN THE G. E. L. CHURCH COMPOUND, RANCHI, BIHAR.

TERMS and conditions for the Supervisor/ Builder/ Engineer for the construction of the new College Building.

1. Money shall not be advanced ~~for~~ before starting the construction of the building.
  2. Building materials( bricks, stone, cement, steel, sand etc) shall be the entire responsibility of the Supervisor/ Builder/Engineer . However on application in part/1 full as funds available cost of cement and steel be made available. Payments for materials except cement and steel be made only after the completion ~~for~~ of the construction to the supervisor/builder/engineer.
  3. Accounts for materials be maintained properly and correctly with Principal/Secretary by the Supervisor/builder/engineer.
  4. The Supervisor/builder/engineer shall pay fine of Rs.100/-(one hundred) per day if he fails to finish the construction within the scheduled period (6-8, months).
  5. The supervisor/builder/engineer is able to complete the construction work within six(6) to eight(8) months from the date on which he is entrusted with the construction work.
  6. The supervisor/builder/engineer is prepared to accept payments for materials in part/ full as funds available without ~~for~~ interest.
  7. The Supervisor/builder/engineer is able to complete the construction work of the building with Rs.7,00,000.00(seven lacs) including full necessary furnitures, water system. electrical equipments etc etc.
- N. B. The detail of furnitures is to be supplied by the Principal/secretary.
- law/ 8. The supervisor/builder/engineer shall not go to the police or to the court against the department for the settlement of payments of bills etc., but he shall be prepared for amicable settlements. The S/B/E. forfeits his final payments if he violates this item.
9. Remuneration for the Supervisor/builder/engineer shall be amicably settled between the Principal, Building Committee and supervisor/builder/engineer as soon as the building construction is over. Final payments and remuneration shall be paid only after proper verification of construction including furnitures electric works etc. etc,

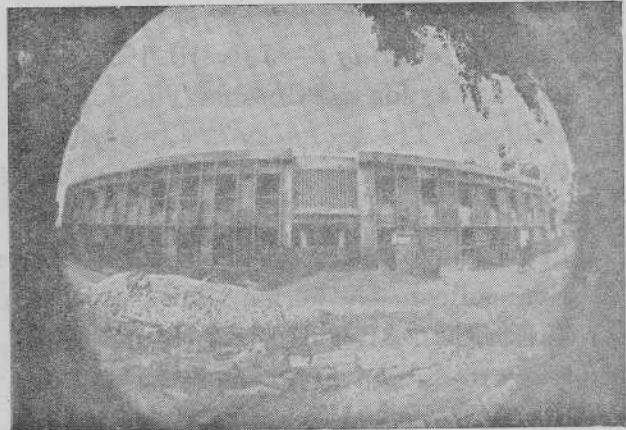
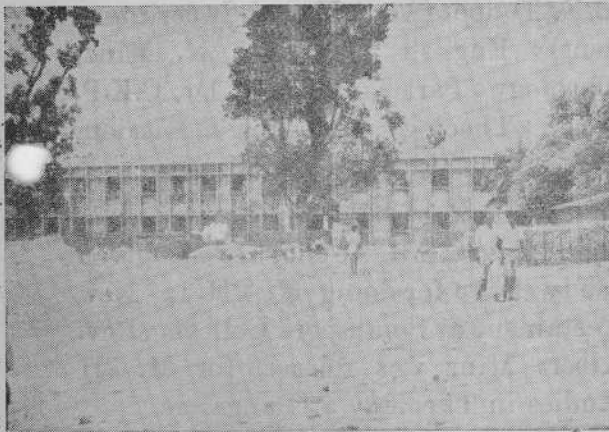

The College reopened with retreat from June 26-28/1975. **"The role of the Pastor in the Congregation"** was the main theme for the Retreat. It was divided into three Sub topics : A" The role of the Pastor in the city Congregation. B. The role of the Pastors in the Agricultural Congregation. C. The role of the Pastor in the mission field. These sub topics were discussed under the guidance of Fr. Deleta. St. Alberts' College, Ranchi, Fr. Munzs, Agriculture Training Centre Namkum, Ranchi. The Rev. Dr. C.K.P. Singh, Acting Pramukh Adhyaksh, G.E.L Church Ranchi. Daily Bible studies were conducted by the Rev. R. Dang, lecturer in Old Testament.

Note : Nos 2, 3, 5, 6. left the College after three months' Studies. They realised spiritually that they did not have calling for full time ministry in the Church. No. 9 was expelled due to misconduct No. 7 left College on his own accord.

*Inaugural Ceremony for the New College, building* :— July 10, 1975 was a great day for the Gossner Theological College. The foundation stone of the College building was laid down on 10.7.74 by the Rt. Rev. Bishop Nag, President of the Federation of the Evangelical Lutheran Church (now U.E.L.C.I). After one year the building was ready to be inaugurated on 10.7.1975, by the Acting Pramukh Adhyaksh, Rev. Dr. C.K.P. Singh. On that great day an ecumenical gathering was present to give thanks to God for his great work through this College. The College lived a nomadic life for 109 years. Through L.W.F. God gifted a permanent place to the College in this world.

A general report prepared and published by the staff and the students was released. All the members of the K.S.S. and the guests were invited for fellowship dinner.

*Teaching Staff Full Time* :— Rev. Martin Tete, ( Principal ) : Church History, Pastoralia, Biblical Knowledge.

Mr. A.M. Topno (Faculty Secretary) : Hindi, Rev. Dieter Hecker, (Librarian) : New Testament, Christian

Ethics, Biblical Knowledge, Music : Rev. Mrs Ursula Hecker (Student Advisor) : Greek & Christian Education : Rev. Albert Minz; Church History & New Testament, Rev. C.A.B. Tirkey, Religion : Rev. Royan Dang : (Registrar) : Old Testament : Cand B.K. Toppo, (Asst. Hostel Superintendent) : English : Rev. Dr. N. Minz; Theology : Part Time : Rev. Dr. C.K.P. Singh : Theology of Church & Mission, Mr. Justin Ekka : Indian Music.

*Members of the faculty on study leave*; Rev. C.S.R. Topno; He was given study leave for doing M. TH. in New Testament at Serampore College. Rev. Albert Minz was released for M. TH studies in Theology at Bangalore.

At the end of the academic year 1975-1976, Rev. Dieter Hecker and the Rev. Ursula Hecker left for Germany. During their service here they identified themselves with those whom they served. In addition to his teaching job Rev. Dieter Hecker helped in building up our library. Now our library is in a position to meet the need of a B.D. College. The Rev. Ursula Hecker served also as students advisor in Our College from 1974-76. Our students shall never forget her friendly and good advice. Paulus and Nirmal, the two sons of Dieter and Ursula, were active member, of our College family. Nirmal was born in our midst. He returned to Germany with Indian Name. Hope, that he will return for service in our midst.



Circumstances did not permit Dr. Arno Sames and family, successors of Heckers, to join us in December 1975. We hope and pray that they will be with us in near future.

The Salary scale of the workers in the College is not satisfactory. They will get more than double of this Scale if employed in a government or any other private firms. They are committed for the service of the Lord through this College. They are working for the Church and the Church has to think

for their better financial status. From March 1976 at the risk of Dr. Singh, pay scale has been raised.

*Scholarship for the Students :-*  
M.P.E.L.C. students were financed by their Church. The Church spent Rs. 100/- (One hundred rupees) per month, per student for boarding and

pocket money. The G.E.L.C. students received assistance from their Church. The Church spent Rs. 50/- per student per month. The monthly bill per student in the boarding is Rs. 65/-. The G.E.L.C. students themselves have to be responsible for extra expense of Rs. 25/- each per month. Miss Tirkey and Miss Topno were supported by Sister Ilse Martin. Miss Martin offered Rs. 160/- per month for these students for twelve month. One of our student, Mr. Binod Tirkey, was supported by K.N.H. Scholarship of Rs. 80/- (eighty) per month. A sum of Rs. 80/- per month per student is sufficient at present. The church could not give fund for maintenance.

The above statements show that the workers in the College are leading a sacrificial life for the church and the G.E.L.C. students, upon whom depend the future leadership, are trained to lead a life of poverty.

As far as the training of the pastor is concerned, the G.E.L. Church has never played a definite financial role. The Gossner Theological College at Ranchi and the Bible and Buniyadi Training School at Govindpur are financially foreign institutions. The G.E.L. Church has spent her strength and money for establishing and running secular institutions but she has not spent a penny for this College. The real test of financial autonomy has come. The workers in the College and

the students did not get their salary and stipend from December 1975 to February 1976. Request for financial assistance was made known to the Church. The church leaders instead of helping started finding faults with the College. The financial autonomy is one of the reasons which is responsible for driving almost all the highly qualified persons in Theology out from the Church service.

The College continues to be a College in the midst of financial threats. The lecturers do not loose their patience. The students are faithful in their studies. The university result for this academic year is Cent-per cent.

Mr. Xavier Francis James is doing B.D. at Serampore College. Rev. Hemant Hansda is to write his B.D. qualifying examination in 1977. The rest of our students have been employed in various parishes as assistants to Parish Pastors. Miss Shanti Juliani Tuti is the first lady to be graduated in Theology. She is one of the teachers of our Bible And Buniyadi Training School, Govindpur.

The members of the faculty were well informed of financial threats to the College and they could take the following steps :

1. To start an Endowment fund for the College. This is an emergency fund for the College. This account has been opened with the United Commercial Bank, Ranchi, which is jointly operated by the Principal and the Registrar.

2. The old class rooms have been rented to Gossner College of Science and we get some money to maintain the College, building.

3. Gossner Theological College has a hall in the centre of Ranchi city to accommodate about 500 people. The general public of the city used our hall on permission in this academic year. The first meeting was held by Chotanagpur Chambers of Commerce and The Chief minister of Bihar, Mr. Jaganath Mishra came as Chief guest on the occasion. The Second occasion was the drama staged under the

guidance of the Deputy Commissioner, Ranchi, for raising money for flood stricken people of Bihar. The College receives small revenue from those who use it.

4. Rooms for office purpose have been allotted to Lutheran World Service, William Carey Research Institute and the CISRS Ranchi, Branch.

*College Convocation April 7, 1976.*  
The Chief guest and the speaker for 1976 Convocation were Dr. C.K.P. Singh and Rev. Dr. N. Minz, respectively. The following prizes were awarded to the students :

A. Christian Theology : The donor for the prize is Dr. N. Minz in memory of his late parents Abraham and Parsadi. The recipients of the prize were Anil Kumar Mathew, Biswas Surin, Xavier Francis, George Thomas Biswas, Philimon Toppo.

B. The Rev. S.A.B. Lakra Prize for Church History :— The donor is Rev. S.A.B. Lakra, the former professor of Church History. The recipient of this prize was Mr. Xavier Francis.

C. Merkha Pump Prize for History Religions :— The donor is Rev. C.A.B. Tirkey in memory of his late mother Mrs. Merkha Pump Tirkey. The Recipients of this prize were Xavier Francis and George Thomas Biswas.

D. Prizes for Biblical Studies :—  
Donor : Rev. Dieter Hecker Recipients :—Xavier Francis & Anil Kumar Mathews.

Rev. D. Hecker and family were given farewel through the programme arranged by the Students Union.

## Life and Activities in the College

*Sunday Worship* :— Our students were actively involved in Sunday School and children service of the head quarter congregation. A few of them became members of the Sunday choir. Rev. Mrs. Ursula Hecker helped and guided the Students to run the Sunday School. Throughout the year on all Sundays G.E.L.C. local used compulsarily all the members of the staff for preaching good news. Rev. Albert Minz served as Pastor of Karkatta Parish near Ranchi.

*Summer Work* :— The M.P.E.L.C. students are always employed in their congregations as assistants to Pastors during summer. This arrangement helps them to come into contact with fields where they are to work in near future. The North west Anchal of the G.E.L.C. offered employments to all her Students during last Summer. The students had a very rich experience of the life of various congregations. The members of the staff were also invited to Bible classes programmed by the congregations.

*Monthly Prayer meetings* :— Programmes for the monthly prayer meetings were arranged by the students and Rev. Dieter Hecker made arrangements for film stripes.

*College Affiliation* :— Our college was provisionally affiliated with Serampore College since 1969 at B. TH. level. The main conditions for the confirmation of affiliation were building, library

etc. We fulfilled all the conditions and the senate of Serampore College confirmed our affiliation in February 1976. Now our College is a full fledged B. Th. College.

Dear Sir,

In the first place, let me express my appreciation and hearty thanks to the K.S.S. for implementing the new pay scale with effect from July 1975. But in this connection I would like to draw your attention on the following points.

- 1) At present I have been receiving the same scale as that of a M.A.B.D. But in the new pay scale I discovered that M.Th. is placed on equal level with B.A.B.D. This is certainly a degradation of and discredit to the M.Th. degree.

The pay scale is:

B.A., B.D./M.Th. ... 375-10-425-15-500-15-575

B.A.M.Th/M.A.B.D. ... 400-10-450-15-525-15-600.

In the above scale, in the first place, B.A.B.D. is regarded as equivalent to M.Th. and in the second place B.A.M.Th. as equivalent to M.A.B.D. The possible explanation as regards the former would be that one is B.A.B.D. and the other is only M.Th. But here it is quite obvious that M.Th. without B.D. or B.A. is quite unthinkable. So, to say that one is M.Th. necessarily implies that he is either B.D.M.Th. or B.A.M.Th. Thus in no case B.D.M.Th. is lower than either B.A.M.Th. or M.A.B.D. The above scale shows that B.D. is not recognised equivalent to B.A. What I would suggest is as follows :

B.A. B.D. ... 375-10-425-15-500-15-575.

B.A.M.Th/M.A.B.D./B.D.M.Th. ... 400-10-450-15-525-15-600.

- 2) I discovered that in the new pay scale there is no place for a man like Mr. Anand Masih Topno. In the bill of Theological College for July 1975 I found that the bill for Mr. Kiran Horo was Rs.258/- according to the new pay scale whereas for Mr. Anand Masih Topno it was only Rs.242/- and this was according to the existing scale as no provision is made for such cases in the new one. What an injustice it is when a L.D.C. with his matriculation gets a higher scale than a lecturer in the same institution with all his M.A.B.Ed.

Thank you very much for your kind letters of 26.12.74 of Nos. 449 and 451/74

regarding stipends and the additional teacher for the college (referring to the resolution of the officers of the KSS, as College faculty has decided, so far no letter from the faculty secretary has been received by me.

The subject has been dealt with by the officers of the KSS according to the actual financial condition of the Church. The decisions are thus not incorrect though not satisfactory to your goodself. The church at the centre cannot afford to give more than Rs 50/-; this amount is also possible only when the all parishes of the GELC can contribute at least Rs 100/- which is to be centralised latest by the end of Feb. 1975. The matter has been forwarded to the Anchal Adhyakshas to do the needful. If the amount are not centralised by the given time either the stipends have to be lessened or no new admission in 1975 to the GEC is possible. If all the Anchal would also centralise the 25 paise per head collection since 1975 there shall be abundance of money for the college also. You have already given the copies of your letter let us hope they will do the best for you. According to my personal opinion the stipends have to be given only for ten months (i.e. 60/-). Till now I am not quite sure and clear what is being done with the stipends of these two months, viz May and June. I will highly appreciate if the a/cs for late years can be provided as to what has been done with that amount. Here I would also like to see the financial statement of the College since it is wanting in the office.

According to the earlier position of the College staff there was no need of Genl B. Loppo, when Rev. G.B. Birkey rejoins the College from 1st Jan 75. At present it is also the same position in the College thus the decision of the KSS office is in line with the staff position of the College. The points raised by the staff faculty may be of importance but not relevant to the decision of the officers. If the matter is so important it should immediately be discussed in the College Council (and not only in the faculty) which is immediate and much responsible for the College. Further I would like to remind the fact that Rev. Dr. B. Minz has argued and claimed before the senate delegate to give full time for the GEC from 1st Jan 75 to fulfil the staff condition in the College for full recognition of the College.

May I at this point suggest that College council be convened at its earliest possible. It will be also good to appoint one of the members of the Building committee to operate the bank a/c "Building Fund" along with the Principal. I feel myself unable to have any hand in the business any longer.

All further information the decision of the officers as communicated remains valid.

Dear brothers,

To live the Gossner Church, she must have Theological Institutions. Church have two Institutions which all of you knew, namely the Gossner Bible and Buniyadi Prashikshan Kendra (G.B.&B.P.K) Govindpur and Gossner Theological College, (G.T.C) Ranchi. Both these Institutions are the life of the Church. No.(I) must exist to have trained Pracharaks and No.(II) to have trained Pastors. Due to financial difficulty, you all know, we have decided to stop admission of students in both the Institutions, but it is not the solution. This matter will be considered very seriously in the next Samiti meeting.

I would like to give you my proposal as "food for thought" to come prepared for the next Samiti meeting. As you know that we are sure to get Rs. 25000.00 from Berlin yearly as Bank interest for Theological Institutions, let us request the LWF to continue to give a subsidy of Rs. 35000.00, let us say for indefinite period. In this way we are to have Rs. 60000.00 only as sure money for the Institutions. But the Institutions have a budget of more than a lakh. So to adjust our selves with the above amount I have the following proposal:-







Dear Sir,

Thanks for your letter regarding the question of Principal's allowance. I think by this time you must have received explanation for the same from the Head Accountant, KSS. I have to add very little to it.

Since you are ignorant of the fact how this amount came in to being, I would like to explain the matter for your clarification.

The KSS passed a resolution at the end of '67 to raise the Principal's allowance to Rs. 100/- when the late Principal Surin and College authorities reported the K.S.S. that from the next session i.e. '68, the college would be raised to B.D. standard and actually some P.D. students were taken in. Had the college been raised to B.D. standard in '68, the Principal would have got an allowance of Rs. 100/-, though there was no provision made in the '68 Budget. Principal Surin had also claimed the said allowance when P.D. students were admitted, but after he was explained the matter he was satisfied. Budget is made one year ahead so in anticipation of a B.D. College the raised allowance was put in '69 budget.

Last year again the KSS was reported by the college authorities that now Serampur ~~will~~ would not allow B.D. Course to our college but instead L.Th. will be raised to B.Th. standard. Please mark the New Scale, where Principal's allowance has been made to Rs. 75 - for a B.Th. College.

In this connection I have to say that the KSS did not consider the allowance of the Heads of Pracharak Training & Tabita Bible schools as their status is not going to be changed.

Budget is a provision made for certain work, if the work is not fully implemented, it is not necessary to spend the budgeted amount.

I think this will clear the matter.

Please refer to KSS Chalan No 5200 Dt. 31-5-69. Your Bill in connection with Principal's Allowance has been reduced. You have been given Principal's Allowance only @ Rs. 50/- P.M. against your Bill which claimed Rs. 100/- P.M. for the period from January 69 to May 69.

I am sorry I could not give you in writ the reason why it has been ~~done~~ done so at the time of payment. I hope this letter will clear this matter now.

In the Budget 1969, there is, sure enough, a provision of Principal's Allowance @ Rs. 100/- P.M. from Jan 69 and henceforth. The Budget 1969 was prepared long ago and the said Allowance then was fixed with the expectation that the Lutheran Theological College would be raised to B.D. -standard by 1969.

Well, we know the college standard is still (May 69) the same as it has been. There is no question why the Principal's Allowance should not be given in the same old rate as was given before.

To claim money only on the ground that it has been budgeted looks wrong. Please be informed about the same.

1. In the Budget 1969 of GELC there is provision of Principal's Allow. @ Rs. 100/- PM. But, the Budget was prepared more than a year back, and the Principal's Allowance was raised to higher amount with the expectation that the Lutheran Theological College Ranchi would be raised up to B.D. standard by 1969.
2. The above College could not be raised upto B.D. standard uptill now, hence the question of giving Principal's Allowance according to the Budget does not arise.
3. As long as the College remains in the old standard the Principal's Allowance would not be changed unless and untill the KSS does not decide otherwise.
4. The provision in the Budget is not the ground of any claim.

Thank you for your letter of June 6, 1969 regarding our verbal agreement on temporary accommodation for Rev. C. Polson and his family. I endorse fully the first part of your letter, i.e., that ~~these~~ Polsons will stay in the other part of the Jubilee Bungalow till the required quarter will be ready for their accommodation.

Regarding the second part, I beg to say and request you to kindly find some more money or arrange to complete the renovation of the ~~xxx~~ proposed quarters with the available amount to make it livable. I had thought that I would be able to spare about Rs. 200.00 (Rupees two hundred) from the minor repair item of the current College Budget and draw it from the miscellaneous section, but to my disappointment I found today that during the present minor repair works I have over spent about Rs. 200.00 (Rupees two hundred). That is to say that the expenditure has gone up to Rs. 700.00 instead of Rs. 500.00 as expected estimation for the repair works. But the work which was begun had to be completed and so I took a risk in completing the work. This means that I will not be able to spend anything on the proposed quarter to be ready for Polsons. Kindly bear with me my limitations at this point.

Further may I say that the proposed quarter i.e., the quarter formerly occupied by the late Principal Surin must have the following most essential items of renovation in order to make it livable for a College Professor.

- (a) Ceiling construction
- (b) Partition of the big room into four small rooms with adequate door arrangements.
- (c) A back door through one of the four rooms after partition (this is not too essential, if possible it would be better to open a door, but not too urgent)
- (d) Renovation of the kitchen and store rooms in the back yard.
- (e) Rewiring according to room arrangements

I personally feel that Rs. 4000.00 as mentioned by you, for this purpose, would be sufficient to cover most of the above items of renovation. I hope that you would keep this in mind when you permit the builders to take over the work. I would like that the rooms be arranged as per plan of the College.

1. Preamble :- As per request of the Chairman of the Board of Theological Education Rev. Dr. C. K. Paul Singh, G. E. L. Church through his letter No. BTE/22/68 - Si. Dated October 19, 1968, the committee of the following persons, Mr. S. Bhengra Head Accountant of KSS. as Convener, took up the work of Audit and Completed. We found that the Expenditure in 'LIBRARY' and 'CONTIN-  
GECY' items is much more than the BUDGETTED amount provided for the  
year 1968.

### STIPEND.

The Voucher showing purchase of rice and dal for stocking purpose is not clear. It should be made in detail and above suspicion.

The Stipend payable to regular students has been totally drawn before the year end.

The Stipend of Private Students with the exception of Rantai student from Rewa Mission Field, has been received up to September 1968. The Stipend Rantai has been received up to February 1968 only.

### SPECIAL LIBRARY.

Without receiving any Grant a Sum of Rs. 2408.76 has been spent in purchase of Library Books. It is assumed that the money involved in this is stipend money.

### CONSTRUCTION WORK.

A sum of Rs. 400/- is shown being paid to Ranchi Improvement Trust. There is no receipt for that. We are informed that the above amount is paid as "SALAMI" to the Improvement Trust.

There are no proper VOUCHERS for the expense incurred in erecting five doors of 'Marriage Quarters' amounting to Rs. 325/- only.

Subject to foregoing explanations we are satisfied with the Accounts drawn up by us through FILES and NECESSARY INFORMATION.

Important :- Subject to the Audit the Balance to be in the hand on 30th September 1968 with Late Principal Saban Surin is as follows:

8. Suggetions :- In course of our Audit we found several irregularities in connection with BOOK-KEEPING of Theological College Ranchi account. In order to have a good account keeping, College should maintain regularly

- A Main Cash Book.
- Subsidiary Accounts Book of separate Expenditures with the corresponding Voucher Files.
- If possible "LEDGER" BOOK/BOOKS also be maintained. This will help preparing STATEMENT of the Accounts.
- All Income both from Gossner Church and Out side be entered in the Main Cash Book.
- It would be better if the expenses of Private students also were paid in to Theological College Ranchi through KSS. Treasury.
- A Bank Account in the name of Theological College should be opened for the sake of SAFTY.
- Principal should CHECK the Mess and other Accounts time to time, which are more or less handled by the students.

1. The opening prayer was led by Prof. J.J.P. Tiga.

2. Attendance :-

The following members were present :-

1. Prof. J.J.P. Tiga
2. Dr. M. Bage
3. Dr. C.P.K. Singh, B.T.E. Chairman
4. Rev. Junal Topno
5. Rev. S. Surin, Principal, Secretary College Council
6. Dr. T.C. Dell (Guest visitor)

3. In the absence of the Chairman Prof. J.J.P. Tiga was unanimously elected chairman for the day.

4. The minutes dated 12th May was read and confirmed.

5. Matters arising out of the last minutes :-

(a) Draft constitution of the B.D. College :- Resolved that the draft-committee with the addition of Dr. Singh be requested to place the draft-constitution before the next meeting.

(b) B.D. students :- The principal reported that two students have passed their B.D. Entrance Examination namely - Sri Anjor Kullu and Sri Bilkan Horo. Two P.D. students - Sri Nehemiah Topno and Rev. Innocent Aind could not pass the P.D. English papers to get admission for the B.D. Course. Resolved - Sri Anjor Kullu and Sri Bilkan Horo be admitted in the B.D. Course here in this college as external students of the Serampore College to be taught from this session 1968.

(c) Stipends :- (1) Since Anjor Kullu is a regular student he will get a stipend of Rs.70.00 p.m.

Tuition fee of Rs. 100/- p.a. will be paid by the college to Serampore till the affiliation is granted. Other fees of Rs.52.00 will be paid by the students.

(2) Bilkan Horo - Since Bilkan Horo is unable to attend the classes regularly he will appear at the Examination as an external candidate from Ranchi Centre. He will not get the stipend but his tuition fee of Rs.100/- p.a. will be paid by the college to Serampore till the affiliation is granted to Lutheran Theological College Ranchi up to B.D. level. He will also pay Rs.52.00 to Serampore.

(3) The application of Mrs. Parekhletta Minz :- The application of Mrs. P. Minz for admission to B.D. class was read and considered.

Resolved-(a) Mrs. P. Minz be admitted in the college for B.D. Course as a day-scholar.

(b) She will get a stipend of Rs.30/- p.m. The college will pay her tuition fee of Rs.100/- p.a. to Serampore College. She will pay Rs.52/- p.a. to Serampore.

6. Stipends for B.D. Day-Scholars:- It is resolved that B.D. Day-Scholar should be given a stipend of Rs.30/- p.m.

7. Stipend of Pius Topno :- Sri Pius Topno be invited and offered a seat for B.D. Course here in this college. That his scholarship be transferred from Gurukul to Ranchi, if he comes to this college.

8. B.D. affiliation :- The chairman read from the minutes of Serampore Senate dated Feb. 1968, item No. 18 was read which is as follows :-

Application for B.D. affiliation in Hindi, Lutheran Theological College Ranchi :-

The Registrar placed before the Senate an application from the Lutheran Theological College, Ranchi for affiliation at B.D. level in Hindi medium. After a full consideration of the matter the Senate took the following action :

Resolution XVIII -

- (a) Resolved to receive the application and refer it to the Executive for proper action in the light of the National Consultation to be held in April this year.

- (b) That the Executive be authorised to send a delegation if found necessary and to report at the next senate in 1969.

In this connection the Registrar's letter dated July 18, 1968 was read.

Resolved :- That the senate delegation be invited preferably in the last week of October 1968 and all the expenses be borne by the College Council.

9. Co-option of members from other churches from where we have students in the college :-

- (1) The incorporation of a clause to this effect be first considered as a part of the constitution and if accepted, step should be taken for such co-option.

- (2) It was further resolved that the heads of the churches and organisations from where we have students be invited to the meetings of the college council as consultants.

10. Staff :- (a) A Hindi Teacher :- B.D. class has been started therefore, action should be taken to invite application from candidates. Candidates must have passed M.A. in Hindi. Application should reach to the Principal up to 15th August 1968 positively.

The selection committee is asked to call for applications to interview the candidates and to recommend to the College Council the candidates selected.

- (b) One more teacher for the college :-

The need was felt that there should be one more teacher with theological qualifications.

It was resolved to request M.P.E.L.C. to depute a teacher for this college with atleast a B.D. Degree preferably one who has Master Degree in theology with pay.

- (c) Quarters :- The college needs immediately two quarters for two teachers mentioned above.

Therefore, resolved that the Pramukh Adhyaksha be requested to make the following arrangements in consultation with the authorities concerned -

- (1) That the quarter now occupied by Revd. Santosh Surin be allotted to the Hindi teacher and that Revd. Santosh Surin be shifted to some other suitable quarter.

- (2) That a portion of the Lal-Bangalow be allotted to a teacher invited from M.P.E.L.C. or some other sister church.

## II. Library :-

Resolved that Rs.5000/- be spent out of Rs.20,000/- for purchasing modern theological and other books published in India. Dr. T.V. Bell be authorised to write to the Gossner-Mission and to ask for this money in order that such book may be procured here in India. A copy of this resolution be sent to the B.T.E. and the K.S.S. for information.

12. Furniture :- The Principal reported that the present number of Almarihs are already full. We are in need of more almarihs in the library.

It was therefore, resolved to request the Gossner Mission to grant a sum of Rs.500/- for two more Almarihs to be purchased from the market.

Rs.400/- will be spent for two Almarihs and Rs.100/- for the repair of the doors of the new Almarihs already supplied by T.T.C. Phudi.

13. Assistant for librarian :- The librarian Dr. T.C. Dell expressed the need for some one to help him in the library on a full-time basis and he recommended Mrs. Merian Minz for this purpose.

It was therefore, resolved that Mrs. M. Minz be transferred from her present field of Practical work to our college library, which will be considered as her practical training untill Dec.'68. The matter be again considered at the end of this period. She should join with immediate effect.

14. Results of the L.Th. Examination :- The Principal reported that the following twelve out of thirteen students have passed the final L.Th. Examination. 5 students in the 2nd class and 7 students in the third class.

Alphius Baxla was referred in one paper.

It was resolved that the following three students Sri Albert Minz, Sri Sugar Kongari and Sri Royan Topno have passed in the L.Th. Examination in the 2nd class with 50% in English be invited from their practical training immediately to join the class for their P.D., two English papers and five B.D. paper. It was further resolved that Belas Lakra also be invited to join this class with immediate effect. All the four above students will be given stipend of Rs.60/- p.m. This arrangement will ensure atleast six students when the 2nd year B.D. class will be started in July 1968.

Note :- The three students namely Sri Albert Minz, Sugar Sagen Kongari and Sri Christ Saban Royan Topno will be sent for their practical training after their B.D. Course.

15. New admission of two girls :- The principal reported that the following two girls have been admitted to the L.Th.

class. These two girls are namely - Miss Promila Lugun and Miss Jolgina Lakre.

The budget of the college was consulted and it was found possible to keep these girls if the Budget is reshuffled without any further demand. The college Council approves the action of the principal.

16. Declaration of candidates :- The following three students, who are already working in the congregation for the last few years be recommended to the Pramuks Adhyaksha for declaration as candidates for Holy ministry. These three students are as follows :-

1. Suresh Toppo
2. Mansidh Toppo
3. Prabhudas Sunil Tirkey

17. Building Programme :- The building programme for the college for three years has been already finalised by the College Council and Pastor Seeberg has in principle agreed to this programme. But in order to get some help from other sources a building plan should be prepared and sent to the T.E.F. Principal S. Surin and Prof. J.J.P. Tiga should be authorised to prepare a plan.

18. Centenary of the Lutheran Theological College Ranchi :-

The Lutheran Seminary G.E.L. Church has been founded round about 1867 and first Pastor Paulus Nemo has been ordained in the year 1869. Thus the college is now 100 years old.

Resolved that the college centenary be celebrated in the college along with the Jubilee Celebration of the G.E.L.C. in Oct. 1969.

Programme should be chalked out in consultation with the Jubilee Committee and K.S.S.

19. Appointment of a Registrar :- The College Council feels that there should be a registrar for the college. His power and function should be defined in the constitution.

Further, the Draft-Committee is requested to include it in the draft.

20. (a) Pay scale of the G.E.L. Church :- It was pointed out by the faculty that the pay scale of workers of the G.E.L. Church has been always considered keeping in mind the salaries of the teachers of the Education Department of Bihar. Since there has been a radical change in which may be seen in the documents appended here to the salaries of teachers of non-government schools and colleges in Bihar. It is absolutely necessary that in the light of the pay scale of the employees of the G.E.L. Church be immediately revised and brought up-to-date.

(b) The teachers of the Theological Institutions :- In fixation of the salaries of the staff of theological college and the pracharak training school the cases of the ordained teachers have always been overlooked and their pay scales are much below those of the schools and colleges in the neighbourhood although in many cases the qualifications are higher than those in the non-government schools and colleges. The College Council recommends that the pay scale of the whole G.E.L. Church be revised and that the cases of the teachers of the theological institutions be carefully considered keeping in mind the salaries of their fellow - teachers and professors in the secular institutions inside and outside the G.E.L. Church.

21. Categorising the teachers of the Theological College :-  
Resolved that the teachers of the theological college Ranchi be categorised as teachers, Junior teachers, Lecturers, Professors and as heads of departments. The matter was postponed for the next meeting.
22. Bonds for students of the L.Th. College :- A form should be prepared by the Draft-Committee.
23. Next meeting :- The College Council will meet on the 25th August at 9.30 a.m. in the college premises.
24. The minutes will be confirmed by Dr. Singh, Prof. Tiga and Principal Surin, Secretary College Council.
25. Vote of thanks : The College Council expresses hearty thanks to Prof. Tiga for taking the chair in the meeting.
26. The meeting came to close with a prayer and benediction led by Dr. G.P.K. Singh Chairman, B.T.E.

Examination. Nor that the B.F.Course. (If,
