RESOLVED that FD A/C No.127197 dt.11.12.64 for Rs.10816/- be renewed in the same bank for one year. Sri Christ Anand Tirkey, Treasurer and Rev. Dr. Marsallan Bage, Pramukh Adhyaksh will jointly operate on this account.
- b. Opening of SB A/C in the State Bank of India, Ranchi Branch:  
RESOLVED that a SB A/c with the State Bank of India, Ranchi, Branch Ranchi be opened in the name of the G.E.L.Church and that the same be jointly operated by Sri Christ Anand Tirkey, Treasurer and Rev. Dr. Marsallan Bage, Pramukh Adhyaksh.

e. Outstanding loans and advances: As per statement various amounts have been drawn as loans and advances from the GELC treasury on different dates which are to be realised by administrative bodies concerned as shown in the statement.

(1) Loan of Rs.1325=00 against Gossner High School: Sri C.A.Tirkey and Sri C.K.Tirkey were appointed to inquire in to the above loan and advance and report to the KSS. After inquiry they reported that Rs.725/- loan was taken by the Principal, Gossner High School in the name of school and Rs.600/- in the name of Late Mr. J.Barla. Whereas the authorities of the Gossner School state that as per Inspection Note of an Inspecting Officer the Church has a loan of Rs.6,635/- payable to the school and whereas Rs.600/- is traceless, it is RESOLVED that the loan of Rs.1325/- be written off.

(2) Advance of Rs.900/- drawn by Late Miss K.C.Sokey: As regards the advance of Late Miss K.C.Sokey, it was made clear by Sri C.A. Tirkey and Sri C.K.Tirkey that she had a deposit of Rs. 592=57 in her Provident Fund account. Therefore RESOLVED that Rs.592=57 be recovered from her P.F.A/C and the rest be written off.

(3) Rev. Mansidh Topno's advance of Rs.200/- RESOLVED that Rev. M. Topno be reminded to submit T.A. bills through the SE Anchal for his transfer from Sindri to Govindpur immediately.

f. Budget Balance recoverable Rs292=50 : RESOLVED that the Budget balance recoverable amounting to Rs.292=50 be written off.

g. Affiliation fee of Rs.199=00 to LWF:  
It was reported that by the Treasurer that as per letter dt. Oct.20, 1965 from Mr. K.D.Benjamin, Treasurer FELCI, the LWF has increased affiliation fee of all member Churches. Accordingly the GELC has to contribute Rs.199=00 in addition to Rs.3228=00 previous amount of affiliation fee. Thus the GELC has now to contribute Rs.3427=00 from 1965.  
RESOLVED that the increased affiliation fee of Rs.199=00 be contributed to the LWF for 1965 from any amount of our Treasury.

## DEPARTMENT OF YOUTH WORK

## YOUTH WORK-GELC

REPORT BY  
Rev. C.G. Schmidt.

It gives me pleasure to be able to submit a report which speaks of progress and development. For some time I had felt that things were moving too slowly in my work here, but that complaint has gone, because 1965, especially since July, has been marked by much activity and progress, for which I am deeply thankful to God.

Let me now list the evidences of progress and development :

(1) THE CONSTITUTION : During the course of the year I was able, with help from Mr. H. Samadd and Rev. M. Tete, to formulate Constitutions for youth work on the GEL Church level, on Anchal level, and on local level. These Constitutions have been duly adopted by KSS Samiti, and in recent weeks they have also been translated in to Hindi. Together with notes and explanations they will appear in a special Youth Handbook (in Hindi), which is to appear at the beginning of next year. I believe that this book will prove a real help and blessing for all who are interested in youth work in our church.

(2) APPOINTMENT & MEETING OF YOUTH DEPTT: During the course of the year this Deptt. was appointed, and consists of the following persons:

Director : Rev. C.G. Schmidt.

This Deptt. has met twice. The first meeting took place on Saturday, August 14, and the second on Saturday, Oct 2, 1965. At both of these there was a 100% attendance of members, and all seem prepared to take an active interest in the work. This, of course, makes the Director very happy, and he looks forward to a future of happy co-operation.

(3) COMPLETION AND OPENING OF THE YOUTH CENTRE: The building on the Ranchi compd. which formerly housed the Chotanagpur Central Christian Co-operative Bank is now the GEL Church Youth Centre. After this building had been allocated as a Youth Centre it took quite sometime to finalise negotiations with the Liquidator, but finally at the end of May it became ours at a cost of Rs. 5,800=00. Then the work of alteration and renovation began, and the Youth Centre was dedicated on Sunday, August 15, before a congregation of approximately 1,000 persons. The Centre includes a main Hall, reading room, kitchen, store-room, guest-room, Director's office, one room possibly to be used for radio and recording work, caretaker's quarters, and bathrooms. The total cost, including price of building, is slightly over Rs. 20,000=00, of which Gossner Mission has donated Rs. 12,000=00 and LWF has suggested that the remainder be placed on the budget of the GELC for 1967. There are a few more things which must be done when the rains are completely finished, which may cost another Rs. 1,000=00 or so. At this meeting the Youth Deptt. passed a special resolution of thanks to KSS for making this building and land available for youth work.

(4) YOUTH LEADERSHIP TRAINING COURSE : from Oct 1-3, 1965 we conducted a Youth Leadership Training Course at the new Youth Centre, and reports suggest that this Course was very favourably received. The following number were present :

Church leaders: 5; Members Youth Deptt : 12; Delegates : SEA-8; NWA-II, Chandwa Mission field-I; Orissa Anchal-9, Khutitoly Synod-2; Visitors : Assam Anchal-1, Ranchi- appr 30-35. The Director's two main lectures were : "What is required of a Christian Youth Leader ?" and "Helps for Youth Leaders in Programme Planning".

The cost of such a Course makes it obvious that in future we shall have to have more and more of such Courses on a regional level.

(5) VISITS TO OTHER AREAS: Since April the Director was able to visit the following areas: Loyonkel, Takarma Synod (Church Jubilee); Chaibassa/Jamshedpur (special meetings including Rev. Ishida of LWF); Kinkel Synod Bible Camp at Baghdega; Takarma Synod Social work camp at Bano. I hope to make many such visits also in the future, especially in 1966, because it is an excellent opportunity to meet and speak to large groups of GEL Church young people.

(6) RANCHI PROGRAMME : Since the opening of the Youth Centre we have had regular programmes, including Bible Study, every Sunday morning from 9.30 to 11.30, and attendances have been around 75-80, mainly students, but not all. After my return from Australia we shall also introduce regular programmes during the week. Apart from this, there has been much office work, and weekly lectures on youth work to the students of the Theological College.

FINANCES : Up to now all finances for youth work in the GELC have been borne by Lutheran World Federation and Gossner Mission, except for two very pleasant exceptions : One young man and one young woman came to me and offered a donation of from their first salary for the Youth Centre. In one case the amount was almost Rs.400=00, in the other case it was Rs.50=00. Both of these young people do not want their names mentioned, but I am sure you will join with me in thanking them for this sacrifice.

Now that the youth work has been properly started and it is clear what can be and what should be done, the church, especially in the Anchals, will also be prepared to bear a portion of the cost, so that this may really become a GELC programme.

We have worked out the following budget for 1966, as the Youth Programme budget :

Or must we weaken this programme which has just begun ? You will realise that the above proposals do not affect the Director, who is fully supported by LWF, including his travelling expenses.

ALL-INDIA ASSEMBLY OF CHRISTIAN YOUTH AT JABALPORE December 28, 1965-January 2, 1966: For this conference GELC was offered 20 seats for delegates, and I strongly advised that we use this opportunity, and so the Youth Department has nominated 20 delegates. My wife and I also hope to attend, and there are several GELC young people attending under SCM and BCYU delegations, which means that a total of about 30 from our church shall be present. I shall be contacting Anchal leaders to help in payment of costs, but the greater part will be borne by a gift from Lutheran Youth in Australia. We think that attendance at this Conference will be a real blessing for youth work in our Church.

FULL TIME CO-WORKER : This meeting has before it the important task of appointing a full-time co-worker for youth work. I have many times given my advice on the subject, and now, being not present with you, I shall nevertheless be praying that God's wisdom and guidance may be with you, so that the right man is found for this important task. May God bless you all !

**3. FINANCE SECTION OF THE KSS:**

In the opinion of the Committee, the suggestions of the Financial Advisor in regard to the management of finance section is quite good.

**4. SALARIES AND WAGES IN THE CHURCH:**

No one can deny that the present salaries and wages in the Church is unsatisfactory. The KSS has already taken steps to survey the Church scale. Financial Advisor too is of opinion that salary scale be raised. He has also worked out a minimum standard for the scale.

RESOLVED that KSS should bring out a new salary scale. Further recommended that a sub-committee on scale be formed at this session to work on the scale and to bring out its report in the next Samiti for consideration and to be passed by the next full KSS for implementation.

**5. PRINTING PRESS:**

The Printing Press of the GEL Church is running on a business line. It is expected that its business should widen to fetch better income so as to help the Church finance.

I was very much pleased to find a resolution in the minutes of the KSS regarding administration of the KSS Office.

It was for a longer time that I have had the impression that efficient and prompt work done in the Gossner Church suffered from insufficiency of the office and that much dissatisfaction and complaints resulted from it.

I gathered from your resolution that you had the same impression. You, therefore, decided to change some of the positions to be held in the Kss office.

I like to make the following comments:


remember,

- a) As far as I am-concerned, the position of "Office Superintendent" is vacant at the moment. It is important that you will appoint for this post the most able and devoted layman to be found in the whole Gossner Church. For, he would have to
  1. relieve the President of the Church of much work and would have to take over many of the administration tasks. This should be stated in his official regulations. He should see all the mail addressed to the management of the G.E.L. Church, and he should be responsible for answering same in due time. He should also be in the position to draft important letters.
  2. have the supervision over all the co-workers in the KSS Office - in spite of the highest authority of the President. He would have to see that they start their work punctually, that they have enough to do and that they are diligent. I have heard complaints about it.
  3. We call this man "Präsident der Kirchenkanzlei." The church of Germany is, therewith, giving him real authority. You cannot copy it. Maybe, the titel "Office Superintendent" is not sufficient and limits his authority. Maybe, the titel "General Secretary" of the G.E.L. Church<sup>2</sup> would be more suitable. Yet, if his authority and his tasks are clearly put down in his Terms of Reference, the name of his titel would not be so important anymore. It is decisive that he carries out his functions.
- b) It is a question of whether the "Gharbandhu-Business-Manager" - the present one is, obviously, not efficient enough for his tasks - belongs to the staff of the KSS-Office or whether he is to work under the Superintendent of the Printing Press. Maybe, the Superintendent could give him better instructions and could also have an eye over his work.

- c) Please, reserve the right and freedom - it is my urgent advice - to give notice to unable or lazy co-workers in the KSS-Office. Reputation and authority of the G.E.L. Church decisively depend on reliable and quick work done in its leading office.
- d) I very much hope that your resolution will really be realized and will not only be a piece of paper. A good and efficient management is one of the greatest honours of the G.E.L. Church.

Subject: Proprietary High-School of the GEL Church

Dear brethren of the KSS,

It was with the greatest interest that I heard during my stay in India last month that you seriously think of building a High-School run by the church. Your President said that he could not think of a better task but working for the erection of such a school after the termination of his term as Pramukh Adhyaksh.

I like to state the following:

1. I am sure that the member churches of the Lutheran World Federation - our churches here, too - are much interested in such a project. I already mentioned it during our discussion in March 1965 when we talked about the most urgent tasks of the GEL Church in the coming ten years. I think that such a school would be the basis and condition for planning an Evangelical-luth. College, too, if and whenever this plan will be realized.
2. The CDS of LWF should be asked at its meeting in Jugoslavia this July as to whether it will be in the position to support this project. It is only worth-while to invest time and efforts in developing such plans, if the reaction of LWF is a positive one.

3. The pre- pre- decisions and considerations are necessary:

- a) Site: Shall the school be built in the country (with hostels) or in town ? I am in favour of the first suggestion. The land not used on the compound of TTC Fudi would be a possibility.
- b) Teacher: Are there enough able and devoted High-School-teachers available within the GEL Church or within the Christianity of Chota Nagpur ? Only christians should teach at this school.
- c) Size: Should there be four or six classes there ? Should there be one or two tracts - humane learning and scientific teaching ? The number of teachers and the costs will depend on it.
- d) Expenses: High fees will have to be paid for attending this school. Do you think that there will be enough families who will be able to pay such fees for their children ? You should not count on foreign grants or on teachers coming from abroad; otherwise you would have many difficulties soon.

Those are only some of the most important questions.



4. There is another point of view which may be important to know before planning such a school. Do you think that the unity of the Gossner Church will be strong enough to carry such a project?
5. It will surely take one year to work out all plans for building such a school. Is the Gossner Church in the position to release Rev. Dr. Bage, the possible future leader of the school, from other bigger tasks for it?

I do not say "no" to the project. But, I want you to consider as it is written by St. Luke (14, 28-30): For which of you, intending to build a tower, sitteth not down first, and counteth the cost, whether he have sufficient to finish it?
