

Dear Friends,

I am enclosing the instructions to those Chartered Accountants who are auditing the accounts of hostels receiving support from Kindernothilfe, together with proforms for the Statements of Accounts which are required. Also enclosed is a new circular on the maintenance of the Special Gift and Joy Accounts which incorporates a few small alterations to the previous instructions which were enclosed with our circular No. 12.

After consultation with the Manager of CSITA and the Income Tax experts consulted by the C.S.I. Synod regarding the provisions of the Finance Act 1972 relating to "Voluntary Contributions" it is considered necessary and in the interest of the Homes and Hostels that an Income and Expenditure A/c and a Statement of Accounts should be prepared in addition to the Receipts & Payments Account. Once you have prepared a Receipts & Payments Account it will take your Chartered Accountant only a very short time to write an Income & Expenditure Account and Statement of Accounts which he can prepare from the Receipts and Payments Account.

These accounts should be prepared in accordance with the proforms which are enclosed and may please be submitted to us not later than 1st August every year.

In the case of Homes in South India we shall be sending details of the amounts received by us for your Hostel Endowment Fund and the balance with us for your Hostel Improvement A/c. This information should be incorporated in your accounts. For the Homes in North India it is not necessary to give this information in your accounts since these funds are held in Germany.

We shall be most grateful for your co-operation in these matters.

Instructions to Auditors for the Audit of the accounts of Homes/Hostels receiving support from Kindernothilfe, Duisburg.

With effect from the financial year commencing 1st April 1972 (or if the calender year is followed from 1st January 1972) Kindernothilfe requires from every hostel/home receiving support from KNH the fallowing Audited Statements of Accounts:

Receipts and Payments A/c
Income and Expenditure A/c
Statement of Accounts at the closing date of the financial year.

Under the provisions of the Income Tax Act 1972 voluntary contributions are liable to tax if during the year there is a surplus of Income over Expenditure which exceeds Rs.5,000/- unless permission under section 11 (2) is obtained for accumulation. In view of these provisions it has been considered necessary and in the interest of all the hostels/homes to ask that an Income and Expenditure A/c and a Statement of Accounts should be prepared in addition to the Receipts and Payments A/c. These statements of accounts may please be prepared in accordance with the proformas which are enclosed.

In many cases hostel funds are also deposited or banked with the Diocesan/Church Treasurer or other authorised person, in which case such balances must be shown in the accounts. A certificate for such closing balances should be obtained from the concerned officials which should also show in what form the balances are held, whether on Fixed Deposit or on current account with the Bank.

Special Gift and Joy Accounts must be shown on separate account forms in accordance with the proformas which are attached. The opening and closing balances and the total receipts and payments on these accounts must also be incorporated in the Consolidated Receipts and Payments Account. These special gift and joy accounts must also be audited and certified by you and we are enclosing the instructions for the disbursements of these gifts for the purpose of your audit.

Kindly note that Capital Grants for Hostel Endowment Funds are being received for most hostels in South India and are being held by us on behalf of the hostels/homes. Once a year we shall be sending to the Hostel Managers and Diocesan/Church Treasurers in South India a statement showing the amounts received each quarter and the balance at the 31st March.

The opening and closing balances on the account of the Hostel Endowment Fund and Hostel Improvement Fund and the receipts during the year must be shown in the consolidated Receipts and Payments Account and in the Statement of Accounts of the homes in South India.

We require all the hostels supported by us to maintain a Cash Book and a ledger with heading in accordance with our proforma. An attendance register and a stock register for food provisions should also be maintained.

Supporting vouchers in the form of the official bills of the suppliers should be obtained for all purchases except for vegetables and petty purchases for which bills cannot be obtained. In your audit all these records must be examined and in your Audit Report please report on how they are maintained together with any other observations which you should give as a result of your audit. It will be appreciated if you are able to give any recommendations for the improvement of the accounting system of the Home.

INSTRUCTIONS FOR THE MAINTENANCE OF SPECIAL GIFT ACCOUNT

JOY ACCOUNT

Besides the regular fostership money or special grants for building or other improvements some of the fosterparents are sending "special gifts" for their fosterchildren or for the Home/Hostel.

These "special gifts" are noted in separate lists showing the Reg. Numbers, names of children and the amounts.

If the name and Reg. No. of fosterchild is stated in the list kindly transfer the respective amount into the "Special Gift Account". This money should be used for the particular child and its family. The Special Gift Account should be maintained in a separate cash account from the general Hostel/Home account either on the original white sheets provided by us or in a cash book ruled in the same manner. It should contain the details as per our printed forms.

The difference in exchange which is shown on the Special Gift List and any other gifts which are wholly designated for the Joy A/c of the Home may be entered directly in the Joy Account. All other amounts must be entered in full in the Special Gift A/c.

If the special gift sent by a fosterparent for his fosterchild is exceeding an amount of Rs.60/- during the year under audit kindly keep in mind that no child should receive more than Rs.30/- on more than two occasions in any one year and transfer all the amount above this ceiling to the Joy A/c. Provided that the Special Gift received falls within the limits prescribed in this paragraph the full amount should be spent to purchase something useful or joyful for the child. (e.g. if Rs.30/- is received as Special Gift for a child Rs.30/- (or as near as possible) should be spent for the child and not just Rs.10/- or Rs.20/-).

Kindly do not simply pass on to the boy or girl the money sent by the fosterparents but purchase something useful and joyful for the child and its family after consulting him/her.

Any amount which is received for the Joy A/c of the Home should not be spent on food, clothing or repairs of buildings etc., but is denated additionally by the sponsors for the enjoyment of <u>all</u> the children in the Home; for example: Christmas celebrations for all children, excursions, sports and games materials, playground equipment, music instruments for the hostel, library, pictures for the Home, special gifts for Non-KNH children or for fosterchildren who do not receive special gifts.

In the case of children who have been transferred meanwhile to other Hemes their gift money should be transmitted immediately to the new Hemes under intimation to the Indian Office. As far as possible the gift money received for the children who are no longer in the Home should be disbursed to them by personal contact or M.O. as a final token of love of their fosterparents and the "Thank-You" letters

obtained and sent to the Indian Office. If this is not possible all such undisbursed amounts should be transferred to the Joy A/c and a letter of thanks to the fosterparents be written by the Warden of the Hostel. In this letter he should indicate why he was not able to disburse the Special Gift to the concerned child and state how he proposes to use the gift for all the children.

It is very important that after receiving any special gift the fosterchild writes a letter of thanks (TY-Letter) in which it should mention in detail what was purchased from the money received. If the children are too small to write the Thank-You letters (TY-Letters) themselves the Wardens are kindly requested to write on behalf of the children expressing the gratitude to the fosterparents.

The Diocesan or Church Treasurers are kindly requested to send the "Special Gifts" to the Correspondents or Wardens of the Homes soon after the receipt of the special gift remittances. As the fosterparents are eager to get an early acknowledgement of their gift the Wardens or Correspondents should kindly purchase the presents for the respective fosterchildren soon after these cheques have been cashed.

The "Special Gift A/c" and the "Joy A/c" are subject to the annual audit by Chartered Accountant.

This supersedes our special instructions on the subject circulated with our circular No. 12 dated 1.6.1972.
