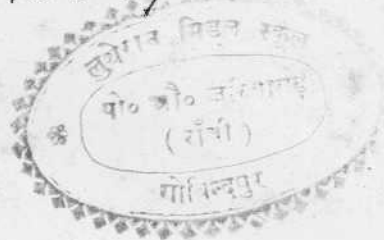

It seems that for this Battle for Bread I may have to persuade an M.L.A,possibly Shri Bage for it. In all my applications from the next time I shall name him among the list of "Copy to ..".It seems someone,again an M.L.A.must be persuaded to "Dance Attendance".I must din into the ears of this M.L.A. that money due for seven years has not yet been paid out.Moreover,a tempest in the tea-pot of Shri N.D.J.Rao has to be created and flutter in the dove-cot of Patna must be set agoing or I shall not get the Compensation money.I have been beating the air all this time.This must cease.I must have recourse to flushing as in hunting.

You know,with a typewriter in my possession,my Secretary's office is a miniatre radio which can be listened to by some ten persons at a time.So ~~xxxx~~ I can cause ~~xxxxxxxx~~ some ten officers to read my application by producing copies at a time. If I do not get the Compensation money before the X'mas,I shall release this final application and then enjoy its festivity.It involves the matter of a cool thousand.Mum is kept over the Compnesation money.That's why I wrote above that something more has to be done.

Sir,

I beg to report that the District Superintendent of Education, Ranchi ordered the Headmaster of the above School to re-submit the Bills for Fee Loss in his letter No. 2516 dated 16-12-57, true copy of which is being submitted to you. The Headmaster re-submitted these bills on 9-1-58 to the Dy. Inspector of Schools, Khunti through the Peon-Book. I requested his Head Clerk to inform me in an addressed post card when those bills have been countersigned, so that the Headmaster might receive those ~~kkkk~~ countersigned bills personally to be handed over again through the Peon Book to the Dt. Supdt of Education. The Head clerk replied to me in meaningless words. I have further requested Shri B. Dangwar of Khunti to reply me in an addressed postcard when they have been countersigned. He too seems to have failed in his attempt.

I would like to report to you about these Fee Loss Bills for 49-50, 50-51, 51-52 and 55-56 were first submitted on 11-2-56. They were ordered to be re-submitted by the Dy. Inspector, Khunti in his letter No. 825-42 dated 30-6-57 with the words, "Any Arrear Bill submitted earlier has been decided to have been cancelled and fresh bills have been called for." Accordingly the Headmaster submitted those very bills along with Arrear Increment Bill from 1950 to 1954 on 8-7-57 for the second time (true copy of Dy. I.'s letter No. 825-42 dated 30-6-57 submitted herewith).

Now the Dt. Supdt of Edn. in his letter No. 2516 dated 16-12-57 complains that those very Fee Loss Bills from 1949 cannot be traced in his office. So the Headmaster 9-1-58 submitted those bills for the third time. Therefore I pray you in all sincerity on behalf of my mute teachers who hopefully expect that money even after a long lapse of some seven years, to find out conclusively whether those bills from 1949 have been received by the Dt. Supdt of Edn. If they have not yet reached him after the re-submission on 9-1-58, I pray you ~~km~~ with equal sincerity to let me know very kindly from the Dy. Inspector of Schools, Khunti whether they have been countersigned as yet and when they can be expected to be handed over to the Headmaster whom I have instructed to submit to Dt Supdt through the Peon-Book for fear of being lost.

Further I pray that the same fate is meted out to the Increment Bill of Rs. 1320/- from 1950. It was first submitted on 12-12-55. It was resubmitted on 8-7-57 under orders of the Dy. I.'s above letter No. 825-42 dated 30-6-57. The Dt. Supdt himself requested the Dy. Inspector in his letter No. 2530 dated 17-12-57 to send it to him for the third time. I shall be very grateful if you very kindly trace out whether it has reached the Dt. Supdt.'s office, if not, this should also be traced out whether it is still in the office of the Dy. Inspector and when it is expected to be countersigned. This bill is to be similarly handed over to the Dt Supdt through the Peon Book.

Being at a loss to spot out precisely the dilatory office procedure of labyrinthine maze and being a person of no weight in the eyes of the world, I pray you to throw your influential weight into the scale.

Sir,

Realising fully that I hereby transgress an important established procedure and etiquette in thus addressing no less a humane and great personage than an Inspector who controls the destinies of the semi-starved teachers of five big districts and knowing in my heart of hearts that my poorest petition cannot go unheard, but being equally emboldened to find that your benign self is a well-wisher of all teachers who do not know what a square meal is, year in year out, I humbly knock at your noble gate to be paid to my school a sum of Rs 1572-37 Np and another sum of Rs 1320/- making a princely amount of Rs 2892-0-37 Np due respectively for seven long despairing years and for equally desperate four long years. I humbly place my naked grievance below for your judicious scrutiny and sympathetic orders.

The District Superintendent of Education, Ranchi deigned not even to reply a line to my Regtd letter Numbers 79/B-57 and 83/B-57, both dated 21-10-57 respectively for Rs 1572-37 Np, Fee-Loss Compensation from April, 1949 to March, 1956 and for Rs 1320/- Arrear Increment Due from April, 1950 to March, 1954, the former bill being submitted originally by my Headmaster on 11th. February in the year of grace 1956 and then resubmitted on the 8th. July 1957, the decimal era and the latter bill being originally submitted on the 12th. December in the year ~~xxxx~~ of grace 1955, the old pice-age and then resubmitted on the 8th. July in the year of grace 1957, the new decimal age again. I had humbly enquired from him as to when he could be expected to make the above payment in his kindness. By an irony of fate, he wrote not a line-cheering or or chilling in reply to my subsequent Reminder No. 88/A-R-57 dated 11-11-57 sent through my Head Supervisor, Lutheran Schools, Ranchi, the official spokesman. One's heart sinks within oneself when one discovers, to one's misfortune that a kind reply-cheering or chilly- cannot be obtained, not to speak of getting one's hard-earned money, leaving me to wring the hands, worse than a wail. Dogs bark and the caravan goes on.

Free Primary Education enacted by the benign Government and thereafter blessed too, is enforced by the beneficent Education Department while the payment of Compensation for Fee-Loss and Arrear Increment is executed by the office of the District Superintendent of Education. But the Bills in question, were originally submitted on the 11th. February in the year of grace 1956, the old pice age and the 12th. Dec 1955, the same era, respectively, were resubmitted on the 8th. July 1957 after one age died out with this order of the Deputy Inspector of Schools, Khunti on 30-6-57, "Any Arrear Bill submitted earlier has been decided to have been cancelled" giving no palpable reason, probably because the bills needed to be changed in decimal coinage of Nehru Government. It smacks of dilly-dallying seeing they were despatched in old pice age in 1955 and 1956 and resubmitted in universally welcomed decimal age in 1957, the former age dying an unceremonious death on the 31st. March, 1957. One fine morning, my Headmaster was awakened and surprisingly reminded, the decimal pice tolled the knell of the parting old pice as early as the 1st. April, 1957 and that his more-than-one year old bills have to be re-garbed in the up-to-date approved decimal dress which he executed posthaste in the jubilant obedience in his artless simplicity little knowing that he is, to his unpleasant surprise, for more than 12 calendar months, week in week out, month in month out, sumptuously fed with nothing but the Barmecide Feast with seven others of his tribe including one of the fair sex. In submitting and re-submitting the same Bills after this despairing lapse of more than 12 months tinged with this dilly-dallying. Does anybody in the world know that these mute teachers with their mute children and mute dependants are driven headlong to lead veritably a dog's life? The only remarkable improvement in these old-pice Bills, that they have been re-garbed in the decimal Bills within a period of some 12 months, at this snail's speed.

It is note-worthy that these mute teachers of mine are heralded as nation-builders in season and out of season from the press and the platform but get attention cold as charity, getting no Compensation for Fee-Loss for seven surprising tedious ~~xxxx~~ seven years and Arrear Increment for no less tedious four years. In this bewildered complicity, one is left to grope in the dark whether these two sums have at all been allotted

to this school or the money is simply tight or flagrant vacillation is meant to put off the payment indefinitely. that

In this vacillation, one is reluctantly led to conclude the profession of payment of the Compensation for Fee-Loss and the Primary Free Education are greatly, if not diametrically opposed as in this instance. It is dead certain that the benign Government cannot or shall not go back upon their word on the Free Primary Education or they would have allowed re-levy of fees in that stage if that had the lesser sanctity than the law of the Medes. It unmistakably points to the fact that the Compensation or Arrear Increment, paid out at reasonable lapse of time. In this case, it is not so paid. Confusion is worse confounded if it is to be out of the frying pan (of Free Primary Education) to be into the fire (of this Compensation).

Therefore, clutching doggedly at your towering magnanimity, realising that your benign self is well posted up with the agonising heart-throb of the poverty-stricken teachers who are thus destined to know no square meal in a day and who are never square with all the world, ~~realising~~ knowing full well that your dignified office is not only a court of justice but but also a court of benevolence and believing firmly that you would in ~~kindly~~ your great kindness put an end to this Barmecide Feast, I fearfully but prayerfully knock at your solemn gate pinning my faith to the fact that you are filled with milk of human kindness and hoping inflexibly that this humble petition would find a soft corner in your heart in changing overnight the piteous fate of these teachers by a stroke of your mighty pen, for which act, the staff, their mute dependants, I and none the less their mute children shall join in a chorus of hymnal thanksgiving for the princely coffer which will speak volumes in just praise of the sterling qualities of your head and heart.

One word more, and I have done. Last but not the least, seeing you so kindly spared your otherwise precious time in the midst of your other onerous duties in going through the petition of a Secretary of a rural Middle School of no significance, I thank you in all humility and sincerity.

Before I make exit I crave forgiveness of all sins of omission and commission, for all time.

Sir,

I hope you have, by now, kindly forwarded my
Reminder letter No.88/A-R-57 of 11-11-57 to the Dt.
Supdt.of Education, Ranchi.

I am at a loss to realise that the great officer
did not or could not reply to my original two letters
both dated 21-10-57. I suppose he means to sit tight
on this money of the school. However I am patiently
waiting for some days more for the sake of official
formality. I am preparing to write either to the D.I.
or the Inspector or the D.C. in his capacity of
Chairman of the Planning Committee. But before I write
or complain to any of these officers, I mean to go and
see him first in a day or two. I am beginning to doubt
seriously whether or not the way is being prepared
for the hushing up of the ~~xxxx~~ one-year-old bills
or whether any hush-money is necessary before the
final disposal of these bills, ~~xxxxxxx~~ something
like the story of the mistress you told me the other
day. These bills were firstly sent on 11-2-56 but
were returned with the words, "the bills are supposed
to have been cancelled". They were resubmitted promptly

So a police case has been filed against Shyam Lal Mahato, the then clerk of Sy. P. S. Khunti.

. Please also let me know what action you are taking towards regular payment of teacher's salaries. It is a serious thing not to pay them for last six months. The managing Committee ought to look in to this matter without further delay. I have seen the minutes of the M.C. dated. 19-1-54²⁸⁻¹⁻⁵⁴ and 29-4-54. It is strange that the committee which sits after long gaps has not considered the financial position of the school which is so deplorable. If the Illaka is subsidizing the school it should be again and again effectively moved and Illaka members on the managing committee should be asked to persuade the Illaka.

If you could send me a financial statement i.e., Receipt & Expenditure of last 1½ years together with a statement of monthly income and expenditure, that will help me in assessing the actual financial position of the school.

This may please be treated urgent.

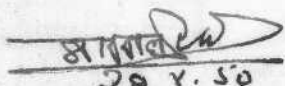
