Sir,

I have to draw your kind attention towards the following facts for your kind and favourable consideration and necessary action.

That (1) The teachers of this School have not been paid their Dearness Allowance for the quarters ending Feb. '53 and Feb. '54 i.e. Dec. '52 to Feb. '53 and Dec. '53 to Feb. '54 as yet.

(2) Enhanced Pay and Increment for the months of January and February 1954 has been paid to some teachers only when some have been paid partly and some have been left altogether.

(3) Enhanced Pay and increment for the month of March 1954 has not been paid as yet even to any of the teachers.

(4) Mrs. Lola Tiga (Asst. Mistress) M.E. Trained is working in place of Miss Premika Muir (M.E. Trained) who discontinued her service due to her marriage, is getting her Enhanced pay and increment at the rate prescribed for an untrained one; as at the time when the proposition statement was being prepared, there worked an untrained Middle pass teacher temporarily.

(5) Shri Jaimasik Ekka (Non-Matric) who is working in place of Shri Mangaldas Lakra (Matric) from 19-7-54 has not received his Dearness Allowance for the period from 19-7-54 to 28-2-55 amounting to Rs. 74/3/-. He is getting his Dearness Allowance from March 1955.

(6) From April 1955 the teachers are getting their Enhanced pay etc. from your office. But they are not getting their dues at the rate countersigned by the Deputy Inspector of Schools, Lumula though the bills are being submitted with increment certificates and at the rates suggested by the authorities during the last Educational Conference held at Lumula.

(7) The Service books of teachers have been opened but the teachers are still deprived of their Provident Fund privileges. A petition for necessary enlightenment in this respect was submitted to you but no information whatsoever has been received as yet.

With regard to the above items I request you to kindly help the teachers by making necessary arrangements for the payment of arrears of the teachers concerned, the payment of Mrs. Lola Tiga at the rate prescribed for a trained one as

She deserves opening of Provident fund accounts and payment of their monthly dues as they deserve according to prescribed scale of pay.

Full details in connection with items 1, 2, 3 and 6 are being enclosed for your kind perusal.

School Gumla. Rs.1956/- being last-year's arrear is a big sum which must be paid without further delay. Since an educational institution is vitally connected to the Educational Department of the Government and is subject to its inspection and disciplinary action, non-payment of teachers amounts to gross negligence. This may result in stoppage of Government aids and suspension or withdrawal of recognition of the institution which will be too much for the school and the Church.

It is expected that this matter will receive your serious and immediate attention. I may be informed of your ~~proposed~~ proposed plan of action.
