- 1. Name of the fund: The name of the fund shall be "G.E.L. Church Pracharaks' Pension Fund."
- 2. Purpose of the fund: The following rules are laid down for the purpose of providing Pension in order to secure the future of the Pracharaks.
- 3. Categories: Incorporated into the rules are the following categories: (a) One-Time Payment Pension.
  - (b) Rogular Ponsion.
- 4. Income of the fund: The income is derived from the following Sources:-
  - (a) Pracharak's own monthly contribution 0 1/ (Four Paiso per rupees) on his basic Salary.
  - (b) Contribution from Pracharaks! . . paying body @ 4% (Four Paise per rupee) on Pracharak's basic Salary.
  - (c) Designated contribution. (Any out side source.)
  - (d) interest of the fund deposited in the Bank.
- 5. Management of the fund: The Pension fund shall be kept in a special fund and be supervised by the K.S.S.MONEY IN THE PENSION FUND IS NOT TRANSFERRABLE TO ANY OTHER FUND.ALSO IT CANNOT BE GIVEN ON LOAN FOR ANY OTHER CHURCH PUPOSE.
- 6. Condition laid down for the receiptent of OME-TIME Payment Pension: Paachapak, who has served the Church for more than one year but less than 10 years (One-Nine) is entitled to receive ONE-TIME payment Pension.
- 7. The Amount of CHE-TIME payment Pension: A Pracharak who has seved the Church for more than one year but less than 10 years will receive the amount of his last basic salary at the time of ceasing his Church service, multiplied by the number of years He has served.
- 8. Condition laid down for the receipient of Regular Pension: Pracharak, entitled to receive Regular Pension: -
  - (a) Must have sorved the Church for 10 years and above.
  - (b) Must have reached the age of 65 years. (The age of retirement).
  - (c) Must retire due to illness or any other valid reasons which is approved by the K.S.S.
- BYE-LAWS

  1. A Pracharak, Prior to his appointment by any other agency and is already receiving Pension, will not be entitled to be a member of this pension Scheme.
- 2. A Pracharak who has been loaded for service to any other Church and is receibing Pension from that Church and has returned for the service of the G.S.L.Church, will not be entitled to be member of this Pension Scheme.

- 5. The calculated number of years commences with the date of confirmation on the post of a Pracharak in the G.E.L.Church. Only completed years of service will be taken into considertion and not the part there of Rotiring age will be 65 years from the date of birth.
- A Pracharak who has not contributed to the Pension Fund required by the rules laid down by the YSS, will not get
- 5. The period in which Pracharak takes leave due to sickness or any other valid reasons, approved by the KSS will be excludedfrom the calculated number of years unless all contritions continue to be paid by those parties concerned.
- period of time, the calculated number of years of service commences with the date on which he resumed his work.
- 7. A Pracharak who through necessity is re-appointed by the Church (Full Scale) during the period of Pension will not get pension for that period.
- 8. A Pracharak who is receiving pension, may engage himself with work for any other Church with permission of the Church (KSS).
- 9. If a Pracharak is put under discipline for any valid reason, his pension will be withheld for the period in which he is under discipline. Only after his re-acceptance into the Church his pension will be paid and continued.
- 10.A Pracharak who has been dismissed from Church service through disciplinary action, will have his pension stopped. However, he will be entitled to get his own contribution Only.
- 11.A Pracharak who has left the Church on his own accord, his Pension will be stopped. However, he will be entitled to get his own cotribution only.
- 12. In calculation Rogular Pension, required amount of Paise will be added to make complete rupees in case of fraction there in.
- 13. If a Pracharak dies, notice must be given to KSS within a month by his immediate authority.
- 14. This Ponsion Scheme is applicable also for the Pracharaks of the G.I.LChurch.

We the members of G.E.L. Church head quartered at Chakradhar pur are very glad to inform you that an initial mes step has been taken to construct a "NEW CHURCH BUILDING " at Chakradharpur on the very site selected and on the same foundation laid down by you on 29.11.1953. The old and young, small and teens all are giving tremendous help to the local church building committee to build up a help church. The local parish has helped us by disbursing to an amount of m. 8,000/- , Father J. F. Guidera, Roman Catholic Paster has encouraged us by supplying with san power and ribbands and the local members co-operated us with their unrealisable demations to the extent of h. 3,000/-. As a result of which the building is almost all completed except the roof. Trusses and asbestos Sheets etc. are now essentially required for the roof. The present estimated cost of the said equipments is amounting to h. 18,000/-. Every efforts are being made to fulfil the requirements from our end but all in vain as the Chakradherpur parish has become empty banded now in all respects, the members are in precerious position to subscribe their denations at present. The matter had already been referred to the local Administration of 5.2.L. Church. (i.e. to Ilaka and Anchal Committee) and the demand was placed at the same time for financial assistance but the Administration is quite unable for helping as and there is no one to advise and guide us as what be do?.

In the circumstances, we are sorry and ashamed to tell you whether the construction work taken over will be desploted in near future as we have become quite helploss.

Further we are sending herewith some photos taken at the initial stage of the building for your kind information. At the same time we would like to inflits your kind attention to the works programme taken by me as the generator of this work programme is Rov. H. F.E. Baruta only and not the others. Blease advise us with some suitable indications so that we say be able to readh the real goal. If there will be any help from your end, either in any shape or in an abstract, the same may kindly be sent direct to the Secretary, G.E.L. Church, Chakradharpur Parish, Chakradharpur Dist. Singhbhume, State- Bihar (INDIA) to avoid delay under intimation to the Pramukh, Anchal Adhyaksh and Ilaka Chairman of G.E.L. Church, if necessary.

At the length, we are requesting you to kindly remember us and also our new Church building in your daily prayer, so that we may be belogsed with holy-spirit, power, courage and wisdom in performing the sacred work.

#### NOTE OF RECOMMENDATION BY THE SUB-COMMITTEE

The Pension Scheme passed by the K.S.S. meeting dt.16th October to 21st October, 1980 is enclosed.

The existing Scheme for Pracharaks does not provide any benefit to the Widows of Pracharaks.

In order to bring parity in case of Widows' pension, K.S.s. in their meeting held on 9th December to 11th December, 1993 directed the Sub Committee to give specific recommendation on the matter of Pension to the Widows of Pracharaks.

The Sub Committee Members had a sitting on 5th March, 1994. The sitting started with a small prayer. The Scheme for Pracharaks was placed b fore members by Rev.J.Sanga for review and further amendment to the rules. In order to remove the inequities in the matter of pension to the Widows of Pastors and Pracharaks the Committee feel it necessary to extend the benefit also to the Widows of Pracharaks.

The fund position and the Income of the fund was also studied and a further investment of Rs-1.00 lakh lying in current account, the additional financial burden of pension for widows can be met.

Details of fund position is also enclosed. The Committee has the following proposals/Recommendation.

- Proposed amendment in Rules.
  - Rule No.3. To include
  - (c) Pracharaks Widows Pension

- 2. Proposed amendment for inserting a new Clouse No.9
- 9. Condition laid down for the receipient of Pracharak's Widow's Pension.
  - (a) If a retired Pracharak, receiving regular Pension dies, the Widow of the Pracharak shall receive ONE-HALF of the pension amount of her deceased husband as Widow's Pension.
  - (b) If a Pracharak, entitled for Regular Pension dies before his retirement, the total amount of his own contribution shall be paid to his Widowed wife at a time and thereafter she will be paid CNE-HALF of the Pension amount of her deceased husband as Widow Pension.
  - (c) If a Pracharak, e titled for CNE-TIME payment Pension dies before his retirement, his total Pension amount due to him shall be paid to his widowed wife.

Committee also recommend that this amendment will come into effect from Ist April, 1994.
