



Dear Mr. Lakra,

On the subject, I have to say that loan cannot be given from any account other than Education Fund, but the credit balance on the account is Rs.2345-62 only after loan given to Gelel Ras High School Rs.658-50 and to Lutheran High School Lehardage Rs.1025-75, Total Rs.1684-25. Thus only half of one month's salary as loan could be given to your school on strict condition that it will be refunded as soon as you get grant from the Government according to your ~~commitmant~~ commitment.

Second thing I would like to write to you that for the welfare of teachers, especially of high Schools, Central Education Fund has been created, but I had the impression that the high School headmasters are not interested. To raise collection from teachers and students, I wrote several letters but without any good response. You have mentioned in your letter the difficulty in raising collection, is mere excuse. If you had acted with interest, I have strong belief, you would have been successful. It is not only you but all the headmasters have shown their disinterest except one or two.

Thirdly I want to say that according to statement you have submitted to the chairman Education Board, number of students is 388 and 14 staff members in your school. Thus Collection from your school would have been:-

1. Students' Contribution	- Rs.388-00
2. Staff's	" -Rs. 28-00

Total Rs.416-00

Collections from your school thus far have been received Rs.304-00 only. Still we have to receive from your school is Rs.112-00 only.

Please note that it is the first condition that ~~Rs.112/-~~ will be deducted out of the sanctioned amount of loan payable to your school.




Dear Mr. Lakra,

With reference to your letter referred to above on the subject noted above I have to say the following:-

1. That as per rules framed by the KSS on the basis of recommendation made by the headmasters' conference last year, application for loan must be submitted in the prescribed form.
2. That the KSS is unable to give loan from any sources other than the Central education fund. But I am sorry to write that you the head-masters of high schools do seem to be interested in the creation of the fund. You must be aware that from your school Rs. 200/- only has been received to this fund from where atleast five hundred is expected, according to the strength of the school.
3. According to publication in the July issue of Gharbandhu total collection to this fund is Rs. 3783.83 only out of which more than Rs. 1600/- is already given loan to two high schools. Therefore Rs. 4000/- cannot be given to your school. Please do not expect so much loan. If you apply in the prescribed form I shall see how much of loan could be given.
