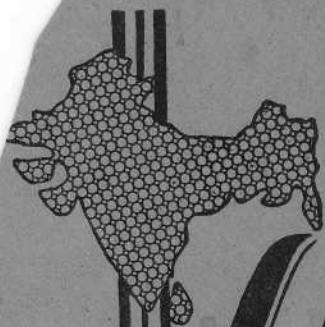

Sambalpur Court--

Dear Sir.

With due respect I beg to  
inform you that- Regarding the  
land registration of Tujomura new  
parish, in our last meeting at  
Ranchi during the Kalisaya Amsabha  
we had a talk verbally in the Ranchi  
church building. As yet I am quite  
unknown what is going to be happened  
once not- but more than thrice I had  
tried to accommodate within Tujomura  
but in vain, what can I do, we have  
already shifted from the old station  
Madhupur and however we have  
been staying in a useless quarter at  
Koinzor village three or four km  
back from Tujomura. Without registration  
it is impossible to erect even a cottage  
in unregistered land. I want to  
know your opinion that- when you are  
coming here for this job. Somebody  
has told me that money have been  
already sectioned three thousand for this  
purpose.

Secondly  
Rerhahkot is a Jmb area  
as decided by the Anchal Samiti.  
You will be glad to know that I have  
also applied an application in the  
Kachhari for a Compound near Raithole  
hol College. The same part - is  
Anabadi land. We the members of  
Rerhahkot have chosen that place and  
openly we have discussed with the  
Tahsildar officer of the Division.

In a sound figure, it seems that my station should be at Raizhakhol partly because pojo mura is far away from the congregations which are abolished by the Anchal. All congregations <sup>within</sup> ~~are~~ Raizhakhol Division. I think within - a proper survey Anchal ~~will~~ confirmed pojo mura to be a new parast within parangula slake.

If I will remain at Johnson's  
centre every day and every time  
without money or bus fair it is  
very difficult to even get a little work  
so it is available however I will  
manage a place within Fairbairn  
Area. In geographical way  
the centre will be the best for  
the Livingstone work. Every  
person of that area are ready to  
stand a church building on the  
applied land. When time will  
come it will not be possible to get  
a piece of land for us in that

area:

Finally I want to draw your  
kind attention towards this written  
and hoping to get an urgent reply  
from you for this purpose. My  
opinion is that please you try  
to come Sambalpur before Xmas  
so that I can build a house in our  
poor land. When you will come  
we will ~~take~~ go to Raichakhol too to  
see the place which I have applied.  
I will be very much thankful if  
we can manage a piece of land  
within poor Raichakhol.

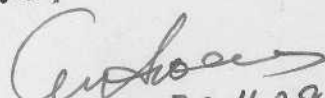

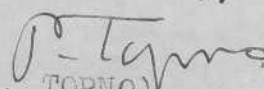

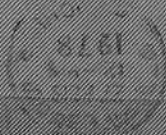

Dear Sir,

It is a matter of great pleasure that a definite agreement is arrived at through the informal talks held among the representatives or responsible leaders of the GFL Church under the chairmanship of the Acting Pramukh Adhyaksh GFL Church on 19th and 20th Feb.1976 at Ranchi.

The agreement opens a way out from the present deadlock in the GFL church caused by unavoidable and obvious circumstances. It is agreed upon that

- (a) A new constitution be drafted and implemented.
- (b) The KSS be formed which under the chairmanship of Acting Pramukh Adhyaksh Rev. Dr. CKP Singh will arrange for drafting and implementation of the new constitution by 10th of July 1976.

There is now atleast something for the GFL Church to step onward. But there is still matter to be taken into consideration, the matter of finance. It is a fact that all payments payable from the KSS treasury has been withheld with effect from January '76. The only reason to withhold is that there is no sufficient money available in the KSS fund. Of course there is balance money in BFL A/c, some in P.B.A/c and Edn. A/c. But most of the balance has been utilised in other items of expenses such as KSS Central Budget expenses, loans, deficit and so on. Unless the money for these expenses is found out or arranged it is surely not wise to go on paying. Also it is not advisable to pay only some departments under KSS; after all a father is responsible for all of his sons not particularly for some. So that is this, the payments have been stopped. If it goes on like this for another month how can the KSS proceed?

To proceed on the matter of finance is more important, and the Anchals of the GFL Church are concerned in it. There is a need of full and honest cooperation from all Anchals, without which there will be a different kind of deadlock more dangerous and disastrous than the constitutional deadlock. In the year 1975 the Anchals' support to the KSS was very poor in relating to different contributions. Here is a statement of different contributions of Orissa Anchal which will explain how the Anchal behaved in the year 1975.

| 4. Loans refundable under Anchal   | nil                  | Rs. 6,370.00        |

(1) Atam Palan Dan:- Orissa Anchal tried its best in respect of Atam Palan Dan though it did not reach the target amount. We received the sum from Sundargarh, Rajgangpur, Karimati, Loarom, Zarakudar direct. Some amount came to us in the name of Orissa Anchal. It is difficult to find out from here which of the Ilakas has not deposited. We believe some amount is still lying with the Ilakas or Anchal.

(2) Contribution to Theological Education:- Orissa Anchal has cooperated even in this item of contribution. An amount of Rs. 800.00 is received. Most of the parishes have paid their own share of Rs. 100/- Rourkela, Madhupur, Jharsuguda, three parishes of Rajgangpur and two parishes of Zarakudar. We are still to receive Rs. 100/- from each from three or four parishes.

3. Money fetching buildings income:-

The Adhyaksh has promised to contribute Rs.1440/- from Anchal out of money fetching buildings income. But no money came into KSS although there was a promise.

4. Loans:- No effort has been made by the Anchal to refund school loan given to Rajgangpur High School.

I request you to collect all the amount explained above immediately and send them before 10th of March '76. If you fail to do this, I shall not be able to carry on. For me there will be difficulty to arrange money even for the next KSS meeting.
